Rule and Regulation Regarding Disputed Biffs

In case of a dispute between the subscriber and the Company as to the correct amount of a bill rendered by the Company for service furnished to the subscriber, which cannot be adjusted with mutual satisfaction, the subscriber may deposit with the Railroad Commission of the State of California at its office in the State Building, San Francisco, the amount claimed by the Company to be due. Deposit checks, money orders, etc., must be made payable to the "Railroad Commission, State of California." Upon receipt of said defoosit, the Commission will investigate the complaint and communicate its findings to the parties.

Failure on the part of the subscriber to make such deposit with the Railroad Commission within fifteen days after notice by the Company that such deposit must be made or service may be discontinued, shall warrant the Company in discontinuing the service without further notice.
