We are currently meeting with JACL and other redress groups across the country with the goal of uniting behind a single Japanese American Community Bill, but we believe it is not too early to begin building a legislative campaign NOW. To get any legislation passed, we need endorsements from organizations in the Japanese community, as well as support from non-Japanese groups. We need everyone who is for just reparations to actively participate in petition drives, letter-writing and visits to your Congresspeople, and fund-raising. We are not asking the government for a handout; we are asking for just compensation for what was lost in homes, businesses, educational and occupational opportunities, health and damage to the pride and dignity of our entire community. After forty long years, our time has come for JUSTICE NOW, REPARATIONS NOW!
