POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS:

That I, SEIGO MIWA; of Honolulu, City and County of Honolulu, Territory of Hawaii, do hereby make, constitute and appoint SHIGERU NAKATA, of Honolulu aforesaid, my true and lawful attorney-in-fact for me and in my name, place and stead and for my use and benefit, to do all and any of the following things, to-wit: to carry on and to transact all my business in the Territory of Hawaii and in the United States of America; to enter into, perform and carry out, and to rescind, terminate and cancel contracts of all kind; to buy, take on lease and otherwise acquire, and to hold, sell, mortgage, hypothecate, pledge, lease and otherwise dispose of, and in any and every manner deal with real property, leaseholds and other interests in real property, stocks, bonds, goods, wares, merchandise, choses in action and other property and rights of any nature whatsoever, in possession or in action; to sign, seal, execute, acknowledge and deliver deeds, bills of sale, contracts, agreements, options, leases and other instruments; to transact my banking and other business with the Bishop National Bank of Hawaii at Honolulu and with any and all banks, firms, concerns, corporations, partnerships and persons in the Territory of Hawaii and elsewhere; to sign checks for the withdrawal of funds from said Bishop National Bank of Hawaii at Honolulu and/or other banks, institutions, persons and firms with whom I may have an account or accounts, or with whom I may have dealings of any nature; to endorse checks, promissory notes, drafts and bills of exchange for collection or for deposit; to accept drafts and other negotiable instruments and to receive, endorse, negotiate and deliver bills of lading and other evidences and documents of title to merchandise, stock certificates and other securities; to waive demand, notice

and notice of protest of checks, bills, notes and other negotiable instruments; to borrow money from the Bishop National Bank of Hawaii at Honolulu and/or from any other banks, persons, · partnerships or corporations, from time to time upon such terms and at such rates of interests as my said attorney shall deem proper or expedient, either without security or upon the security of all or any portion or portions of my property, whether real, personal or mixed, and to give, make, sign, seal, execute, acknowledge and deliver promissory notes and other obligations, mortgages, pledge agreements, hypothecations and other securities, and any such mortgage, pledge agreements or hypothecations may be with such powers of sale and/or foreclosure and may contain such other provisions, covenants and conditions as may be deemed necessary or desirable by my said attorney, and to execute all documents and writingsof whatsoever kind and nature in connection therewith; to collect, receive, enforce payment and collection of and otherwise reduce to possession, and receipt and give releases and discharges for all sums of money and other kind of property whatsoever that may be due, payable or belonging to me, to which I may be entitled to possession, or which lawfully should belong to me; to remise, release and quitclaim to all my estate, right, title and interest including any curtesy in any property of whatsoever kind or nature; to give, sign, seal, execute and deliver such bonds, guaranty, indemnity or other agreements or undertakings as may be necessary or proper or convenient in connection with any of the transactions hereby authorized; to vote at any and all meetings of stockholders any shares of stock which I may own on any and all questions that may come before such meetings; to prepare, sign, execute, acknowledge or swear to and to file any and all returns for income and other taxes to the Territory of Hawaii and to the United Ptates of America; to prepare, make, execute, swear to

or acknowledge any return, information, affidavit or report which may be required by any governmental authority; to pay all taxes as may become due and to do and perform all things lawfully required of me by authority of law; and to make all reports and returns under the Social Security Act.

could do if personally present, with full power of substitution
and revocation, hereby ratifying and confirming all that my
