

The Struggle Goes On



This past June 28, the U.S. Supreme Court upheld the racist Bakke decision and legitimized the myth of "reverse discrimination" by outlawing quotas. The Court said Bakke had been discriminated against by the special admissions program at UC Davis Medical School. This dealt a harsh blow to the struggle for equality for Third World people and women. The decision sets the basis for wiping out Affirmative Action programs which were only just beginning to compensate for past discrimination.

We must get organized to defend special admissions programs. On the campuses, in factories, in offices, and in the communities, we must unite to smash every scheme to implement the Bakke decision. ABDC has initiated the National Week of Resistance/Semana Nacional de Resistencia from November 6-12 to educate and organize the people to resist this attack.

Commemorate Third World Strikes of the 1960's

The 60's was a decade of resistance: strikes erupted on campuses, cities exploded in rebellion, millions marched and protested. November 6 marks the 10 year anniversary of one of the most significant struggles of that decade against national oppression--the San Francisco State University strike. The militant strikers demanded the establishment of independent Third World and Ethnic Studies departments, financial aid to serve minority students, and open admissions. The students were joined by teachers, workers, parents, and community supporters. Together they had to battle then, as we do today, the police, the courts, and school administrators. The SF State strike was an example and inspiration to dozens of other strikes that spread across the U.S. It continues to serve as an example today.

The gains won in the 60's--special admissions, ethnic studies, affirmative action, bilingual and bicultural programs, women's programs, community services like childcare, health clinics, and legal aid--were not won easily. Since they were granted they have been steadily cut back. The Bakke decision is a full-scale attack that lays the basis to wipe out hundreds of programs.

No Implementation of the Bakke Decision

The Supreme Court handed down the law, but school administrators, employers, and government agencies will now attempt to implement the Bakke decision. The precedent has been set to implement the decision on the job-axing affirmative action programs in hiring and promotion, and in the communities—cutting services for Third World people and women.

LOS ANGELES -

SACRAMENTO

Sacramento-Davis ABDC is continuing to put pressure on the U.C. Regents. On October 12 we picketted at the Chancellor's luncheon. Supposedly, the luncheon solicited community input into the administration's affirmative action plans. Along with the Third World Coalition of Davis Law School, we presented the Chancellor with a list of demands that must be answered by November 6. On that day we are planning an action to address the new admissions policy.

As the main focus of the Week of Resistance we are calling activities around the Jarvis-Gann cuts and the attacks on Third World welfare workers. On November 10 we plan to have a potluck in the Black community. We will sponsor it with the Racial Coalition.

On November 20, the Board of Supervisors will decide whether welfare workers will be demoted and if selectively certified bi-cultural workers will receive protection from Proposition 13 cuts. We are mobilizing extensively for this critical meeting.

SAN FRANCISCO -

The Week of Resistance in San Francisco will host 3 or 4 programs in addition to activities on campuses. Rally Exposes UC Regents

On September 25, over 150 angry demonstrators "welcomed" Allen Bakke to his first day of school at U.C. Davis Medical School. Bakke, who claims he was a victim of "reverse discrimination" rushed the picket line for his class. But as he did, he heard loud and clear: "Reverse discrimination—a racist lie, Bakke's plan will surely die".

The demonstration also focused on the UC Davis administration which warmly welcomed Bakke and is currently revising its special admissions program in the wake of the Bakke decision.

Soon after Bakke ducked into his class, the demonstrators presented a list of demands to the dean of the Medical School. The demands were to maintain and expand special admissions, that the administration admit to past discrimination, and that students have equal input in admissions procedures.

The UC administrations and regents would like to forget about special admissions. They would like to return to the days before these programs existed, before quotas were established to provide some guarantee of minority enrollment. The militant protest showed that people are still fighting the Bakke decision. They are meeting the attempts to implement the Bakke decision with forthright demands that the programs be maintained and expanded!

Administrators and employers want us to sit back and say the struggle is over. But it is just beginning. When administrators at Hastings Law School axed the special admissions program last spring, students, faculty, and community supporters boycotted classes and forced the administration to retract its version of the Bakke decision. Bitter struggle was necessary to win these programs in the 60's and militant, united, organized struggle is necessary to defend and expand them today.

End National Oppression

As conditions deteriorate, Third World people are hit first and hardest. All working people suffer from the rising costs-of-living, unemployment, speed-ups, and layoffs. Yet it is minority workers—the last hired and the first fired—who suffer the most. The Weber case is to employment what Bakke is to education. Weber, like Bakke, says he was discriminated by the company's affirmative action program. We must struggle for the rights of Third World and women workers to job and promotional opportunities.

In the communities, the repeated police murders of national minority people, especially minority youth, is evidence to the ever increasing national oppression. The recent march of thousands through the Black community of Crown Heights, N.Y., to protest the brutal police murder of Arthur Miller demonstrates the determination to smash national oppression. In California, Proposition 13-Jarvis Gann has signaled a new era of assault on the rights and livelihood of the people, particularly minorities and women. The cutbacks in health, childcare, social services, and jobs are devastating to many Third World communities and clearly reveals the systematic nature of national oppression.

The Week of Resistance will be a week of education and struggle. The Week will help link the many struggles together, both locally and nationally. Each ABDC local will be initiating various programs and activities in your area. We encourage you or your organization to join with us in the National Week of Resistance/Semana

Nacional de Resistencia.
