then I want you to load on car any way I would  
like you to keep continue collect large implement  
which we need to repair or need take take apart  
some of little thing probably you can take apart yourself  
then stack in new shed. I am very sorry to bother  
in your busyest time, but please will you kindly  
help us. When you receive this letter, to call  
Mr. Peckham office and talk over well and as soon  
as you can, please start.

List of implement I have wrote to you about loading  
the cars and taking care of the implements, I have wrote  
about them in many way, but it is just your personal  
information. I think you have better ideas so, I will  
leave everything to you. I do not care if you

take a little time as long as you do a fine job so I wish you will do your best please. We are depending on you to do the job of course I know you are very busy but please help us.

First I wish to have the flat bed car loaded as much as you can, then start on the box car, I wish to have plenty of lumber from Milpitas Lumber Co, and use on the box car to make partition between the things to things so that you can pile things as high as you can. In the meantime I wish you to be careful so that nothing will fall on top of the tractor car, or spray engine and any other things which are easy to break. Then find some more room, I wish you to load the household goods like I wrote on the household goods list, please.

Almost all my implements which I send back from Gridley, California, and some I left home should be in my new shed, but someone reported to me that nothing is left in my shed. I think the Sells Co, or someone else is using my implement around there. I expect Mr. Scott to know where all they are so I wish you will talk with Mr. Peckham also talk with Mr. Scott about the implement before you start to work and I wish you to report to Mr. Peckham

about the condition of collecting the implement if anything happen, please,

My house hold goods, some which are in the house where I was living and some in the tent house (bottom & top) Mr. Scott is taking care of the keys for both houses, I have <sup>enclosed</sup> put a copy of a list in ~~the~~ mail in each of these list to Mr. Peckham and Mr. Scott,

In meantime I have wrote to Mr. Peckham about getting lumber and nails from Melpetas Lumber Co. so when you go and get lumber talk with Mr. Crabb, and let him call up Mr. Peckham and about the payment of the bills, please tell Mr. Crabb to mail the bill to Mr. Peckham's office. I also wrote Mr. Winson about you are going to help us so I think Mr. Winson all ready understand in case Mr. Winson needs to find out something, <sup>please</sup> tell him to call Mr. Peckham and also about the Kruisich Garage tell him to call Mr. Peckham about repair the car if they do not start yet or if they are not sure of something else,
