Cordial Reception to President on Voyage Down Mississippi May Induce Him to Try for Third Term.

M EMPHIS, Tenn., Saturday, Oct.

S.—President. Reoseveit's visit to Memphis yesterday may become the turning point in deciding the great question as to whether he will recant his declaration and run for President in 1902.

If anything could make Roosevelt change his mind it would be the prospect of carrying some of the states in the 'Solid South.' just as he carried Missouri in 1904. Democrats of Memphis who are sick of seeing the South isolated year, after year, assert that here would be a strong probability of his getting the electoral vote of Tennessee, which has now two Republicans in the House of Representatives. The reception given Roosevelt was significant in that it marked a complete revulsion of sentiment toward him on the part of the people of Tennessee, Kentucky, Missouri. Oklahoma, Louisiana—and Arkansas, all of which states sent their crowds to throng the streets and bid him welcome.

It was his second visit to Memphis. His first trip here was just five years ago, when he came to participate in the reception to General Luke Evright on the latter's roturn from the Philippines. Then the Southern mind was filled with bitternes toward the Prosident because of the incessant efforts he was making to force on the citizens of Charleston, S. C. the appointment of Dr. Crum, a negro, to be collector of the port. It was a badime for the President to come ther and there were many hisses as he drove, through the streets.

The President seemed greatly impressed Friday with the cordiality of his; reception and it is believed he is mearer the point of yielding to the clamor for a third term than ever before.

# ESCAPE SCOT

Case Against P. O. Webber and John Kreuger, Alleged Blackmailers of Miss Arnt, Dismissed on Technicality.

MACKINTOSH SAYS HE WILL NOT PRESS CASE

Prosecutor Declares There Is No Law Covering the Offense Because Miss Arnt Did Not Believe Statement of Men.

O. WEBBER and John Kreuger, the men accused of extorting blackmail from Miss Maud Arnt, victim of "Colonel" W. W. Reed's the victim of "Colonel" W. W. Reed's persecutions, on condition that they refrain from slandering the young woman's fair name, stand an excellent chance of escaping scot free the consequences of their misdemeanor by virtue of the advantage taken of a technicality by their counsel and an indisposition on the part of Prosecuting Attorney Kenneth Mackintosh to prosecute on another charge.

Cummings' motion was made at 3 o'clock yesterday afternoon. The court adjourned the case until '330 o'clock this morning and took the motion under advisement. When the case was called this morning Justice George held that the complaint was defective and dismissed the case but declared that the evidence was so strong against the accused that it was his, duty to remand both 'Webber and Ereuger to jail until Monday morning, so as to give the proseouth webber and Kreuger to jall until Monday morning, so as to give the prosecuting attorney a change to bring the charge of obtaining money under talse pretenses, which the court believes will solve the difficulty.

It is now up to Prosecuting Attorney, Mackintosh, and there is a strong probability that the prosecutor will make no effort to press the charge suggested by Justice George against the men.

\*\*Bo Law, Says Mackintosh.

"There will be no new compliaint filed against the men," declared Mackintosh this morning. "There is no law covering their offense. In order to obtain a conviction upon the charge of obtaining money under false pretenses it must be shown that the victim parted with her cash upon belief in the statement made by the defendants, which constituted the false pretenses. In this case, however, Miss Arnt did not rely upon those statements. The money was marked and paid over to the men for the purpose of entrapping, them and not upon any reliance which she placed upon their statements that the prosecuting attorney's office had issued warrants for the arrest of these men in at the hospital that the department should be notified when Gover was able to be taken to Jail.

Testerday Gover was permitted to leave his room and go out for a walk, as had been his custom for a week. He was seen to leave the hospital, but he did not return. The police were notified of this fact this morning and a search is now being made for him. Where Gover has gone neither the hospital authorities nor the police have been able to learn. He didn't appear at the room where he stayed prior to the day of the shooting, and his friends whom the police have interviewed, deny all knowledge of his whereabouts.

Gover undoubtedly was in possession of the fact that the police wanted, to arrest him, and it is conceded that he took the opportunity yesterday of leaving the hospital and hiding out. It is probable that he has left the city. Chief Wappenstein decided some time ago to prosecute Gover for shooting with intent to kill Miss Taylor and perhaps of making a test case of the law against attempted suicide.

Gover was desperately in love with Miss Taylor and had been refused an offer of marriage. On the afternoon of August 14 he went to the girl's home and again repeated his offer. It was conclusively shown by the testimony of these wilnesses that Miss Arnt had given Webber and Kreuger \$100 in marked bills on condition that they would not appear against her and swear to offenses which they admitted she had never committed. In making their demands, the fact was brought out by the evidence submitted that the men attempted to intimidate Miss Arnt by declaring that the other side had offered them large sums if they would appear and attack her reputation. They wanted the money, they said, because they wished to leave the city. They told her that they understood warrants were out for heir arrest to compel their attendance at Miss Arnt's trial as witnesses. It was this threat which Prosecuting Attorney John W. Whitham used in basing his appeal for the issuance of the new complaint charging the men with obtaining money under false pretenses, and which the court declared was the charge on which the men should be prosecuted.

Pastor of Immanuel Church Tells of Early Struggles— Went Bicycling With Woman, but in Company.

Her husband was a poor jeweler. Somehow he did not get along very well and many times he came to me for financial help, which I gave him. Once I paid his rent and kept him from being shoved into the street. Another time he went broke and I saved him from absolute business, ruin by going to his creditors and helping to straighten out his affairs, even advancing him money.

"Poole's charge that I went bicycle riding alone with Mrs. Poole is absolutely false. During-the six years I was pastor of the Center Street Baptist Church the bicycle craze was at its height, and we formed bicycle clubs in the church. Many evenings in the summer we would organize riding parties, and would ride on the boulevards of Roston. I never went out with Mrs. Poole unless he or some others were along. Mrs. Poole and my wife were the most intimate of friends.

"I deny absolutely the charge that I stole the love of Poole's wife. I believe the man is a drug flend and I am absolutely positive that he has never told his wife of his attempt to extort money from me. I helleve sike knows nothing of this thing and that when she does she will repudiate him and his charges."

Rev. W. G. Jones has been a pastor of Immanuel Baptist Church in this city for a number of years past. He les widely known among Baptists of the Pacific Northwest. He maintains his work in the ministry for the pure love of it, as his wife's great fortune would easily enable him to travel and seek enjoyment in various ways devoid of the drudgery of the ministry.
