Taking the fifty-second Psalm as his
text, John D. Rockefeller, Jr., addressed
the Young Men's Bible Class of the
Fifth, Avenue Baptist Church for the
first time in several months yesterday.
His talk was regarded as one of the
most interesting he has ever delivered
before the class, pattendarly as he
spoke at length upon the accumulation
of wealth and deplored the present-day
tendency to obtain power and riches by
not always, legitimate means.

"There is no sin," he said, "in accumulating wealth in an Interest and legitimanner sind using that wealth rightmate manner and using that wealth right-

we must not be so particular about it. Perhaps he was untruthful; perhaps he did crush others in building up his own posttion; but the world overlooks these things. If that is our frame of mind let us hold our final judgment in abeyance until we can look a little further at the picture presented to us."

Rockefeller then drew a picture of the need for men who make little demonstration but live righteous lives; men who can always be trusted to do the right thing no matter what happens; men with whom one's wife and children would be safe.

CHICAGO BANKER OBJECTS TO CRITICISM OF RICH

CHICAGO. Monday, May 4.—Of late we have had altogether too much denunciation of wealth, so that all wealth has come to be looked upon as predatory and its accumulation as somehow inherently viclous. Often, too, the church, I think, has been inclined to join in this chorus. It is time that it led the way back to sanity and to a rational and ordered view.

This criticism of what was termed the attitude of the church in giving countenance to the critics of the republic was volced last night by David R. Forgan, president of the National City Bank in a talk before the Chicago Sunday Evening Club.

The service was conducted largely by members of the Chicago Association of Commerce, and prominent business men embraced the opportunity to turn the tables upon their brethren of the cloth and give the church a few hints as to the proper note to sound in pulpit oravors.

Without exception, the men who talked

without exception, the men who talked took a hopeful view of the chical standards of modern business, contrasting them with the attitude of the business leaders of fifty or even twenty-five years ago, vastly to the credit of the former.

To illustrate his general proposition that ethical standards will constantly improve; Forgan turned to figures.

Out of every thousand of checks that are laid on my desk representing business transactions, he said, "there is possibly one that stands for a crooked transaction. The other 939 represent plain transactions, both parties to which are eminently satisfied with the exchange.

are eminently satisfied with the exchange.

"The church, I think, should ccase denouncing the accumulation of wealth from the pulpit. The church should say to the business man: "Get money and more money, but get it honestly. Get money; don't let money get you. Then bring some of your wealth here. Be conscious of the power of money. Do to despise it.

"The relation of the church to wealth should be sympathetic, not antagonistic."

Ganot Enforce All Laws.

"Before I received the nomination for mayor." said the executive, "I received a letter from one of your number, in which he put to me a humber of questions. The first was: Will you, if elected mayor enforce all the laws on the statute books? I answered him frankly 'No.' and I told him the reason for refusing to do as he desired.

"On the statute books there is a law passed by the territorial legislature in 1831, in which only four occupations are permitted on the Sabbath day—those of hotelkeeper, undertaker, druggist and livery stable work. This statute is still unrepealed, and is incorporated in Ballinger's code and Hill's annotated statutes.

ELEVEN DROWNED HEROIC CHILDREN OFF OREGON

Steamship Minnie E. Kelton Becomes Unmanageable in Storm and Part of the Vessel's Crew Is Lost.

LIFE-SAVERS FROM **NEWPORT MAKE RESCUES**

NEWPORT, Ore.. Monday, May 4.—
During a big storm Friday night
off this Coast, the deckload of
the steamship Minnie E. Kelton shifted
and strained the vessel, which sprang
a bad leak. Saturday noon a big wave
struck the vessel and washed her deck-

struck the vessel and washed her deck-load and cable overboard, leaving the vessel waterlogged and unmanageable and deck awash.

Eleven of the crow were drowned, some while trying to launch a boat; four of a raft tried to get ashore but only one succeeded and he sustained tour off a rate tried to get ashore but only one succeeded and he sustained a broken leg. The life-saving crew of this place took nine men off the vessel and landed them on the shore about fifteen miles north of here.

The Minnie E. Kolton, Capt. James McKenna, was bound from Aberdeen to San Francisco loaded with lumber. The last seen of the vessel she was picked up by another schooner going north.

As soon as the news of the disaster reached here the life-saving crew at Yaquina Bay station loft for the scene. After a trip fraught with danger the crew reached the vessel and succeeded in rescuing the nine men who remained on the vessel. The lifeboats put ashore twenty miles north of Newport. The known lost are:

Thaw himself undoubtedly will go on the stand in his own behalf. Feabody said. Feabody declared that the prisoner is willing to submit to any examination the court or the district attorney may desire as proof of his sanity.

Peabody said he and Attorney Graham will oppose any attempt to have the case transferred to New York County, which it was reported Assistant District Attorney Garvan would make at the opening of the hearing.

"We want the case tried in Dutchess County," said Peabody. "Thaw's place of confinement is here. The writ was made returnable here and we believe that the crowds of curious people which would be attracted in New York can be avoided in Poughkeepsle.

"We hold that the burden of proof rests upon District Attorney William T. Jerome to show that Thaw is insane. He has never been declared to be insane. Jerome's commission in the first trial adjudged him sane. The jury in the second trial deemed him insane at the time he killed White."
