

The most successful branch of the trust is that which controls afl of the ferries which center in New York. The boys who work for this trust are neatly uniformed and are paid regular weekly wages, not large, to be sure, but regular. Then, in order to prevent them from pocketing some of the money paid them for shines, they are compelled to ring up a miniature cash register has a gong attached and each ring means 5 cents charged against the boy, for which he must account at the end of the day when he reports at the Grand Street headquarters of the trust. This combination on the ferries, together with the rental of privileges in the large office buildings and in front of corner salons, has done much to make the old-time bootblack personages of history, rather than of the present. A few of the old type still exist, but they are fighting against great odds.

The match boy is another creature of metropolitan existence who has largely disappeared. MR. SABIN REPLIES

Intimates That Old Operators Will Have to Go.

His Message Under Consideration by Committees of Chamber Commerce and Business Men.

When the committees from the business men and the Chamber of Commerce met yesterday afternoon to receive the answer of Superintendent Sahin of the Sunset Telephone Company in regard to the operators there were some very disgusted men. The committees were informed in the morning that they would receive a message from Mr. Sahin by the middle of the afternoon, and when they were informed that no message had appeared they waved warm and did not hesitate in saying so.

J. H. Allen moved that the committee from the business men report back to the hody they came from. W. G. Armstrong moved as an amendment that the committee report back, as Mr. Allen had moved, and that a mass meeting of the citizens be called at the Armory for tonight and there take some public action in favor of the girls.

Mr. Armstrong gave as his reason that it was no more than was justify due the Seattle citizens to allow them an apportunity to have a hand in the proceedings. When Arfstrong had relinquished the floor, J. S. Goldsmith arose and cautioned the assembly to go slow. "The message may have been delayed," said he, "and it will not pay us as representive business men to act rashly in this matter." As subsequent events proved, this was a wise piece of advice.

Mr. Allen, again obtaining the floor, made the statement that the reason he had moved for the business, men's committee to report back was simply that they might be instructed by the business men and undoubtedly be given full power to act in this matter, and they would thus be able to meet the committee from the Chamber of Commerce in a decisive way. Armstrong them withdrew his amendment, and the original motion carried.

After the meeting had practically broken up, and the men had gathered in little groups to discuss the probable outcome of the strike, a telegram from Mr. Sabin at San Francisco arrived. It read as follows: as foilows:

Sabin at San Francisco arrived. It read as foilows:

"Messrs Collins, Goldsmith and Cheasty, Seattle, Wash.: Telegram received. The first fact, stating that you wish to act in a spirit of perfect fairness, shows we both occupy the same ground. As to your telephone service at the present moment, I find you have Tfty-eight of the most skilled operators on the Coast, and fifty-five new operators. Total, 113, as against a total of ninety-one last week. The skilled operators are sufficient for, and do, fill the important positions at the switchboard, and the other operators are enough to give all pretty good service. It will improve daily. Five new switchboards will be in use after tomorrow, and eleven more will be installed within ten days.

"Seattle has been, for a year, the hardest city in the country to provide telephone service for. The Klondike boom caught us in the middle of our underground work and removal to a new office. At present you have a perfect plant except in the quantity of switchboards, This will be remedied as noted above within ten days. The fifty-five new operators employed were not taken on until the striking operators absolutely declined to return to work. I talked with their representative directly by telephone last Sunday.

"Now that these fifty-five new operators, all Seattle girls, and who compare favorably with any we ever employed, have assisted us in the transaction of your telephone business under my direct promise of steady employment. I ask you in the 'snirth' of parfect 'bown. rect promise of steady employment, I ask you in the 'spirit of perfect fairness' how can I throw them in the street to make room for the former operators, who at this moment are annoying us in every way possible, including the blocking of your telephone calls by the hundred?

This, of course, put a new light upon the matter, and after a hasty conference it was decided by both committees to report back to the bodies they represented and they will do so today. In discussing the telegram and the results that are likely to follow its arrival, Mr. Prosch this morning stated:

"I am afraid it will be a losing fight. The only hope fae telephone company had was to play a delayed game and they have accomplished their purpose.

"As long as they can hold us off until the service gets in good running order they will win. We cannot possibly ask them to remove girls from positions who are giving good satisfaction, and unless something is done in the immediate future, the strikers might as well quit."

Superintendent A. C. Sands of the local branch of the Sunset Company said this morning that he had no desire to talk. He said that Mr. Sabin would run the affair, and what he said would certainly go. He could not see but that the present force was doing as well as the old one had done, and their work would undoubtedly improve as they became used to the system. The company has raised the wages of the force now working.

"When I left Nome, or, rather before, on June 28, a prominent doctor stated to me in confidence that seventeen cases of smallpox had been reported to the hospital, and he continued that the Lord only knew how many more were scattered through the camp."

WASHINGTON, D. C., Saturday, July 14.

—The proclamation does not recite the terms of the agreement. It is said that each government will probably proclaim only such features of the arrangement as are necessary for the guidance of its own official the public at present. The putting into operation of the German meat bill is deferred for an indefinite period. The official explanation is that the purpose of its suspension is simply to allow of the execution of existing contracts held by American meat packers. It is not discoverable just now whether or not this meat act figures in any way in the reciprocity agreement, and it may be, and probably is, the fact that the suspension has been arranged for separately.

The state department is perfectly satisfied with what has been secured under the agreement for American exporters and though the proclamation enumerates no special privileges conferred upon these exporters, the department officials feel that they will be satisfied with the results attained when they are fully disclosed.


