

Proved That Municipality Not Only Has Lowest Adult Death Rate, but Lowest Infant Mortality as Well.

EIGHT AND TWO-TENTHS **BELOW NEAREST RIVAL**

STATISTICS furnished yesterday by the United States department of commerce, bureau of the census, substantiated Seattle's claim of being the healthlest city in the United States and today more statistics from the WAGE INCREASE PETITION healthlest city in the United States—and today more statistics from the same quarter show that in addition to having the lowest adult death rate of any municipality in the country, the Queen City also has the lowest infant death rate—the best possible indication, according to experts, of the city's salutary condition.

For 1911, Seattle's Infant death rate per 1,000 population under 1 year of age was 78.6, or 8.2 lower than its nearest rival. Oakland, which gains second place, with a rate of 87.2. Third position in the list is won by Spokane, the rate there being 97.8. Los Angeles is fourth, with 100.1, and Portland, Ore, is a close fifth, with 101.9. San Francisco, the only other Coast city in the running, has 104.8.






