Pacific Shoe and Leather Co. Mr. Chas. E. Shepard, of Seattle Library Commission.

> With Librarian Smith He Gathered Much Valuable Information in Eastern

Ci ies. /

Attorney Charles E. Shepard, a member of the library commission, returned yesterday evening from an Eastern trip, after an absence from the city of about two months. During that time he spent a great deal of time visiting public libraries and library buildings in the various large cities of the East, gathering information and ideas in regard to library construction, in contemplation of the task soon to come before the commission of selecting plans for the new Public Library Building in this city.

In addition to visiting a large number of the finest libraries in the United States Mr. Shepard called to see Mr. Andrew

Mr. Shepard called to see Mr. Andrew Carnegie at his home in the Fifth Avenue residence district in New York, and learned the name of the gentleman to whom Mr. Carnegle desired the plans for the proposed Seattle Library Building to be

Mr. Carnegle desired the plans for the proposed Seattle Library Building to be submitted and by whom approved.

While in New York Mr. Shepard learned of the decision recently rendered by the Supreme Gourt of this state recognizing the right and authority of the regents of the State University to dispose of the old University site in this city. This information was very gratifying, since Mr. Shepard is one of those who have all along insisted upon the pre-eminent suitability of the University site as a location for the new library. Now that the last obstacle to the sale of the property has been removed by the Supreme Court. the matter of the purchase of suitable property and the commencement of the work of construction upon the Library Building has begun to take definite shape.

Librarian Smith, who has also been in the East, was with Mr. Shepard for a while and they visited a number of the leading public libraries together. Everywhere they went, Mr. Shepard states, they were received by librarians and other officers of the libraries which they visited with the greatest courtesy, and consideration and frank advice given in the matter of selecting plans for a library building.

Libraries Visited.

Libraries Visited.

"Mr. Smith and I visited together or singly," said Mr. Shepard this morning, "the libraries of Milwaukee, Chicago, Cleveland, Detroit, Pittsburg, Buffalo, Boston, Providence, New York, Jersey City, Brooklyn, Newark, Baltimore, Washington, Philadelphia and Auburn. In each of these places we saw and talked to the librarians in charge and from them we received many valuable ideas and suggestions in the matter of library construction. Many of the Eastern library buildings, even many of those of comparatively modern construction, have already been found to be unsatisfactory for the purpose to which they are devoted. The features which were unsatisfactory in the libraries were freely pointed out to us and we were frequently warned what to avoid as well Libraries Visited.

as what to include in the adoption of plans.
"We shall, of course, endeavor to comwe shall, of course, endeavor to com-bine as many of the excellent traits of the buildings visited with as few of the faults as possible. One of the errors frequently made in library construction is requently made in library construction is that of providing a capacious, elegant, even stately board room to accommodate the meetings of the board of commissioners in charge: This is a mistake that we should avoid. It is all very well to have a nice, even an elegant board room, where there is sufficient money to enable us to indulge in luxries. But where the money is limited almost to the absolute necessities in providing space for the accommodation of the patrons of the library it can be easily dispensed with.

"Another frequent mistake noticed is that of including great massive staircases. This is another magnificent luxury, but not a necessity. Stairs should be ample and sufficiently roomy to avoid the appearance of crowding, but they need not of necessity be massive.

pearance of crowding, but they need not of necessity be massive.

"Mr. Carnegie is now erecting in Wash-ington a library building the exterior of which is magnificent, and the interior well arranged and commodious. This building will cost when complete \$300,000. We have but \$200,000, so cannot duplicate that building, but I think we can build a similar one of less expensive materials and providing practically the same amount of room and other convenience. If it is found that we can do so I think that the plan in general of the Washington building will be the best for us of any we visited."

Rear of Several Tenderloin Houses Are Veritable Garbage Heaps.

In the rear of several buildings on the east side of Second Avenue South between Jackson and Main Streets, are great heaps of the very worst kind of garbage. In the rear also of some buildings on the south side of Washington Street between Second and Third Avenues South are similar heaps. Most of it seems to have been thrown from upper windows and the trail of the stuff from the second and third-story windows down the brick walls is as clearly shown as if a painter had done the work with his brush. The Next Steamer Will Bring the First Mail Sacks From the Interior.

The Lynn canal liner Dolphin reached port this morning with 200 passengers and a lot of interesting news from the north up to December 7, the date the vessel departed from Skagway. Her voyage down was uneventful, good weather being experienced all of the time out. The weather was turning bitterly cold along the entire Yukon valley when the steamer left for the south, but the river immediately in front of White Horse was still open.

Almost all of the Dolphin's passengers came from Skagway and Juneau. There was very little of importance which had transpired at either place since the last advices, with the exceptio! of a startling and sensational attack upon all forms of vice by Judge Brown at Juneau. The news from Skagway, Dawson and the Yukon includes the sale of an im-The news from Skagway, Dawson and the Yukon includes the sale of an immensely wealthy group of Copper mines at White Horse, news of another Mmpede from Dawson, the trial of highwayman Tommierlin, who held up the Dominion gambling house, a drop in the thermometer on the Yukon to twenty degrees below zero, the arrival at Skagway of the first mail from Dawson, a strike of the carpenters at the Sentinel Island lighthouse, the sale of the Skagway Alaskan, and other items of intelligence of importance to the outside world.

The second big sale of copper claims was recorded in the transfer from Dr. G. L. Sipprell to Mr. Carrier of four claims in the White Horse-copper belt. The properties adjoin the well known Dixie concession. The consideration is at present unknown, but is supposed to approximate \$200,000.

A stampede from Dawson followed the arrival at that place of Ben Bull, an old prospector and trapper, on December 3. He came into town from the Hart river, which is an upper tributary of the Peel. Bull brought with him several Peel Indians and eighty dogs, with sledges, on which to take back provisions.

Bull refused to talk about the district. He got his supplies and started back to the district and was followed almost immediately by several large parties from Dawson. Others were expecting to start as soon as they could get ready. There are said to be only three white men in the Hart river country. They are supposed to have struck something remarkably rich.

An unknown Tagish Indian was severely and perhaps fatally injured by a captive wolf at Carlbou on November 30. He had an unusually close call for his life. The animal was tied to a stake and had been made ferocious by teasing. The unlucky mative got too close and the wolf grappled him by the throat. Before the venturesome Indian could be rescued his neck was terribly lacerated.

Inspector Harrigan removed the injured man on a sleigh to White Horse for treatment and at last reports the doctors hoped to Save the Indian's life. He had almost bled to death.

For the first time in the history of Yukon navigation all the, the head almost bled to death.

For the first time in the history of Yukon navigation all the steamers succeeded in reaching their winter quarters and were housed for the long freeze up. Heretofore two or three of the boats were too venturesome and were caught in the ice. Last year the Eldorado narrowly escaped destruction in a high jam, which careened her over and threatened to crush her hull. Two or three others, were in more or less perilous nositions. were in more or less perilous positions. Thee is but one scow frozen in the ice and that one is a total loss.

The first outbound mail from Dawson reached White Horse on Saturday, the day the Dolphin sailed, and was expected at Skagway on Tuesday, arriving in Se-attle on the next boat. The mail is being brought out by four dog teams and the four loads will aggre-

dog teams and the four loads will aggregate nearly half a ton. Of this amount, 600 pounds was sent out from Dawson and nearly 500 pounds was picked up at Steamboat Slough from the steamer Emma Nott, which was forced to go into winter quarters at that place on the close of navigation.

From Dawson to Skagway on a bicycle is a feat accomplished by Robert Young of Skagway. He left Dawson November 25 and the Dolphin brought advices to the effect that the intrepid young cyclist reached his destination at Skagway on December 7, twelve days out. The young man pedaled the distance between Dawson and White Horse in ten days. Mr. Young also brings the latest thoroughly authentic news as to the condition of the trail.

From Dawson to Selkirk he found the From Dawson to Selkirk he found the trail fairly good, but from Selwyn to Five Fingers there was much open water. The trail on the cut-off was fairly well beaten and across Lake Le Barge it was all that could be desired. The river from Le Barge to White Horse is also in fine condition, in spite of the reports to the contrary, and on his last day's ride Mr. Young made 80 miles with ease. Even on the river he averaged 60 miles a day. In speaking of his trip, Mr. Young said:

The trail is fair in places, but there The trail is fair in places, but there is still considerable open water in the vicinity of Selwyn and big jams near Heli Gate. I made good time on my wheel as far as Selkirk, but after I hit the bad trail was compelled to carry it for three days, riding being out of the question. "Between Minto and Mackay's I broke through the ice and went in the water up to my neck. Another night the trail was so bad I could not reach a roadhouse and had to camp out under the trees, keeping warm by the side of a big bonfire.

"After I got on the cut-off I made good time, for the mushers had beaten the trail down fairly well. I met about a dozen people going in and passed a number coming out. Le Barge is in fine condition for travel, and some people may think that Fifty-Mile is in bad condition, but it looked good to me. I averaged six miles an hour on that river and altogether, with the spurt across Le Barge, made S0 miles the last day, and was just ten days en route. Dawson is quiet, but there is considerable preparation for winter work, and it is estimated that there will be fully as much doze as there was last winter. The roadhouses on the way are all open for business and nearly all of them have made extensive improvements, so that with the improved stage lines travel to Dawson this year will be fairly luxurious."

Let Mattie Seaton have my gold fish. Give my ring to Emery.
