COAST TO SUFFER BY SEAMEN'S LAW

Congressman Humphrey Declares That Within Few Months American Ships on Pacific Will Be Thing of Past

WASHINGTON, Monday, Aug. 24.—"Within a few months after the seaman's bill becomes a law American ships on the Pacific Coast engaged in foreign trade will be a thing of the past," said Representative Humphrey today in commenting on the House action authorizing consideration of the seaman's bill tomorrow. He said the bill will pass and that, eventually, it will become law.

JAPAN MUST BE HELD DOWN, SAYS LONDON

Assuming that Japanese action is not limited, according to her pledges, no sensible American will hold England to blame for an event she is quite powerless to prevent.

NO CEREMONY ATTENDS ACTION IN BERLIN

JAPAN'S OFFICIAL WAR DECLARATION

TOKYO, Monday, Aug. 24.—The full text of the imperial Japanese rescript declaring war on Germany, issued at 6 p. m. "We, by the grace of Heaven, emperor of Japan, seated on the throne of our ancestors, in the name of our nation, do hereby make the following proclamation to our loyal subjects: "We hereby declare war against Germany and we command our army and navy to make every effort in pursuance of their respective duties, to attain the national aim by all means within the limits of international law.
