LONDON, Saturday, March 13.—Lady Ida Sitwell, sister of Lord Londesborough, one of the famous women whose features have been immortalized by Sargent and whose portraits were one of the sensations of the 1901 academy, was today sentenced to three months' imprisonment in Oid Bailey by Justice Darling after being found guilty of conspiring to cheat Miss Frances Dobbs out of \$30,000 on two bills of exchange drawn by Lady Ida.

The bills were discounted by a money lender but were subsequently dishonored. The judge declared that she had been guilty of "cruel and heartless conduct; that she was well educated that she was a dishonest thing." Lady Ida listened and smiled.

SPOKANE BANK ROBBED


SPOKANE, Saturday, March 13.—

Theodore Pederson, the last of the King County wreckmasters, has the saving grace of humor. He has held the job since January 13 last, and never yet has he taken it seriously.

Four years ago, some of his friends had him nominated for wreckmaster, putting his name on the Republican ticket as a joke. He was defeated by a colored gen'leman named George Washington Williams who took his official elevation somewhat seriously.

As election day approached last fall, friends of Pederson joked him on his ficial elevation somewhat seriousity. As election day approached last fall, friends of Pederson joked him on his defeat four years ago. Pederson "called" them. He bet a certain amount that he could cop the nomination and gallop away with the office. The friends covered the bet to their later financial anguish. Pederson rolled into office with a vote of 31,742 to his credit. He almost led the Republican ticket.

Since then he has discovered it takes about two miles of state statutes to define the office of wreckmaster, its duties, privileges, province and responsibilities. In loading all this on the job, the Legislature overlooked two things: It failed to give the wreckmaster any means for puting his powers into effect and it forgot that never in the history of Seattle harbor has there been an abandoned anything.

Only One to Make Money.

Pederson admits he should worry about abolition of the office he won on a bet. He is the only wreckmaster in the memory of the oldest bewhiskered inhabitant to make any money out of the office, the bet having netted him quite a few chunks of silver.

"It's an imposing-loking job on the statute-books" he said, "the duties of the office are to keep the coast clear and take charge of any abandoned wrecks in Seattle harbor. If a wreck is abandoned in the harbor the wreck-master sticks a flag on it, advertises it for sale and gets a big cut of the proceeds. master sticks a flag on it, advertises it for sale and gets a big cut of the proceeds.

"The only trouble with the job in Seattle is that there are no wrecks in the harbor and if there was a wreck, the owners wouldn't abandon it unless the decks were awash or the vessel was at the bottom of the bay. The county, however, collects a \$1 filing fee when you run for the office. My sole idea in running was to win the wager and to wipe out, the memory of my defeat at the hands of George Washington Williams. "Under the statutes, the wreckmaster has unlimited power to command assistance but unfortunately the Legislature never provided the wherewithal with which to pay the drafted assistance.

"Probably the reason no one could find me lay in the fact that since taking the office I have been spending my days on the waterfront. That is the last place anyone would look if he were trying to find the Seattle wreckmaster.

Will Ignore Legislature.

"So far the Legislature has neglected to notify me that I am to be abolished. The lawmakers never consulted me. In fact, we wreckmasters of the Sound and Grays Harbor knew nothing of the onslaught on our jobs or undoubtedly we would have been represented by a large and veciferous lobby with a big warchest contributed from our official earnings. You can say for me that since the Legislature has not gone to the trouble of sending me word of its action, I am officially unaware of the abolition of the office. Therefore, any comment I may make on the Legislature's action is purely unofficial.

"A certain dignity has to be preserved by us public officials. However, I can say this much without reservation: Things look on the mend for the Republican party. EMBARGO ON BOXED APPLES FOR EUROPE

An embargo has been placed by railroads on shipments of hoxed apples from the Northwest to the Eastern seaboard with final destination in Europe. They will not accept through bills of lading not protected by some means of diversion at seahoard in case water transportation is unavailable.

This action was made necessary by the scarcity of steamer space. Offers for shipment are heavy, but war conditions are increasingly restrictive. The steamship commanies are confining themselves to taking care of a few regular shippers on contracts for space made in advance, thus reducing their carrying to the minimum. They absolutely refuse to take on any fresh business.

Most of the space now available for apnles is controlled by the two central selling agencies, the North Pacific Fruit Distributors and the Northwestern Fruit Exchange. Each of them is using every available boat for shipments to Livernool, London, Manchester, Bristol and Hull.

Recause of this limitation of imports, the English market for apples promises to be fairly good for the close of the season, despite the war.

FOUNDATIONS LAID FOR BIG \$60,000 WAREHOUSE

Foundations were laid during the past week for the \$60,000 seven-story concrete E. E. Simpson warehouse at Pike Street and Western Avenue. Contract for the construction was let by the E. E. Big Fair Constructs Buildings of Temporary Character-Plans Elaborately to Meet Any Fire Danger.

Owing to the close proximity of San Francisco to the large lumber producing centers and considering the temporary nature of Exposition structures the general use of such building materials as brick, steel, stone and concrete was largely eliminated in the erection of the great exhibit palaces that make up the central portion of the Panama-Pacific International Exposition, says Modern Building.

There are, however, certain portions of the now finished work which did require the use of more permanent materials, particularly of steel and concrete.

require the use of more permanent materials, particularly of steel and concrete.

Altogether there are the neighborhood of 200 buildings of all kinds on the 625 acres of the exposition site.

When it is considered that, with the exception of the Palace of Fine Arts, the dome and dome structure of the Palace of Horticulture and the Tower of Jewels, the frames of all buildings, including the wall studding and sheuthing are of timber, it will be realized that there is a tremendous fire risk. The fires at the Chicago Exposition and the burning of the buildings at Brussels indicated to this Exposition that fire protection and fire prevention should be made a part of the construction program.

In this direction several extraordinary measures have been introduced for fire protection. These measures include a complete fire-fighting apparatus, both a high and low pressure water systems, automatic sprinklers throughout the buildings and open cornice sprinklers between the buildings, both a regular and automatic fire alarm system, wheeled and hand chemical extinguishers, etc.

Concrete Fire Walls.

From the construction standpoint the chief item in the system of fire prevention was the erection of concrete firewalls between all contiguous structures. These extend in height from the ground to the tops of the various paraets and thus subdivide the eight buildings of the main group into separate units for the purpose of preventing the spread of fire that might start in one building to another building of the group. group.
