Subject: TEMPORARY DUTY ORDERS.

To : Enlisted Men Concerned.

1. The following named enlisted men, U. S. Strategic Bombing Survey, now in Washington, D. C., are directed to proceed to Hamilton Field, California, to report thereat to the Embarkation Officer, Port of Aerial Embarkation, on dates indicated for air transportation via Army Air Transport to Tokyo under Shipment Identifier and Air Priority shown. Upon arrival at final destination these enlisted men will report to the Commanding General, U. S. Army Strategic Air Forces, Tokyo for indefinite temporary duty in connection with the activities of the U. S. Strategic Bombing Survey. Upon completion of this temporary duty, these enlisted men will return to their proper station, Washington, D. C.

2. This is a TEMPORARY change of station. Direct communication in connection with this movement is authorized.

3. Travel by military or commercial aircraft (Par. 3, AR 55-120, 1943) from Hamilton Field, California to Tokyo is directed and is necessary in the accomplishment of an emergency war mission. Travel by Army or Navy transport, commercial steamship, belligerent vessel or aircraft and rail is authorized. The provisions of AR 35-4810 apply for per diem.

4. In accordance with AR 35-4810, FD will ^{pay}/each of these enlisted men in advance allowance for subsistence at a rate of \$1.00 per meal for twelve (12) meals from Washington, D. C. to Hamilton Field, California.

5. Upon arrival at destination, these enlisted men will be attached to U. S. Army Strategic Air Forces, Tokyo, for administration, subsistence, quarters and supplies.

6. Per diem is not authorized on these orders after arrival at final destination.

7. These enlisted men are authorized to proceed to such additional places within the Pacific Theater of Operations at which temporary duty in connection with this mission may be necessary.

8. The following inoculations will be accomplished prior to departure from the continental limits of the United States:

Smallpox Typhoid Tetanus Typhus Cholera

Vaccination against influenza as prescribed by Section III, Circular 267, WD, 1945 will be administered at home station if the vaccine is available, otherwise at ZI replacement depot or staging area.

9. These enlisted men will be equipped as deemed necessary for this mission in accordance with Column N, WD Pamphlet 38-6, "Itemized Baggage List", dated January 1945, as amended except Sections 6, 7 and 8. Baggage will be marked with name, grade and Army Serial Number only. Sergeant Devlin is authorized twenty (20) pounds excess baggage for official documents.

10. a. Personnel are advised of the following post office address and are instructed to furnish it to their correspondents by use of WD AGO Form 204, Change of Address Cards:

b. Personnel are also instructed to advise publishers by use of WD AGO Form 923 to withhold mailing of publications until notified of a complete mailing address including unit designation and APO.

c. Immediately upon arrival in theater, enlisted men will contact the theater postal officer to arrange for delivery of mail. Prior to departing for another theater or location within the theater, enlisted men will contact the theater postal officer to arrange for forwarding of mail.
