I, KATSU FUJII, a resident of Alameda, County, California, declare that this is my Will.

FIRST: I revoke all Wills and Codicils that I have previously made.

SECOND: I am a widow. My late husband, RYUTARO FUJII, died in 1962. I have five (5) children, now living, all adults, whose names and cities of residence are:

I have one (1) deceased child, MARY HALPERN, who has left issue now living.

THIRD: I give all of my interest in the real property situated in Alameda County, California, and commonly known as 25072 Soto Road, Hayward, California, together with any insurance on the property, to my daughter, HANAKO FUJII, if she survives me. If HANAKO FUJII does not survive me, I give the property to my grandchildren, WALTER KAZUO FUJII and

VICTOR KEN FUJII, in equal shares if they both survive me, and if only one of them shall survive me, I give the entire property to the survivor of them. I give the property subject to any encumbrances on it at the time of my death, including any mortgage, deed of trust, and real property taxes and assessments.

FOURTH: I give the residue of my estate, in equal shares, to those of my children who shall survive me.

FIFTH: Except as otherwise provided in this will, I have intentionally omitted to provide herein for any of my heirs living at the date of my death; I have intentionally omitted to provide for the issue of any of my children who have predeceased me or who shall predecease me.

SIXTH: If any beneficiary under this will in any manner, directly or indirectly, contests or attacks this will or any of its provisions, any share or interest in my estate given to that contesting beneficiary under this will is revoked and shall be disposed of in the same manner provided herein as if that contesting beneficiary had predeceased me.

SEVENTH: I nominate my son, KENJI FUJII, as executor of this will, to serve without bond. If my son shall for any reason fail to qualify or cease to act as executor, I nominate my grandchild, WALTER KAZUO FUJII, as executor, to serve without bond. If both my son and my grandson, WALTER

KAZUO FUJII, shall for any reason fail to qualify or cease to act as executor, I nominate my grandson, VICTOR KEN FUJII, as executor, to serve without bond. The term "my executor" as used in this will shall include any personal representative of my estate.

I authorize my executor to sell, with or without notice, at either public or private sale, and to lease any property belonging to my estate, subject only to such confirmation of court as may be required by law.
