## Procedure To Obtain Shoes Is Changed Again THOUSANDS OF PREVIOUS APPLICATIONS RETURNED

Procedure for obtaining special shoe stamps for the residents have been changed twice since March 1 by the Tule Lake Town Board and then by the Klamath Falls OPA office, causing further delay, it was revealed by the Project Panel.

Thousands of applications made out according to previous instructions to the Tule Lake Board have been returned to the Project on the ground that they do not represent sufficient degree of need.

These applications will be examined and ones which will be acceptable by the Tule Lake Board will be re-submitted.

Last week 44 stamps were received.

Emergency applications for shoes received through the Block Manager's office will be submitted separately to the Board. Through this procedure it is expected that all emergency needs will be given attention.

Block managers have complete information as to the basis on which emergency applications may be granted.

For those who were not issued Ra-

tion Book 1, it will be necessary to attach to the application a statement from the local OPA Board from the place where the evacuee resided previous to evacuation that no Book 1 was issued to them.

The Project Board is composed of the block managers and Don Elbersson and Paul Fleming.

## MORE COAL ARRIVES HERE Volunteers

Arrival of about 40 cars of coal which again jammed the tracks will make it necessary for volunteers to continue working until the present emergency is over, according to Dan Sakahara, supervisor of block managers.

Each block will be responsible for unloading of one carload of coal assigned to them.

Formerly volunteer workers had been recruited on a ward basis, but with the new system each block will be responsible for getting their own coal.

## Defense Attorneys Under Fire In Evacuation Case

Hearing on the evacuation question continued in the United States Supreme Court last Tuesday as members of the court questioned the attorneys attacking

of the restriction as a necessary war measure.

"This war against Japan is not a race war. The evacuation of persons of Japanese ancestry was not based on race. It was based on reasonable classification."

Evans insisted that exclusion orders affecting the whole Pacific coast could only be issued under martial law.

"The constitution does not say anything about martial law," Justice Felix Frankfurter said.

The high court is expected to rule in the case before it recesses for summer.

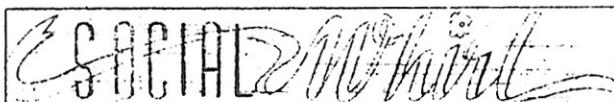
## MUCH DOMESTIC WORK IN CHICAGO
