

Mess Hall, Motor Pool, Housing Employees Get Checks

January pay checks for mess hall and motor pool workers, carpenters and employees of the housing and employment division (activities 220.5, 500, 510, 520, 700, 710, 720) were distributed to the block managers this morning, announced Victor J. Ryan, budget and finance officer.

Provisions of Disability Compensation Explained

Provisions and procedure under which compensation benefits are payable to evacuees injured or disabled while working for the WRA were outlined in administrative instructions received this week from Washington. John Nelson, senior administrative officer, will be in charge of all applications for disability compensation.

Residents who sustain traumatic injuries in performance of duty are entitled to receive necessary medical treatment including hospital care, compensation during the period of total disability, or compensation for specified periods in case of partial disability.

Compensation may not exceed \$50 a month nor a total of \$4000, exclusive of medical and hospital costs, and is not payable for any period in which the worker receives pay nor for a three day waiting period after pay stops.

In case of death burial expenses not exceeding \$200 are payable and compensation awards are made to dependents where the injury caused death. This compensation does not extend to residents engaged in private occupations such as consumer enterprises or to others who are not working for the WRA.

Only traumatic injuries are compensable. Traumatic injuries are those resulting from accident causing harm or injury to the body.

Workers entitled to sick leave benefits for 15 days who are unable to perform their duties due to injuries may elect to receive either sick leave benefits or compensation benefits but they may not receive both.

A worker who elects to receive sick leave benefits may claim compensation for disability continuing after the expiration of the sick leave benefits but in such case he is not eligible for unemployment compensation from the WRA.

Injuries must be reported by workers within 48 hours after injury occurs except where there is justification for failure to report within that time. The commission may disallow claims not made within 60 days and no claims can be allowed if not reported within one year.

The compensation rate for total disability is two-thirds of the workers total monthly wage at the time of injury. For this purpose the monthly wage of the residents include their cash payment, total value of their clothing allowance, \$19 for value of subsistence, and \$6.50 quarters allowance.

However, no compensation will be paid by the compensation commission for clothing allowance, subsistence, or quarters during such time as it is furnished by the WRA.

250 Workers Sought by Railroad Company

In Heart Mountain to solicit 250 track workers for the Great Northern Railroad company, Mr. Holmquist, representative, is interviewing interested residents at employment office 21-26.

Work which is to be on the Butte Line is guaranteed for the emergency period. Wages are 52 cents per hour and time and a half for overtime for six days a week.

傷害手當面に就いて

W. R. A. の仕事に従事し中、傷害を受け居る者に對する手當面支拂に關する指令が今週、府より届いた。

それによると就業中、過失傷害を受け居る者は適宜な治療と労働不可能期間に對する手當面を受け居ることが出来る。右手當面は一月五十弗を越えず、又匪料、病院費を除いて最高額四百五十弗を決定されてゐる。手當面の計算書には給料を受け居る期間及び給料停止後の三日間に入れられぬ。過失傷害の結果、死亡した場合、葬式費、二百五十弗以内と、手當面を遺族に支拂ふ。但し、遺族組合の如き政府以外の事業に従事して居る居住者にはかかる。相傷害の手當面は支拂はれない。

費業員自の怪我は、初めて四十八時間以内に報告せらるべきである。

六十日以後の手當面請求は認められぬ事があり、一年以後の請求は全然受け付けられぬ。當面センターでは管理部門、役人、ネルソン氏がこの手當面請求を取扱つてゐる。手當面の金額は従業員自の給料料の二分の一と指定されてゐる。
