

Cooperatives Rejected at Tuesday's Election

A cooperative form of management for community enterprises was defeated at last Tuesday's election, according to unofficial returns released today. Twelve blocks voted to retain the present trust system, while seven favored the cooperatives.

Seek \$1000 to Finance Hirabayashi Case

An appeal for \$1,000 from center residents to be contributed to the Gordon Hirabayashi Defense Committee, to be used in financing the Hirabayashi test case on the constitutionality of evacuation now being heard before the Supreme Court, was made this week jointly by the temporary community council and block managers.

A voluntary contribution of 50 cents from each family unit was being asked here. Drives are also being conducted in nine other WRA centers to help finance the test case.

The announcement was first made at block meetings Monday night, and the council hopes to have the drive concluded this week so that the money may be forwarded to the Defense Committee as soon as possible.

Increased Wages Announced by Chicago Hotel

Housemen. \$95 month.
Maids. \$55 month with room and board.
