Charter voting scheduled for Wednesday, July 7, has been postponed indefinitely because of last minute changes made in Washington.

Short Wave Radio Sets Must Be Turned In

Residents are reminded to turn in short wave radios to the internal security office in the Sentinel building by Thursday, July 15, Marc L. Campbell, chief of internal security, announced. If the short wave attachment is readily removable, it will be taken out and the remainder of the set returned to the evacuee. Only sets in which the short wave attachment cannot be removed will be retained. Receipts will be issued for all sets or parts retained.

Provisions are provided for seizure of illegal sets and disciplinary action against violators of this regulation.

Application for Shoe Ration Stamps Explained

As there is still some confusion in submitting applications for shoe ration stamps, the following information was released by Victor J. Ryan, budget finance officer.

Stamps will be issued only on the basis of need for shoes as shown by the application. The individual will not be considered in need of extra shoes if he has two or more pairs of wearable or repairable shoes of the kind wanted or which he could use for the same purpose, or if he wants shoes simply for sports wear or dress.

This means that shoe stamps may be issued only for the purpose of necessary work shoes or in the cases of children, women, unemployables, for necessary shoes for general use.

A separate application should be submitted for each member of the family needing shoes. The quantity and types of shoes owned by the individual should be shown clearly in the space provided. Applications may be obtained at the ration desk in the south wing of the old administration building and should be returned after completion to the ration desk from where they will be forwarded to the ration board for approval. If approved, ration stamps will be mailed.

On Thursday at 8:30 a.m. the Bishop will administer Episcopal Holy Communion in 22-26 followed by a ministerial meeting at 10 a.m. A general Episcopal group meeting will be held from 3-4 p.m. and a meeting in Japanese for all issei will be held in 22-26 at 7:30 p.m.

Bishop Reifsnider, a member of the Protestant church commission for Japanese service, is arriving here from Minnidoka and will leave Friday morning for Topaz.
