

Poston kibeI Arrested by FBI on Charges of Sedition

According to teletype information reaching Heart Mountain on Tuesday, George Fuzi, 29 year old kibeI, a native of Seattle who had spent ten years in Japan was arrested by the Federal Bureau of Investigation on charges of sedition at Poston. He was arraigned in Phoenix, Ariz., Monday and held on \$10,000 bail. The arrest was based on evidence that he interfered with selective service laws.

Sedition generally refers to language or conduct directed against public order or tranquility of the state.

At Granada five of 53 nisei were held by the Federal Bureau of Investigation for failure to report for induction. The five are being held pending action by U.S. District Attorney Thomas Morrissey in Denver.

Project Director Lindley said the five had voiced objections on the grounds that branches of the military service other than the army are not open to them and that some center residents expressed belief restrictions against Japanese Americans should be lifted.

Families of these boys are asked to communicate with the local selective service office if these boys are out on seasonal or indefinite leave and cannot report as requested.

Also any boys who have received their order to report for preinduction physical examination and have not reported to the selective service office should do so immediately.
