

Information Issued for Prospective Relocates

Relocates are to call for their permits at the leave office before 10:30 a.m. on the morning of their departure, Ed Nakano, junior leaves officer, announced.

There are two baggage pick-ups per day for those leaving at the following schedule: 8:30 a.m. pick-up for 9:30 a.m. bus; 10:30 a.m. pick-up for 2 p.m., 4:45 p.m. and 11:20 p.m. busses.

In order to avoid last minute delay and embarrassment, residents should heed counsel of the relocation officers by not taking more than the 150 pounds of baggage per adult ticket and 75 pounds per half fare ticket, Nakano said. There is no baggage allowance for minors who do not require tickets. Any person having more than the allowed amount of baggage should contact Harvey Burnett, evacuee property officer, in the Sentinel building and make out freight shipment applications.

Seasonal general farm work offer for 300 men in Smithfield, Utah has been submitted here by the War foods administration, it was announced by the outside employment office.

The basic pay is a minimum of 60 cents per hour, with board at \$1.20 a day and housing at 50 cents per week. The group is scheduled to leave May 15th and residents who make out their leave papers first will be given preference.
