

Community Representatives to Investigate Relocation Opportunity
Being Offered at Toccole Ordnance Depot

Three representatives from Heart Mountain, Eliah Sakauye, Kay Nose and Raymond Katagi, left today with Captain Kinney, personnel officer at the Toccole ordnance depot, to investigate the opportunity being offered by the army for families to relocate and work at the ordnance depot in Utah. The trio was selected by block managers and councilmen.

The men will look into the working, housing and living conditions, and meet Col. Minton, commanding officer, at the depot, as well as the leading citizens of the town of Toccole, located nearby. They will return to the center either Thursday or Friday to report on the negotiations to residents interested in seeking employment at the ordnance depot. Captain Kinney will also return with the group to aid prospective workers in making applications.

Personal security questionnaires, required of all persons working at the depot regardless of race, have gone into the provost marshal general's office from two applicants who applied while Captain Kinney was here yesterday, it was announced by the relocation office.

The type of work offered at the Toccole ordnance depot at the present time is in moving various types and caliber of ammunition. The jobs will be under civil service. Wages will conform with the average hourly rate paid to men doing the same type of work in the territory surrounding the ordnance depot. Complete housing facilities are provided for workers and families at the depot. There are one, two, and three bedroom apartments which may be rented from \$28 to \$39 per month, depending on the size, and the cost includes everything but food and fuel.

Only family men who are interested in moving their families to the depot and becoming an actual part of the wartime community will be considered, it was stated by an Army representative.

Elections to be Held September 25 to Fill Vacancies in Community Council

Nomination petitions for the vacancies at the council office existing in the third community council must be filed by 5 p. m., Friday, September 15, for the elections which are to be held Monday, September 25, according to Hiroshi Matsushige, acting chairman of the council.

In answer to a query made by Guy Robertson, project director, to the Washington WRA office, on whether the block coordinators system can again be revived, the following letter received from Malcolm E. Pitts, acting director:

"The difficulties which have arisen over the elimination of the position of block coordinator as described in our letter of August 7, are unfortunate. I have given careful study to the justification for the retention of this position and of the petition submitted by the people of block 27. It remains impossible, however, to alter the decision in this matter.

"It has been our hope that the community council would be composed of persons who through a desire to contribute to the well-being of the community would give freely of their time and energy. It has been the policy, which has worked successfully elsewhere, that councilmen be excused from their regular jobs to attend to community business. I can see no reason why this arrangement should not work as satisfactorily at Heart Mountain as at the other centers. It has also been our policy to avoid placing the council in the position of being dominated by the administration. It is our feeling that the payment of councilmen might lead to this eventuality.

"I hope the people of Heart Mountain will accept this decision in the spirit which it has been made and will continue to have a strong and vigorous community council."

Councilmen will be granted leave with pay from regular employment for attending council meetings and to perform council business, it was stated by M. O. Anderson, assistant project director.

WRA Desires Cooperative at Heart Mountain, Rossman Says

"In all of the other centers the business enterprises are operated by a cooperative and it is the sincere desire of the WRA to see such an organization be formed in Heart Mountain," Otto Rossman, senior advisor to the business enterprises from Washington D. C., stated. He is visiting Heart Mountain on a routine inspection of the community enterprises in this center.

"A trust arrangement at best is unsatisfactory and cannot be made entirely democratic because it places too much personal liability on the trustees themselves," Rossman said. "On the other hand," he added, "long experience demonstrated that there are many advantages in cooperative organization. It provides a democratic form of organization with a voice by the people in all matters of policy. It eliminates the policy of one man control. It has legal entity which is necessary for protection of the management."

He also pointed out that it has been the policy of the WRA to exercise the minimum of supervision over business enterprises. "The government has no financial interest in them," Rossman declared, "and in line with this policy, business enterprises supervisors have been removed from all centers. It was the opinion of the WRA that center cooperatives were developed to the point where such local supervision was no longer necessary. This is another reason the WRA is desirous of having an incorporated cooperative in Heart Mountain, an organization entirely of, by and for the evacuees."

"Above all the WRA desires a united and harmonious community, and there is room for everyone in cooperative membership on an equal basis," Rossman continued.

He stated that, "It is important that a full trust committee be elected representing all blocks, of people with integrity and sound judgement, and an understanding of the task ahead. The committee to be elected will be empowered to amend the declaration of trust or provide machinery for the organization of a cooperative if the people so desire," Rossman concluded.
