

### Aliens Must Comply With Department of Justice Regulations

A recent communication from the Washington Office indicates occasional violations by aliens of Department of Justice regulations regarding permission to travel. Too much emphasis cannot be placed on the necessity for aliens who must travel to insure themselves against difficulty with the Department of Justice by obtaining U. S. Attorney's permission before undertaking travel. Post card reports of change of address must also be sent to the Federal Bureau of Investigation and to the Immigration and Naturalization Service.

The Relocation Division is at the service of all residents to furnish information regarding travel to those who are leaving the Center and others who wish to have it. Necessary report cards and written instructions are available and may be had upon request.

Those being issued a new seasonal or indefinite leave permit automatically receive U. S. Attorney's permission to travel to the first destination. Travel beyond that point, however, must take place only with the prior approval of the U.S. Attorney of the Judicial District in which the alien is located. It has been emphasized that obtaining this latter permit is a personal responsibility and failure to obtain it may result in difficulty with the Department of Justice.
