

Income Tax Returns Must Be Filed by March 15

Any person whose gross income during the year of 1942 exceeds allowed exemptions is required to file an income tax return by March 15, Jerry Housel, project attorney, announced.

"The fact that a person has applied for repatriation and intends to return to Japan does not exempt him from this requirement," Housel declared.

He also stated that residents of West coast states are generally subject to the state income tax even though they have been transferred to relocation centers. A solicitor recently advised the Arizona State commission officer that evacuees from Arizona living in relocation centers are considered residents for income tax purposes until they have obtained WRA permits to leave the center and establish residence elsewhere. California and Oregon doubtless will follow a similar interpretation in the application of their income tax laws, Housel said.

He again invited residents encountering special problems in completing their returns to take advantage of the assistance available at the project attorney's office in the administration building.
