

Cooperation Asked in Meeting Housing Problem

An extremely serious housing situation at Heart Mountain has necessitated a number of drastic steps which must be taken immediately. C. E. Rachford, project director, declared today. Rachford called for the full co-operation of all colonists in meeting this problem so that the best interests of the greatest number may be served.

Because of lack of housing the school program has been delayed, the director pointed out. Further delay might mean the waste of an entire term for Heart Mountain pupils as credit may be denied for this term by the Wyoming board of education if there is an overly late start. He also declared that as many as nine persons from one family group had been crowded into single apartments, creating a very bad condition.

To meet this situation, Rachford declared two steps are necessary. First, all barracks must be vacated at once to make room for schools. Second, relief must be given overcrowded family groups.

To attain these objectives Rachford set forth a progressive program requiring the co-operation and understanding of all colonists.

First, all bachelors, except where medical necessity prevents, are to be moved to recreation halls for temporary housing.

Second, schools will be opened.

Third, overcrowded families will be moved to more suitable quarters.

Fourth, partitions will be built in large apartments and small families now living in large apartments will be moved into the small apartments created by the partitioning.

Fifth, bachelors will be moved back from recreation halls to apartments.

Proper housing of bachelors will also result in releasing of recreation halls for other functions, it was pointed out. Further relief will be afforded following the erection of permanent school buildings.

"I realize the discomfort and inconvenience that this program will cause many colonists, some of whom have been our most loyal workers," Rachford said. "I can only ask that they be patient and remember that their willing sacrifice means relief for distressed families and schooling for children."

The project director reiterated that this would be a temporary arrangement necessitated by a situation affecting the welfare of the entire camp, and that no effort would be spared to make satisfactory permanent arrangements.

Center Gets 22 Additional Trucks

Twenty-two trucks were added to the project's overtaxed truck force last Saturday when 16 drivers completed a three-day, 350-mile journey from Rawlins, Wyoming.

The '33 and '39 Fords, Internationals, GM Cals and Dodge were formerly used by the C.C.C. and will be used here for general hauling and coal dumping.

Fifteen of the trucks were driven in while seven had to be towed with the front ends of the trucks placed on the rear of the others.

"It started to snow on the way back and got so cold for us that we bought snow and ski caps to keep our ears warm," said Manabe Shimizu, one of the drivers. The only mishaps incurred were running out of gas and a burned out rod.

All mothers with bottles and nipples from the milk stations are asked by Mrs. Hazel Jackson, public health nurse, to return them at once. "There are over 300 babies in this center," Mrs. Jackson said, "and unless every mother brings in her supply of bottles and nipples that she has on hand, there can be no further bottles of milk issued." At the present time, there are about 100 bottles unaccounted for.

Although no new arrangement is being contemplated for milk stations, it is hoped that each station can be supplied with a hotplate in the near future. Nurse Jackson and Dr. Paul K. Ito are now conducting a survey of all the babies in the center. As soon as this is completed, the name of each baby will be put on individual bottles and milk will thereafter be issued accordingly.
