

### Heart Mountain High School Opens Tuesday

Twenty-five subjects will be taught at Heart Mountain's high school which will open Tuesday, Oct. 6, announced C. D. Carter, superintendent of schools. Classes will be held in block 7, buildings 13, 14, 15, 16, 17, 18 and the recreational hall.

Subjects to be taught include U. S. history, general history, civics, social problems, English, journalism, Latin, Spanish, chemistry, physics, general science, biology, algebra, general mathematics, advanced mathematics, business arithmetic, typing, bookkeeping, shorthand, art, home economics, agriculture, shop craft, physical education and band-orchestra.

Further details on high school will be posted on mess hall bulletin boards, said Carter.

Besides the regular instructors there will be five apprentice teachers, two each in the science and home economics departments and one in art.

Similar subjects are being planned for adult education in the evenings for which registration will open next week. Besides English classes for beginners and advance students, subjects to be offered are American history, social science, commercial and cooperative training, industrial arts and crafts, speech and dramatics. Wood shop, ceramics and art will come under industrial arts and crafts.

Four elementary schools are now open at 6-7, 12-7, 15-19 and 25-19. The fifth school will open Monday, Oct. 5, at 28-6 for children of blocks 27, 28, 29 and east half of 20.

Classes are held from 9-11:45 a.m. and 1-3:45 p.m. Mondays through Fridays.

Registration for issei and kibe beginners' English classes will be held at Block 7 mess hall, Tuesday, Oct. 6, from 9 a.m. to 5 p.m.

### Break in Water Pipe Repaired

Repair on a serious break in the pipeline, which caused water shortage for three days, was completed late Friday afternoon, Ben B. Lummis, project engineer, announced. The break was caused by the contraction of the welded joints in the pipe between the center and reservoir. The pipe was laid in the heat of last July, it was explained.

A huge hole was dug around the break to facilitate repair work. To prevent it from filling with water the reservoir was emptied.

Due to the difficulty in maintaining an exact balance between the supply and demand, water shortages were occasioned at times in blocks with high elevation.

Instead of one plate per barrack as erroneously reported in a recent issue, only four permits will be issued per block with not more than one in any barrack.

Since overloaded wiring constitutes a serious fire hazard, colonists are asked for their cooperation to prevent enforcement of drastic measures.

Horikoshi, both Mrs. Browne and Mrs. Douglas attended the first Heart Mountain women's meeting last Sunday afternoon. They brought clothing and flowers which were distributed to the needy through Mesdames Nagata, Nagumo and Takeshita.

### Statement on Dental Service Issued

To clarify a situation which arose some time ago after a notice in the bulletin, the office of Dr. Charles E. Irwin, chief medical officer of this center, today issued a statement of correction in regard to the dental services now available to colonists.

Dr. Wilfred Hanaoka, speaking for Dr. Irwin's office, said that both soldiers and center residents will be taken care of at the hospital dental clinic. Because of lack of proper tools and instruments and necessary materials, the soldiers who were cared for at the hospital were treated only on a prophylactic basis. "Some soldiers were sent to the dental clinic at 1-26 because of lack of material at the hospital clinic," Dr. Hanaoka said.

Patients living near the hospital or anyone desiring dental service may go to either the hospital dental clinic or to 1-26, Dr. Hanaoka declared. Dental clinic hours are from 8 a.m.-12 M. and 1-5 p.m. daily except Sundays.

### Charge for Cashing Checks Explained

"No profit is made by charging three cents for each check cashed at the canteens and dry goods store," stated Douglas M. Todd, head of community enterprises.

Shoshone National Bank of Cody charges Community Enterprises three cents to cash these same checks.

### Plans for Issuance of Clothing Pushed

Plans are being pushed for issuance of free clothing allowances to colonists, according to Philip W. Barber, chief of community services. John A. Nelson, administrative services officer, is reported working out a plan to distribute clothing on a credit basis at the department store as the contemplated script books will not be available for some time.

Dr. Gordon K. Chapman, secretary and treasurer of the United States Council of Churches, visited and discussed church work with the ministers of Heart Mountain last Wednesday. He is also a representative of the commission which is aiding the Japanese in the different relocation areas.

Dr. Chapman will also meet with ministers in Eden, Idaho; Salt Lake City, Utah; Los Angeles and Berkeley, California, and then return to his New York office to discuss and plan the Christian work to be carried out in the centers.

The Council of Churches which is headed by Dr. Frank Herron Smith, has 11 denominations and is working to raise \$15,000 for each relocation center. The Presbyterians have already donated \$20,000, according to Rev. T. Horikoshi.
