Approved Lists To Be Posted at Information Centers Tomorrow

Only heads of families may apply for and receive the clothing allotted by the government, the Service division stressed today when releasing the details of the clothing issuance, which is to be supervised by Mike Miyake.

Approved lists will be posted at Information centers tomorrow. Catalogs from Sears, Roebuck and Co., which was awarded the contract, will appear soon.

The issuance is retroactive to the date of the entry of the family into the Center. It is not necessary to use up the credit which is cumulative.

Census takers will notify applicants so residents should act only after being notified. The corresponding section of each district will be called simultaneously.

Davis Named Police Head

Appointment of Roscoe D. Davis as new chief of internal police at Santa Anita was announced today by Maj. Ray Ashworth, chief of the Interior Security branch of assembly centers.

Prior to his arrival here Friday, Davis was chief of internal police at the North Portland assembly center since its opening.

A native of Kentucky, Chief Davis is 45 years of age, having spent the first 25 years in that state. He lived in Oregon for the last 20 years. He is married and has two grown daughters.

The genial chief served as a member of the Oregon state police for five years. Prior to his North Portland position, Davis was general manager of the Packard Portland company.

He is a war veteran, having enlisted and served overseas during the first World war.

Since 1918 flying has been his chief hobby with golf ranking second.

Salt Lake City which was attended by Amory, the new war public works program is to be integrated with the WPA. This means that under the Lanham act the WPA state office in Los Angeles, headed by Amory, is now authorized to receive and process applications for war public works.

Amory defined these as essential projects having the endorsement of either the Army, Navy, Maritime commission or the War Production board.

"After the application has been processed here," Amory explained, "it will be sent to the regional (Continued on page 2)

(Continued from page 1) should first estimate the clothing needs of the family and spend the family allowance as he sees fit. He must then check the approved list as to price and catalog number. At the appointed time, he will apply for his family's clothing at the application unit, 25 Man o' War avenue, which is in charge of Saburo Muraoka.

After the application is checked by the Finance department, the order will go to the Supply and Warehouse department. When the goods are delivered, the census taker will notify the recipient. The issuance unit, under Richard Kubota's direction, is at 26 Man o' War avenue.

Center residents should check the approved list and catalogs at an early date to plan their orders in advance. Goods may not be returned even if unsatisfactory.

Regulations To Be Interpreted

To assist Center residents in solving their problems, to interpret Center regulations and notices correctly and to disseminate information on all phases of Center life and activities, Personnel Relations representatives have been assigned to each Information center daily from 8 a.m. to 4:30 p.m.

They will explain the function of the hospital, dental clinic, optical clinic

and mess halls. They will also outline the workings of the Social Welfare, Utility, Warehouse and Supply, Finance, Housing, Recreation, Personnel and other departments.

The approved list covers most of the inhabitant's needs and includes straw hats, cords and jeans, tennis shoes and sweaters for men. Women will be able to order aprons, hosiery, house slippers and other necessities.

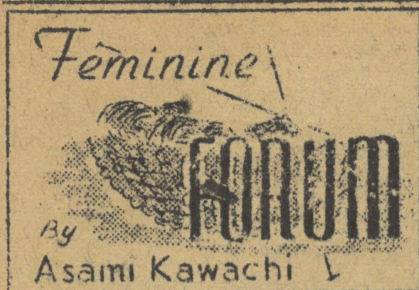

(Continued from page 1) Federal Works agency in Salt Lake. There it will be determined whether the project shall be operated by the Public Roads administration, Public Buildings administration or the WPA --all FWA agencies."

Amory stated that when a war public works project is operated through WPA it will be done by contract, with the payment of prevailing wages. WPA will also continue its program of relief projects, he stated.

As WPA administrator, Amory's duties in the southern California area will necessitate his full time at headquarters in Los Angeles.



Dr. Kenzie Nozaki Leaves for Guayule Research at Manzanar

The camouflage workers look up from their nets and see happy expressions on the middle aged faces of men and women studying English. Now the students are capable of writing letters to their relatives and friends.

We think the following two letters, composed by students in Tsuruko Katayama's class, exemplify the students' enthusiasm despite their difficulty in learning.

"Dear Mrs. Brown,

How are you? I am feeling fine.

I am going to school everyday. I am learning writing and reading. But I cannot so much memorize. So I am too old."

"Dear George,

These beautiful Summer days we are just fine over here.

What are you doing everyday in Poston, Arizona. I am going to school everyday learning my English language."

"They are a pleasure to teach," the teachers say of their pupils, most of whom are over 40 with grown children. "They are so grateful for the opportunity to learn and so willing in spite of their halting pronunciation," Tsuruko comments.

Some of them, like Mrs. Utako Kano, go without lunch so that they may stay for the afternoon classes. Unlike unruly youngsters, these students are as sensitive as they are enthusiastic. For example, they dislike to recite standing up.

The nisei teachers, 25 of them, are doing an inestimable job of breaking down the barrier which exists between the issei parents and their children.

The people's sentiment can be summed up in the remark:

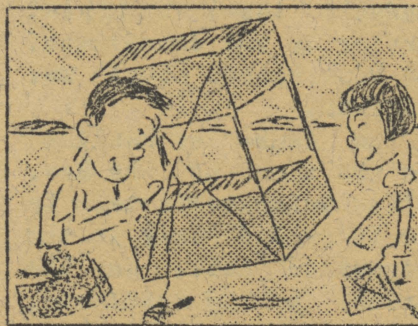

These rulings will go into effect on Saturday.

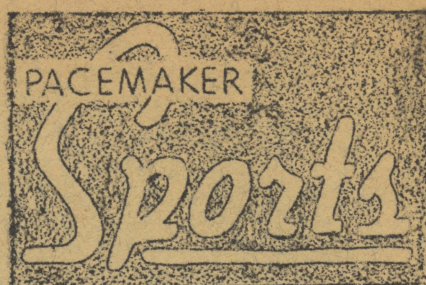
St. Marys in Tie

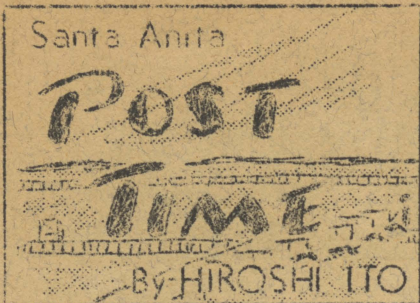

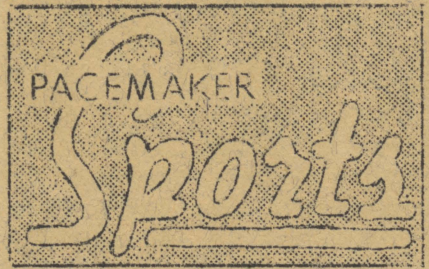
those interested in that brain tickling game, chess, should get together sometime, somewhere.

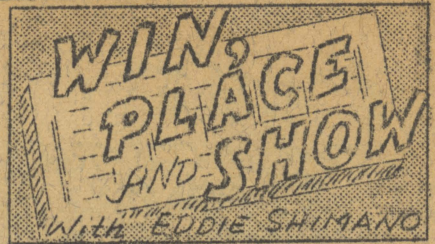

Fight for America in Our Way

Application forms for absentee ballots are available for Santa Anita residents who are eligible to vote in their former place of residence.

The absentee ballots must be in the hands of the Registrar of Voters before August 20.

Voters' registration will be automatically cancelled if ballots are not cast in either the primary or general election. In other words, failure to exercise the privilege of absentee balloting in the present primary election or in the general election in November will mean forfeiture of the voters' eligibility to participate in any further elections.

The right of franchise is not one to be taken lightly, either in theory and principle or in practice and practicality. Much impinges on this institution and its implications are many.

In principle this right of franchise may well be the "test of democracy," a phrase so much bandied about in recent times that its true meaning has become unfortunately obscured.

There are those on the outside who would deny to us on a racial basis the right granted to every American citizen by the Fifteenth Amendment to the Constitution which specifically states that "The right of the citizens of the United States to vote shall not be denied or abridged by the United States or by any State on account of race, color, or previous condition of servitude."

Those who would discriminate against a race on a racial basis alone are enemies of America. For us to passively lose the right of franchise by non-exercising of that right would be aiding in the victory of America's enemies. It thus becomes incumbent on us to fight for America, in our way, on the home front.
