### Mineta Bill Would **Have Supreme Court** Review WW2 Cases

SAN FRANCISCO — Rep. Norman Mineta (D-Calif.) will introduce a bill in Congress next month requiring the Supreme Court to review its decisions in the cases of Fred Korematsu, Gordon Hirabayashi and the late Minoru Yasui, according to JACL National President Cressey Nakagawa.

Nakagawa made the announcement at the JACL National Board meeting Sept. 17 during discussion about a proposal made during the Seattle JACL National Convention by Mike Masaoka. Masaoka wanted JACL to make an effort to have the Supreme Court review its decisions on the cases.

Nakagawa said that he spoke with Masaoka the previous night. Masaoka told him, "Norm will introduce a bill to persuade Congress to ask the Supreme Court to reverse its decisions on Yasui, Korematsu and Hirabayashi in the next session."

Disputing the constitutionality of the order, Yasui, Hirabayashi and Korematsu violated Executive Order 9066 during WW2. They to took their cases to the U.S. Supreme Court, which ruled against them.

Although the Supreme Court decisions still stand, Hirabayashi and Korematsu have since had their cases ruled in their favor in lower federal courts. Yasui was appealing his case until he died in November of 1986. His family tried to carry on the case, but it was decided that since the suit ended with the plaintiff's death.

### Uyehara Resigning as Executive Director of JACL-LEC

SAN FRANCISCO — Grayce Uyehara, executive director of JACL-LEC, announced at the JACL National Board meeting Sept. 17 her decision to retire from the post on Sept. 30.

Uyehara's retirement will come almost three years to the day of her becoming executive director of JACL-LEC on Oct. 1, 1985, when she replaced John Tateishi. She was a major actor in the redress movement, organizing letter writing campaigns at the grassroots level as well as helping guide redress to its enactment at the federal level.

During the announcement, she cited Mollie Fujioka and Mae Takahashi for their work on redress. One of her last official acts will be to host a dinner at the end of September for the staffs of the congressmembers who helped with the redress bill. The dinner will also recognize the major groups and individuals who assisted in redress.

Uyehara will be the keynote speaker at the annual meeting of the National Association of Japanese Canadians Oct. 8-10 in Montreal. She will also participate in the San Diego JACL's redress celebration, also in October.

While discussing her recent move, Uyehara revealed that she and her husband, Hiro have moved from West Chester, Pa., to Quaker retirement community in Medford, N.J. "It's a wonder I made it this weekend," she quipped. "I didn't even know where to find my clothes and shoes the other night when I had to pack."

After a round of applause from the board in appreciation of her dedication, Cherry Kinoshita said, "I think I speak for the board to say that we're going to miss Grayce . . . keep in touch."

### National Board Meeting

### National Director Search to Begin Soon

SAN FRANCISCO — Finding a new JACL national director was just one of the important priorities acted upon during the JACL National Board meeting held this past Saturday and Sunday. It was also significant since it was the first board meeting led by new JACL National President Cressey Nakagawa.

To fill the position as quickly as possible, a decision was made to begin advertising for the national director's position in mid-October. The ad will contain the proposed salary and other pertinent information. Interviews for the post are currently set to coincide with the next board meeting.

Resolution #7

Action was also initiated on genesis of forming a fact-finding presidential committee to investigate the controversial "healing" or "No No Boys" resolution. It was decided that the JACL staff would draw up options on factors such as costs, locations and committee make-up. This outline is due by the end of November so that board members can review it and find direction for the committee prior to the next board meeting.

At the National JACL Convention in August, the JACL National Council decided to form a committee to investigate the background of what happened between the JACL and the socalled "No No Boys." This was a result of a resolution by the Seattle Chapter to try to heal a rift in the Japanese American community.

The resolution was deferred until 1990 so that further study of the issue could be made. The resolution sought to apologize to Japanese American internees who, for a variety of reasons, answered negatively to a questionnaire administered by the U.S. government regarding military conscription and allegiance to the United States. Those answering "no" to the two questions feel that the wartime JACL "branded" those who answered "no no" as disloyal. Others, however, feel that the JACL did nothing improper.

Program for Action

A workplan put together by the JACL staff to implement this biennium's program for action was submitted to the board for for approval. The three-page document outlined goals and objectives, as well as responsibilities for each item.

"I think that if we recognize right off what the goals are," said Bill Yoshino, acting national director, "it's going to be a lot easier to implement the things that the National Council asked us to do." The workplan received praise from the board and was approved with only a few changes.

One of the recent developments in the JACL to provide a service to and attract members was the initiation of a JACL/Sumitomo Bank Visa affinity card. A portion of the meeting was devoted to an overview by bank representative Stan Takemoto, who spoke about the credit card program. In what was probably one of the highlights of the meeting, almost everyone attending the meeting were presented with Sumitomo Gold Visa cards (Editor's note: See related story on page 5).

### Public Affairs

Vice President of Public Affairs Cherry Kinoshita reported that the American Jewish Congress expressed interest in meeting with members of the JACL board during the next National Board meeting in February, a proposal which was approved by unanimous voice vote.

Kinoshita also reported that Mitsue Takahashi requested for the JACL to submit a letter supporting a review of her case by the California Supreme Court. Takahashi, a school teacher, was recently denied a chance to sue her school district for unlawful termination from her job for alleged incompetence. It was decided that Cressey Nakagawa would write the letter supporting the review of her case on behalf of the JACL

'Alarming' Figures'

New Vice President of Membership Services & 1000 Club Bob Sakaguchi announced "alarming" figures for JACL membership. According to Sakaguchi, JACL membership as of July 1988, was 20,048; the figure in December 1987 was 26,500. "I think the one of the things to remember here is that these figures," he said, "reflect up to July, and that we might have a few more after the membership campaign starts in October."

Sakaguchi, referring to the figures and the goals of the program for action, felt that JACL needs to "develop a very comprehensive and visionary membership development program during the next two years."

### Office of Reparations Administration Establishes Redress Hotline, P.O. Box

WASHINGTON — The U.S. Department of Justice has created a toll-free number and a post office box to handle queries from those who may be eligible for compensation under H.R. 442, the Civil Liberties Act of 1987, it was announced Sept. 16 by Rep. Norman Mineta (D-Calif.).

"I am very pleased that the Justice Department has set up a contact point for those with questions, and for the thousands of people eager to confirm their eligibility for compensation under the landmark Civil Liberties Act," said Mineta.

Those who have questions about their eligibility should contact the Justice Department's new Office of Reparations Administration.

The toll-free number, which was established Sept. 19, is (800) 228-8375. The number operates Mondays through Fridays, from 8:30 a.m. to 8:30 p.m. EDT. The new address is:

The Office of Reparations Administration plans to cooperate directly with the National Archives to help verify eligibility. Those seeking documentation of their experiences during WW2 should no longer contact the Archives unless they are seeking the documentation for their own personal use

Letters to ORA declaring that one is eligible for compensation should include the full birth date, Social Security Number, maiden name (if applicable), current address, address at time of relocation or evacuation, name of War Relocation Authority camp and dates of internment (if applicable), and brief description of other circumstances which would help in verification.

The office is hiring linguists fluent in English and Japanese to help answer questions. Under H.R. 442, which was signed into law on Aug. 10, approximately 60,000 Americans of Japanese ancestry are estimated to be eligible for a payment of \$20,000 as damages for the loss of civil rights due to U.S. government actions based on race during WW2.

### Census Bill Cleared for House Vote

WASHINGTON — A bill that would reverse the way the U.S. Census Bureau plans to count Asian and Pacific Island Americans on its 1990 census form was approved Sept. 14 by a congressional committee and is now cleared for a vote before the full House of Representatives.

### No More Offensive Products, Firm Assures U.S. Reps.

WASHINGTON - Sanrio, the Japanese company recently forced to discontinue its line of children's products, has responded to strong concerns voiced by three California lawmakers.

Reps. Robert Matsui, Norman Mineta and Julian Dixon (all D-Calif.) received an Aug. 24 letter from Shintaro Tsuji, CEO of Sanrio Co. in Tokyo, in response to objections they voiced against the firm last month.

The congressmen charged the company with displaying "insensitive and extremely disturbing" judgment in its use of derogatory depictions of Blacks as a marketing tool, as evidenced by its line of "Little Black Sambo" toys. The congressmen also requested a meeting with Sanrio officials to educate them on improving their relationship with American minorities.

Tsuji's letter assured Sanrio's recall of the toys and promised that the company would not deal in any products "which could offend the justified feelings of any group."

sui's bill would retain the form's categories of Japanese, Chinese, Korean, Filipino, Vietnamese, Asian Indian, Hawaiian, Guamanian and Samoan and add two more subgroups, to be determined by the bureau. The legislation would also contain a space for respondents to write in their subgroup if not found in the check-off list. H.R. 4432 is an amended version of a bill earlier introduced by Matsui

in response to the bureau's original plan for the 1990 census. Last fall, the bureau had announced that it would rely on information from its sample questionnaire, which would in effect lump all Asian and Pacific Island Americans into one group. In May, the bureau assured the congressman it would tabulate all Asian and Pacific Islanders on a 100 percent basis, but respondents of the census form would write in their subgroups.

The reason for the write-in format, according to the bureau, is to save space. Citing the language barrier many Asian and Pacific Islanders face, community leaders fear the system may prohibit an accurate count and impair the delivery of social services, such as employment programs.

"Despite what the bureau might hope, this issue is not about to go away," said Matsui. "We have the momentum to block this ill-fated plan before the 100th Congress adjourns. The delivery of many federal and local services depends directly on an accurate census count. I am confident my colleagues will agree that Asian Americans deserve a fair and accurate count."

The measure is expected to reach the House floor later this month.

### Hayes Nominated for Calif. State Treasurer

SACRAMENTO — State Auditor General Thomas W. Hayes has been nominated for the post of California state treasurer by Gov. George Deukmejian. If confirmed by the state Legislature, Hayes, 42, will assume the office vacated by Democrat Jesse Unruh, who died last year. It has been speculated that Hayes was chosen because he would easily win legislative confirmation. Hayes, who is not affiliated with any political party, has been described as a longtime, respected employee of the state Legislature. Confirmation of Deukmejian's first choice, Rep. Daniel Lungren of Long Beach, was rejected by the state Senate and, subsequently, the state Supreme Court.



Though Tsuji added that he could not immediately meet with the lawmakers in Washington, D.C. for further discussion, Matsui said he would explore other alternatives and continue to ensure that Japanese firms do not take American civil rights lightly.

In a related matter, Hallmark cards, Inc. has also moved swiftly to make sure that cards carrying its logo in Japan do not offend minority groups.

Matsui brought the issue to Hallmark's attention earlier this month after learning that a post card featuring stereotypical Black characters was being distributed in Japan under the Hallmark logo. The cards were distributed by Sanrio Co.



### EEOC Sues Hyster for Anti-Japanese Ad Campaign, Use of Racial Slurs

WASHINGTON, D.C. — The U.S. Equal Employment Opportunity Commission (EEOC) has filed a suit in the Federal Court in the District of Oregon charging Hyster, a major manufacturer of lift trucks, with national origin discrimination against Max K. Ozawa. The commission's suit alleges that Ozawa was subjected to harassment based on his Japanese ancestry through the company's depiction of Japanese characters in a racially objectionable form in its advertising campaign and by the use of anti-Japanese slurs in the workplace.

Ozawa, who had complained about the ads to Hyster's higher management, charged that the depiction of a warlike Kabuki actor, a Samurai with a partially drawn sword, and a Sumo wrestler in the company's ads aroused anti-Japanese sentiment by portraying Japanese race as a "brutal, threatening and fierce people."

Others, including the JACL and the Asian American Legal Defense and Education Fund, joined him in stating that the advertisements were racially derogatory in nature. Hyster's own

customer survey noted that the ads could be offensive in the Seattle area because of the high number of Japanese Americans residing there.


In addition, Ozawa reported hearing the company's management and his co-workers uttering anti-Japanese racial slurs. The company later explained that its use of the word "Japs" was an abbreviation for Japanese and no different than referring to a "caterpillar" as a "cat."

Hyster's unsatisfactory handling of the negative ad campaign, along with its use of racial slurs, reportedly subjected Ozawa to stress-related health problems. After a 20-year career with the company, noted with excellent performance evaluations, he resigned from his job as a project engineer.

In its suit, the EEOC is seeking full backpay and other relief for Ozawa, as well as injunction under Title VII.

Responding to Hyster's explanation for the slurs, EEOC Commissioner Joy

### Games Show Korea's Vitality


THE TELEVISED opening ceremonies of the Olympic Games in L Seoul, Korea, were a colorful, moving spectacle. They spoke of the vitality, the imagination, discipline, talent and pride of a people and nation.

The verve with which the Koreans are staging the Olympics is all the more remarkable in view of that nation's recent history. For more than four decades Korea was colonized by Japan in a harsh occupation that sought to destroy the Korean culture. That occupation was ended by Japan's defeat in World War II, but Korea's liberation was tainted by Allied error in allowing the northern half of the peninsula to come under Soviet influence.

Less than five years later, the communist North Korea government attacked South Korea. That war was fought to a devastating and uneasy stalemate by the United States and other United Nations powers. It leveled Seoul, destroyed hundreds of villages, and left the South an economic basket case. It also opened the way for tens of thousands of Korea's most enterprising and aggressive citizens to migrate to the United States under provisions of the Walter-McCarran Act, pushed through Congress by JACL to eliminate racial bias from American immigration and naturalization laws.

But obviously all of Korea's talent was not drained away. Korea's economic recovery has been phenomenal. As hosts for the Olympic Games, Korea has demonstrated impressive originality, organizational ability and a flare for showmanship.

Korean Americans have a right to be proud of the performance of their ancestral homeland. And all Americans can be pleased that some of the Korean culture and determination to succeed have been brought to the United States by immigrants. One of the strengths of America is the diversity of the cultures that make up the nation. 
Now, I've met both.

### The Limited Future of Nisei Leadership

Twice in recent weeks I've been at gatherings of old Nisei friends, mostly people I haven't seen for years if not decades. If the passage of time is not obvious each morning when I look into the mirror to shave, it was startlingly apparent at these get-togethers. Wrinkles. Gray hair or no hair at all. Paunches. The tell-tale shuffle that has replaced purposeful strides.

Despite all that, we enjoyed ourselves. Memories that had been hidden for years surfaced and were vivid again. We talked about people we had known, and the pleasurable things we had done together. As one of the old gang observed, it's an odd thing that we seem to remember clearly something that happened 50 or 60 years ago, but we can't recall what we had for dinner last night.

Few of us who grew up during the same era have distinguished ourselves. None grew very rich or very prominent, but most, I would say, shaped reasonably good lives and now live reasonably comfortably in retirement. Is there much more that one could ask

for? One might say this is remarkable in view of humble beginnings and prejudice and discrimination, and the most traumatic experience of all, the Evacuation, which might have destroyed a lesser people. It didn't, because we wouldn't let it.

But more and more I discovered that our conversation would drift toward current health concerns. Matters like high cholesterol, low fat diets, blood pressure and medication for keeping it under control, strokes, heart attacks and that dreaded C word, cancer.

We talked, too, of who had died since last we met, and were made aware—not morbidly but simply aware—of our own mortality. The thought was left unspoken, but surely each wondered how many of us would be gone when next we meet.

If the average age, not necessarily the median age, of Nisei was about 18 at the time of the Evacuation, those kids who were 18 in 1942 would be 60 years old this year. That tells you something of the graying of the Nisei generation and its limited future as an economic or leadership force.

If Japanese Americans are to retain their identity, then it is high time the Sansei and Yonsei generations step forward. Not that they haven't, of course. They played a highly prominent role in the recent national JACL convention, but still their profile was low in relation to their numbers, skills and leadership abilities.

There is another side to this matter that deserves thought. Is retention of Japanese American identity desirable or important? A couple of decades ago the answer would have been no. Today it would be a firm yes. Today the emphasis is on retaining ethnic culture and ethnic identity in the American stew pot. Celebrating our differences is just fine, provided we don't overlook our mutual interests as Americans. What the national attitude will be at the turn of the century, only a dozen years ahead, is anyone's guess.

I started to write a column about some geezers getting together to shoot the breeze, and it turned into quite something else. Excuse me. You know how it is with old guys.

## Program Is an Investment in Community's Future



We have completed yet another year of the JACL National Scholarship Program, and this year's scholarship supplement to the Pacific Citizen (Sept. 16 P.C.) showcased the many highly qualified recipients of the 1988 scholarships. On behalf of the National JACL, I congratulate all of the scholarship recipients for their achievements and hard work.

The scholarship program is perhaps the JACL's longest continuing program and has been in existence for 42 years. Since the JACL awarded its first scholarships in 1946, the national scholarship program has steadily grown to an endowment exceeding \$500,000, with 37 scholarships totaling more than \$50,000. Since 1983, the JACL has awarded over a quarter million dollars to nearly 200 promising individuals studying a variety of disciplines including law, medicine, the fine arts, as well as disciplines within the sciences, humanities, and social sciences.

What makes our scholarship program unique is that it encourages our youth to pursue different disciplines. For example, the scholarship program offers awards to individuals studying economics and business, law, medicine, creative arts, and the performing arts. One scholarship is dedicated to graduate research on cancer, and beginning in 1990, the scholarship program will offer a scholarship dedi-

cated to the sport of judo. The judo scholarship, dedicated to the late Yutaka Nakazawa, will be awarded to an individual aspiring to study or compete in judo in college.

Our scholarship program is important because we are investing in our community's as well as our country's future. Through the JACL National Scholarship Program, our youth are encouraged to develop their respective talents and interests for the benefit of society, in addition to furthering their own academic careers. The youth that we encourage and challenge today will become the business and political leaders, professionals, journalists, artists, and musicians of tomorrow.

In short, you will find the backgrounds of all of the recipients this year indicative of the success of the National Scholarship Program. However, the program's sucess was also due, in part, to the contributions of past and present members of the JACL.

Cherian asked, "How insensitive can you get?

"In the historical context of the Second World War internment of Japanese Americans on the West Coast, when the term 'Japs' and other derogatory words were used to refer to Japanese people, one has to be very insensitive to make that comparison."

Cherian added, "It is one thing for a company to have a hard-hitting ad campaign against foreign competition, quite another to use racially offensive pictures or words. Let there be no mistake that this commission finds the latter totally unacceptable. Such conduct fuels an atmosphere of racial animosity in the workplace and is illegal under Title VII."

EEOC's suit enforces Title VII of the Civil Rights Act of 1964, which prohibits employment discrimination based on race, color, religion, sex, or national origin; the Age Discrimination in Employment Act, which protects persons 40 years of age or older; the Equal Pay Act; and prohibitions against federal employment discrimination affecting individuals with hand-

### BOARD MEETING

During this portion of the meeting, Mas Hironaka and Tom Arima spoke about the status quo of the 1000 Club and the lifetime membership dues. During a promotion to add new 1000 Club members, the price was temporarily dropped to \$500 dollars, with a deadline of the 1986-88 biennium for the reduced fee. However, about a dozen people sent in membership checks of \$500 since the end of the National Convention. As a result, a motion was made to keep the rate of \$500 until Jan. 1, 1989, at which time it will go to \$1000.

Sakaguchi asked Alan Nishi, JACL treasurer, to report on the latest news of the SRS membership program. Nishi reported that the JACL is now free of the SRS contract and that their final membership campaign will take place this fall.

Treasurer's Report

During the treasuer's report, Nishi reported some bad news on the fiscal front. "We are falling behind on membership from last year—we're approximately \$10,000 behind as far as last year's pace on individual memberships and also about \$25,000 behind on family memberships," stated Nishi.

Based on past trends, however, Nishi estimated that about \$120,000 will be coming in during the next four months, with possibly \$5,000-10,000 of that actually early renewals, meaning a shortfall of about \$30,000-40,000 on revenues for membership.

One of the reasons for the shortfall is that the SRS renewal program that was supposed to begin last spring is just now beginning. "Hopefully, that should be able to reach about \$30,000," related Nishi. He also informed the board that about \$6,000-8,000 will be forthcoming from the JACL Sweepstakes. He concluded by stating, "We are now in a position where we are going to have to borrow again this year."

President's Remarks

At the beginning of the meeting, Nakagawa emphasized that he felt that fundraising was one of the responsibilities of each board members. The board seemed to agree, with PSWDC Gov. J.D. Hokoyama adding that it would be good to put together an informational packet to help "sell" JACL to potential donors.

Nakagawa only had one National Committee appointment to announce at the meeting, that of JACL legal counsel, which will be chaired by Don Tamaki, with major assistance from Dale Minami. Both are San Franciscoarea attorneys best known for their work in the *coram nobis* cases. The appointments were approved quickly and enthusiastically.

Nakagawa also announced later in the meeting that he has begun scheduling dates of availability for community events.

### Additional Information

At the close of the meeting, three outgoing district governors, Mollie Fujioka, Steve Hasegawa and Mae Takahashi, were presented awards of appreciation for their service to their districts and the JACL.

The next two meetings were scheduled for Feb. 3-5, 1989 and May 19-21, 1989. Complete board motions will appear next issue.
