NATIONAL BAPTIST LEADER SPEAKS ON CIVIL RIGHTS

Dr. Jitsuo Morikawa, Secretary of the Department of Evangelism Planning of the American Baptist Convention headquarter in Valley Forge, Pennsylvania, was back in Seattle June 22 at the Japanese Baptist Church to continue his talk on the civil rights revolution. The topic

matter was integrated into a sermon and seminar followed immediately.

He showed his concern on the inactivities of the Nisei. "Where are the Nisei contributing to the common cause for the welfare of others?" Dr. Morikawa asked. "Support of the Churches? American Civil Liberties Union? American Friends Service Committee? Mississippi Delta Ministry? Southern Christian Leadership Conference? Where do you give your time? Political activities? Urban Renewal program? Community action group? World Without War movement? You may count on the people who support these movements and causes as the people who will come to your aid and protection when you suddenly find yourself victim of the irrational community outbreak. And the people who feeds your ego and appeal to your prejudices who regards you as their "kind" but reject the black men and the Mexicans are the very ones who will betray you in the moment of crisis."

History Repeating?

Dr. Morikawa commented on the parallel existing between the Vietnam crisis with the events just prior to WWII for Japan. He spoke of the careless indifference of the Japanese populace "living in danger and unconcerned" and their "failure to challenge the growing power and takeover by the military establishment." Prince Konoye's vacillation and leadership, he stated, was no help for the people to rally the nation towards peace and peaceful settlement with international dispute.

"Disciplined military clique," he said, "driven by paranoid fear of American Imperialism and Chinese threat to national economic welfare, drove the unsuspecting nation down the

road to national suicide and destruction.

"Contemporary American appeal to the danger of International Communism have a strange similar ring. In the name of this presumed threat through appeal to neurotic fear for their national security our nation leads the world in building of armed garrison state. Virtually everything we do is against the backdrop securing our nation against foreign attack, all the way from the building of highways to the placing of man on the moon."

Challenge to Smugness?

Dr. Morikawa disagrees with those advocates who think that all is well with the nisei. Dr. Morikawa had this to say on this subject: "In the future in the moment of national crisis, we Japanese Americans and the blacks and the Mexicans and the Indians are all going to be lumped together despite the fact right now for the last ten or fifteen years we Japanese American really felt that we 'have it made' in contrast to the other minorities. We don't have it made because in the eyes of the great number of white Americans we are still a minority." Katagiri's Comment

Also present in the audience was Rev. Mineo Katagiri, a senior minister of the Eucume: nical Metropolitan Ministry. He was asked to give the closing thoughts for the meeting.

"I am concerned about the sansei and yonsei who are coming up without a kind of identity or knowledge of who they are and what their heritage will be," he said. Katagiri said that he was concerned with their self image in relation to the social revolution taking place.

"Increasingly," he continued, "the orientals are being left out. The upward mobility has just about hit the ceiling. Finally in about ten or fifteen years in the City of Seattle and the rest of the country the orientals are going to rise and engage in equality on the coat tails of the blacks." And for this reason Katagiri feels it is important that the orientals make contribution now in the current movement.
