CHAPTER TO MEET THIS WEDNESDAY, SEPT. 17 TO DISCUSS IMPORTANT ISSUES.

The September membership meeting will be held this Wednesday, Sept. 17 from 7:45 p.m. The Pacific Northwest District Council meeting and possibly the law and order issue affecting the Japanese community may get some airing. Japanese American Centennial program will cite the Wakamatsu Week symbolizing the 100 years since the first Japanese immigrants were admitted to the United States. Representative Brock Adams has been instructed to help insert the State of Washington Issei Story in the Congressional Records. 60 copies of \$1 Centiennial booklets have been sent to various schools in the Seattle Public School systems and to the public libraries. Mimeographed insert may be enclosed with this newsletter on the history of issei in this area. If not, it should be enclosed in the following publication.

Membership drive is still in progress. Tak Kubota reported in the last meeting that 617 members have been assured so far and over \$400 in donations has been received. List of donors will be published in the future issue. We are very close to the JACL quota and any members signed from now on will benefit the Chapter in the form of generous rebate from the National Headquarter, New members will get full credit for year's subscription to the Pacific Citizen weekly. Chapter dues are \$8,50 forsingle member, \$6.50 for husband or wife of member. National 1000-Club dues are \$25 and 1000 Clubber's Chapter dues are \$2. Make check payable to

Youth Concern Committee headed by chairman Dr. Joe Okimoto reports that International Chapter of the Kiwanis International made available cases of coke and the machine for Teen Center. Devenports and easy chairs were loaned by the Blaine Temorial Methodist Church. The highlight of the program was the weekly rap session when teenage and adults exchanged ideas to bridge the communication barrier. With the opening of school term, Teen Center summer recreation program is closed for the year almost as soon as it was opened. But the procedures were crystalized and many lessons learned. The activity will continue periodically such as the flower arrangement introduction for the teenagers described elsewhere in this newsletter. Issei Victimized in the Upsurge of Criminal Activities

An appeal on crime condition has been received by the Seattle Chapter to do something in the approximate area bounded by Weller, Spruce, 14th and 23rd. The tabulation of muging and attack on older citizens showed 44 cases within 4 block radius in a short span of time. Many crimes were committed brazenly in broad daylight. The letter received by the Chapter stated that "calling of police has produced no concrete action or solution. Some has been hospitalized more than once." The letter signed by pharmacist George Tokuda, spokesman for the issei in this area with law breakdown problem, continues "I, as a citizen and taxpayer, feel that certainly, somewhere, someone will be sympathetic and helpful in bringing some solution and protection of the old." Tokuda's letter was accompanied with copy of another letter sent to Councilman Sam Smith, Chairman of the Law and Order committee of the City Council.

A challenge has been sent to the Seattle Chapter. We welcome everyone who is interested in helping resolve this crisis to attend the next meeting to help bring pressure to the city and police department. Lack of safety in walking the streets in your neighborhood is an infringement of human rights. Let's show the concern for the issei who have suffered too much

and too long.

Regular monthly meeting is set for this Wednesday, September 17 at the JACL office.

JACL CIVIL RIGHTS COORDINATOR RAY UNO TO ATTEND PNW DISTRICT COUNCIL MEETING
Ray Uno, National Civil Rights Coordinator, plans to be in Seattle, Saturday, Sept. 20 to spend the day listening to and observing the scene.

Towards that, plans are being formulated for Ray to talk with diverse persons from different racial groups of the community. The schedule is being arranged by Phil Hayasaka and Don Kazama. Hopefully the scene in Seattle may provide some ideas to Ray for JACL, locally as well as nationally.

Another issue is the generation gap. The sansei evidence this in many and fifferent ways and some of this was found as a result of the Teen Center this summer. To this, arrangements are being laid for dialogue with the sansei. Joe Okimoto is coordinating this end of it.

APPLICANTS BEING SOUGHT FOR PROPOSED 16-STORY RETIREMENT HOME

The Kawabe Senior Citizens Fund, Inc., a non profit corporation, and sponsors of the 16-story retirement home to be built soon, is taking application for residence. This initial application is not binding. The minimum age is 62 years and the maximum annual income from all sources shall not exceed \$4,500 for single person and \$5,400 for couple.
