Military-civilian relations during wartime highlight the problems of individual rights as against governmental powers in emergency periods: The Civil Way case of Ex Parte Milligan and the WW2 case of Korematsu v. U.S."

During March meeting Dr. James K. Morishima, Director of Institutional Educational Research at the UW, speaking on the course on "The Japanese Americans," stated that 30 had enrolled last fall and the class has doubled to 60 for the winter quarter. California school system has a more comprehensive program in this area for they are systematically budgeted and such is not the case at the UW. The most interesting topic for discussion is evacuation. Sansei complains that Nisei parents are relectant to talk about their camp experiences.

Tomio Moriguchi has already called two committee meetings, the first on Mar. 19 to establish basic goals and to select committee for Seattle JACL golden anniversary celebration to be held latter part of September with official banquet, a luncheon with "rap" session for youth with prominent persons, and a dance. Hyakunenzakura committee met Mar. 12 and will meet again this week. \$5,000 of the \$15,000 goal has been pledged according to H.T. Kubota, treasurer. Tak Kubota is vice chairman for fund drive to translate and publish the history of Northwest Japanese pioneers.

For later enrollment up to June 15, the coverage begins July 1 since the premium is paid on quarterly basis.

During this open period the previous medical conditions will be covered and applications accepted, however, if such participants are under medical treatment at the time of coverage, they will not be covered until they have been discharged for 30 days. Such cases may be subject to review. YOUNG ASIANS FOR ACTION DONATES FUND TO ASIAN DROP-IN CENTER

YAA met Mar. 29 at the Japanese Presbyterian Church with YAA chairman Susan Tomita presiding. Blood bank drive was started to be made available to anyone, especially elderly Asians. YAA went on record to assist in the proposed cultural center in the International District as proposed by Eric Inouye. As a fund raising project a poetry book will be published with John Eng and Larry Matsuda in charge. Report on the Asian Drop-in Center sponsored by JACL shows it is hurting for money. Rather than split the \$300.00 Christmas card sales profit as previously agreed, the YAA voted to give 50% of their \$400.00 treasury to the Drop-in Center. Decision on Methodist Conference's funding for Asian Minority is still pending. Contingents of YAA observed the proceedings of the Model City Advisory Council of Apr. 6.

INTERNATIONAL DISTRICT BIDDING FOR BIGGER SHARE OF MODEL CITY FUND

Probably it will be difficult to pin point a single cause for sudden turn of event when the International District comprising 5% of the Seattle Model City Program (SMCP) area refused to be satisfied with the 0.9% share of the \$10.4 million granted by the Federal Government the past two fiscal years. International District Improvement Association (Inter-Im) has been evaluating their submissive role with SMCP. Probably if coordinator Eric Inouye continued to . play this same role the usual share of the pie might be forthcoming. But this role is inconsistent with Sansei thinking.

In early March the Inter-Im wrote a 4-page letter to Mrs. Dorothy Hollingsworth, Deputy Director for Planning, SMCP which read in part: ". . . We cannot and will not continue under the present arrangements with SMCP. . . To effectuate a more equitable treatment of the International District will require initially the resolution of legal questions related to the status of Inter-Im as a contractor as well as questions regarding the inherent liabilities on the part of the SMCP and Inter-Im. If these questions can be resolved, then, perhaps, we can begin to address ourselves to programmatic questions and answers which are more commensurate wik with the needs and problems of the International District . . . " The letter was signed by president and coordinator of Inter-Im.

Inter-Im made a proposed project request for the \$34,000 budget for a multi-lingual recreational and cultural center for non-English speaking people. and certainly fitting into the sensitivity program for these needy.

On April 6, the Model City Citizens Advisory Council met to consider this request. A letter was read addressed to Judge Charles V. Johnson, chairman of the Council, which said in part: "We have two basic concerns: first is the plight of the Asian elderly in the Model Neighborhood who are non-English speaking and who suffer from public ignorance and neglect. The Model City is not serving and is unable to serve these people because it apparently has no provisions for Asian bi-lingual case workers and other pertinent skilled personnel.

"Our second concern is the plight of . . . other charcteristically indigent groups represented in the International District. They include the elderly, the recent immigrants, t the Skid Road Transients, who live under the condition of socio-economic isolation and neglect . . It is our feeling that none of these projects will serve our concerns unless directed to do so by the Citizens Advisory Council." --signed by Chinese Community Services Organization, JACI, Filipino Community of Seattle, Inc. and Catholic Priests Association.

Nevertheless the Advisory Council voted 15-14 against the Inter-Im proposal citing that proper procedure had not been followed.

Oriental members of the audience walked out of the meeting after the vote and gathered angrily on the steps of the Lemieux Library at Seattle University. One of them shouted, "Power to the people -- the Asian People!" as he left.

Inouye said his group was threatening to withdraw the International District from the model area "because we don't get anything anyway." Inouye receive about \$1,400 a month to perform community services in the International District and that is all the area has received and that it gets by on the volunteer work of a few priests and other individuals.

In the meantime Inter-Im is working on several avenues of approach to break this impasse.

They will be the official citizens' groups in each high school attendance area to make recommendations to the Seattle School Board concerning education in that high school attendance area.

The Franklin area and the Cleveland area are the two high school attendance areas which have the largest number of Japanese-American students in the city. Do you want a voice on these councils? Join with other groups in making decisions which will affect your children. The Citizens' Advisory Councils won't be another false start if you get involved. For example, these councils have the authority to make recommendations concerning who is the principal of your child's school, and will play a primary role in carrying out the desegregation of the Seattle schools—which will happen. Asian children will be involved in desegregation plans and if you want a voice in the changes which will occur in the Franklin and Cleveland areas in the next few years—GET INVOLVED—BE A CANDIDATE!

Did you know that a recent study of Sharples Junior High students showed that almost one-third of the students entering seventh grade were reading two or more years behind grade level? What's wrong? Why is the system failing so many children? The citizens' advisory councils give an unprecedented opportunity for citizens to directly influence policy on all matters dealing with education--pressure to which the School Board must be responsive. The only candidate requirements are that a candidate be 18 years of age or older and be a resident of that high school attendance area in which he or she is a candidate; or be a parent or guardian of a child attending a school in that area. The tentative candidate filing date has been set for the first week in May and the tentative election date has been set for May 25. COMMUNITY ASKED TO HELP LOOK FOR TOP LEVEL CANDIDATES FOR COMMUNITY COLLEGE POSTS By Dr. Minoru Masuda, Seattle Chapter President

The Oriental Student Union has been pressing for the hiring of Asian administrators at Seattle Community College, especially at the Central campus where there is a large body of Asian students. Many community organizations have supported the OSU in these legitimate requests. The Asian group has met with the SCC Board of Trustees on two occasions to press their case. The Board understands and agrees to the need but has not hired any Asians in the upper echelons.

A couple weeks ago, Dr. William Moore, president of the Central campus of SCC announced his resignation and the search is on for the hiring of a new president. The Asian group has maintained that this position should go to an Asian and we have so told the SCC Board. We have offered to help recruit Asian candidates for this position and they have welcomed this offer. In order to cast our net widely, the Asian (Cont'd next page)

SEARCH FOR HIGH LEVEL ASIAN ADMINISTRATORS: (Cont'd) community group is exploring all avenues of recruitment for top level candidates. In addition to our other recruitment channels, we want to ask the community to reflect on individuals whom they know would be a capable college president for SCC.

The acamedic and professional qualifications are roughly as follows; Teaching experience at the community college level, experience in a high level administrative position in an urban, multi-ethnic college, experience in curriculum development and administration, educational and administrative background in academic and technical education, experience in working with multi-ethnic minority high risk students. Demonstrated a ility to maintain support with students, staff and community and distinct leadership qualities are desirable requisites.

Academic degrees are not as yet specified, but presumably a Master's degree seems to be minimum if bolstered by years of experience. A Ph.D. degree would be a distinct enhancement to administrative experience of the specified sort. A finalized job description brochure should be forthcoming soon.
