The State Capitol Museum and the Japanese American Citizens League announce the receipt of a \$6,666.00 grant from the National Endowment for the Humanities for a project that will tell the story of the Japanese American in the Pacific Northwest.

The project will be in the form of a public program including a portable exhibition packaged to travel and public presentations by members of the Seattle and local JACL chapters. Program planning will be under the direction of Dr. Minoru Masuda, Associate Professor in the University of Washington Department of Psychiatry while exhibit collection and design preparation will be under the direction of Mr. Tomio Moriguchi.

The exhibition will be titled "The Pride and the Shame."

"Pride" refers to the proudness and spirit of an immigrant race that came to these alien shores to seek its fortunes. "Pride" means their families and their children, the second generation Nisei, marginal, trying to bridge the gap with one foot in the community and the other in an unfriendly majority society, striving to fulfill the dreams of achievement.

"Pride" means the Sansei, the third generation, seeking now to establish their identity, working to redress the inequities of society in their own different way.

"Shame" means that the history of discrimination is a part of the immoral tapestry that has also bound up the history of the Nikkei people in their struggle for a place in the sun. As the Nikkei people seek now to eradicate inequities that exist in all fields of endeavor for all minorities, it is the "Shame" of American society that such inequities exist.

Struggle of Minority in American Society

Colorful exhibits will feature photographs, models, and documents telling of the history, accomplishments, disasters, and aspirations of the Nikkei people from the turn of the century to the present. While the evacuation story will be an important focus, the presentations will also put into perspective the socio-politics of a minority group in the struggle in American society. The exhibits will be supplemented by traveling teams of "experts" in public programs combining talks, panel discussions and workshops. Among the topics to be covered will be immigration, Issei distribution and occupations, the socio-political-economic history of discrimination, the Japanese community and its organizations, social psychology of the three generations, the accomplishment of the Nikkei, and the present status and views of the Japanese Americans. In these public forums, local Japanese American groups will help coordinate, participate in, and contribute to the program.

Kenneth Hopkins, director of the State Capitol Museum, said the project will be an important part of the museum's plans to develop a program to bring about a better understanding of the history of minority groups in the Pacific Northwest. The museum, Hopkins said, as an agency representing all of the people of the state, must identify and properly present minority history, so often neglected, in an honest manner.

"The Pride and the Shame" will be seen in a dozen Washington communities during 1971 and 1972, particularly in those where the evacuation was most strongly felt.

Dr. Masuda said, "The Nisei and Sansei who have helped put this exhibit together hope that it will show the uniqueness of the Japanese race and that the frictional blending of people can produce in its historical course an ironical blending of both prideful accomplishments and shameful events."

The State Capitol Museum is operated by the State Capitol Historical Association, 211 West 21st Avenue, Olympia, Washington.

INTER-IM CITED AS THE OUTSTANDING CIVIC ORGANIZATION OF YEAR

Seattle-King County Municipal League named the International District Improvement Association (INTER-IM), a 2½ year old civic action group the outstanding Civic Organization of 1971, during their civic awards luncheon held Apr. 22 in the Washington Athletic Club. Tomio Moriguchi, group president, accepted the Municipal League award in behalf of INTER-IM. Moriguchi is also president-elect of Seattle Chapter JACL.

The organization was formed in 1968 for the specific purpose of opposing the proposed Fifth and Yesler site for the County multi-purpose stadium. Attention then turned to self-improvement programs for the International District.

These were not just "talk programs," but were programs which produced specific accomplishments, such as: initiation of two park projects (Hillside Park and Chinatown Minipark) which are midway through development; initiation of a Turnkey housing facility for the elderly, slated for construction late this fall; preparation of a comprehensive land use plan, scheduled for public review this spring; initiation of a massive street lighting project which is presently 90% completed; assistance in the rehabilitation and conversion of the former U.S. Hotel into a low income apartment facility now known as the "International Apartments"; assistance to small business administration loans; assistance in the implementation of a Neighborhood Health Station and a Neighborhood Social Service Center for Skidroad, of which the International District is a part.

These successes have generated even bolder plans for the future including the proposed Community Resource Center, an Asian Cultural Trade Center, an Asian Cultural Trade Center, and plans for the formation of a limited-dividend local Development Company economic self-help.

At this writing the INTER-IM have negotiated with the Seattle Model City Program (SMCP) for the non-budgeted 50% share of \$110,000 Asian Cultural and Social Services Center with hopes of getting a matching fund from other HUD agency. Earlier SMCP had turned down \$34,000 budgeted request (P.C. Apr. 23). Eric K. Inouye is coordinator for the improvement group in addition to heading community involvement committee of Seattle JACL Board.

PORTLAND CHAPTER ADVISORY BOARD URGES GOVERNOR KUBOTA FOR EARLY PNWDC MEETING DATE

Don Hayashi, Portland Chapter president and speaking for the Portland Advisory Board, issued an urgent call for the Pacific Northwest District Council to meet at the "earliest possible time." Check on the possible PNWDC meeting date finds that it has been tentatively set for June 13 in Spokane. Hayashi in a letter dated May 5 writes: ". . . We have not met since Jan. 17, and there is pressing business which rightfully should be discussed openly at a District Council meeting. These include:

- a. choosing a Health Insurance Coordinator and developing sufficient publicity
- . b. strategizing the campaign to eliminate the Emergency Detention Camp Act
- c. seeking Asian American administrator candidates for Seattle Community College in support of the Seattle Chapter
- d. arranging the schedule for traveling exhibit (Pride and Shame) on evacuation and relocation with the Seattle Chapter
- e. initiating inter-district communication with the Intermountain District Council if we are to conduct a joint District Convention this winter
 - f. considering the possibility of a JACL Regional Office in the PNW with JACL staff
- g. coordinating plans for the 1973 National Bowling Tourney and 1974 National Convention in Portland with the Portland Chapter
- h. ratifying a new PNWDC Constitution (Drs. Tsujimura and Kanda have submitted a proposal already)
- i. setting up definite times for District Council meetings and directing District Council committees to fulfill their assigned tasks.

"An observation of District Council meeting is that its primary function is to give reports (chapter, committee, staff, etc.) and socialize. Little is mentioned about communicating and/or District Council programs. This has discouraged attendance from our Portland Chapter, and we're certain that this is not a peculiar situation. We do suggest that we make every effort to attract broader attendance at District Meetings by programs, fruitful discussions, and complimentary activities to the business meetings . . . "

HUMAN RIGHTS DEPARTMENT TAKES ACTION AGAINST NON RESPONDING CONTRACTOR

An investigation by the contract compliance division of the City Human Rights Department has resulted in a positive affirmative action program for minority hiring by construction company working on a Ballard Sewer separation project. At the request of the City Councilman Sam Smith, the department investigated the hiring practices of J.E. Works Construction Co. In a letter to City Councilman Smith on Apr. 26, Y. Philip Y. Hayasaka, executive director of the Seattle Human Rights Department, reported that the contractor was found to hold a negative attitude towards a program to "seek, sponsor and assist" minorities as called for in 1969 city ordinance.

After several conferences, Hayasaka was able to tell Smith he had recently received a program in which Works indicated he will employ four minority members for the skilled trades and one trainee. Hayasaka also assured Smith the contractor will be encouraged to employ

additional minority employees.

ASIAN BAPTIST CAUCUS ASKS \$20,000 FROM BAPTIST CONVENTION FOR CONVOCATION

American Baptists of Asian ancestry have called an Asian Caucus in the American Baptist Convention and have petitioned the denomination for funds to support it according to the Convention Headquarters at Valley Forge, Penn. The call to establish an Asian Caucus is regarded as a rejection of the assimilation stance taken by the denomination since the end of WW2. Leaders of the caucus said the attempt to assimilate has had a dehumanizing effect and cause as loss of identity, especially among third generation Asians in the United States causing them to ponder: "Who am I? Am I white or Asian?"

A declaration by the convenors of the caucus called for an Asian American Baptist Ethnic Strategy Convocation composed of "knowledgeable and charismatic Asian American Christian leadership" to develop a "definiinitive Christian strategy and ethnic power base from which

genuine mutuality and justice can be implemented."

Designated as a convenor of the proposed convocation was the Rev. Dr. Paul M. Nagano, pastor of Seattle Japanese Baptist Church. Among those listed as committee members were Dr. Akira Ishimaru, Yosh Nakagawa, the Rev. Emery E. Andrews and the Rev. Iwahei Hori, all of Seattle Japanese Baptist Church. Rev. Andrews is visitation minister and Rev. Hori is pastor of the Issei Church.
