requested names of Japanese candidates for nominees as King County Council on Aging Senior Citizen of the Year Award.

Don Kazama spoke on the Franklin High School hiring of Asian vice principal, counselor and bi-lingual teachers. Following the meeting of Asian community leaders with Superintendent of Schools Dr. Forbes Bottomly the administration will extend the search to Bay area for more Asian administrators. "The irony is that we need liaison community workers, counselors and so on. Mr. Troxel (assistant superintendent of South Region) spent agonizing hours to find solution to this school crisis. Security force in the school hallway is not the answer since this has the tendency to create tension and animosity among students," Kazama said. He continued to speak on the Central Seattle Community Council Education Committee's human relations workshop to last 16 honest hours for the benefit of school administrators. Out of this workshop lies the hope of administrators to come up with concrete proposal for the direction of possible solution. "The feeling of students start to surface at the junior high level and flares up in high school," Kazama said.

Art Yorozu spoke to the board on the Asian Job Center's Phase 1 program (see article elsewhere this issue) and made the motion to commit the Seattle Chapter to \$200.00 share in the three months portion of the program. The motion was carried. The board previously had approved the funding in principle provided specific amount was asked.

SCHOOL DISTRICT SEEKS MINORITY AFFAIRS CONSULTANT

The Mercer Island School District, as part of their broadening concern emphasis on multi-racial and multi-cultural educational program, is interested in hiring someone to serve as specialist-consultant in minority affairs. This educator would work on curriculum and course building, teacher assistance and classroom aids, and other educational programs to lend continuity and strengthening to those things already underway in the District as well as to bring need innovation to the schools. PRIDE AND SHAME TRIAL RUN TO BE SHOWN AT FRANKLIN HIGH JAN. 6

Pride and Shame traveling exhibit and program will have its first trial run of display Dec. 9 at the Sammamish High School followed by Franklin High School on Jan. 6. The first official showing will be held Sunday, Jan. 16 from 2-5 p.m. during the reception to be held at the Evergreen State College near Olympia. Exhibit continues to Jan. 28.

100 copies of training manuals were distributed to program panelists and other staff members who will take part in the exhibit programs. The training manual for the exhibit was put together by Ben Yorita, Mrs. Fran Wada, and Dr. James Morishima. Dr. Calvin Takagi will also coordinate training of team members numbering up to 15 to be knowledgeable. Puyallup Valley JACL, the Portland JACL, and the Spokane JACL will also help with the exhibit and program.

The Seattle JACL together with the State Capitol Museum of Olympia under director Kenneth Hopkins were funded by the National Endowment for Humanities for \$6,666.00 for one year. Itinerary to be covered by the traveling exhibit includes Olympia, Shoreline and Highline Community Colleges, Western Washington State College, Bainbridge High School, Yakima Junior College, Tacoma, Spokane, Vancouver, B.C., Puyallup, Portland, University of Oregon, Columbia Basin Community College and Washington State University. Other possible stops may include Skagit Valley Community College, Central Washington State College, Bremerton Community College, and Whitman College.

The exhibit covers five chronological periods: a. the pioneering period -- 1890-1905 b) the family building period -- 1905-1924 c) the post-exclusionary period -- 1924-1941 d) the war, evacuation and relocation centers -- 1942-1945 e) the post-war period (1) 1946-1965 -- increasing acculturation (2) 1965-1972 -- the rise of the Sansei.

Community's Asian Employment Center project's first phase pilot program is reaching the moment of truth when the office becomes operational Dec. 15. Under interim chairmen Keiji Sato and Jiro Namatame, the community fund drive received cash commitment from NVC, JACL, Japanese Baptist, Seattle Nichiren and Faith Bible Church while other churches and organizations await the monthly board meeting to make their actions official. The regular chairman Lloyd Hara is too busy at this time of the year with county finance to make full commitment

In preparation for the second phase the Asian Job Center entitled Employment Opportunities Center (EOC) articles of incorporation as a non-profit organization has been prepared by Ron Shigeno who was on loan from Sylvester Burch of the Pratt Center.

The purpose of EOC is "to coordinate the efforts of various organizations to place Asians into jobs commensurate with their skills. The job center manned by permanent staff will collect and disseminate job information to prospective job seekers, counsel, and assist job seekers in preparation of resources and arranging potential job interviews. This office will work with other manpower organization to direct persons for training, education and other services."

The center staff will consist of project administrator, lead counselor, counselor and secretary on full time basis.

The assistance in making the most effective presentation for fund request has been received from Pratt Center and the Concentrated Employment Center. The organization has submitted \$85,000.00 budget proposal to the Southeast Beacon Hill Planning Variation (Model City Task Force) which meets at Sharples Junior High School. The Black community, the American Indian community, Hispanic community and the Filipino community have already established their own job center.

Masao Tomita is chairman for recruiting volunteer office workers on day to day basis for the first phase program. The job will consist of answering phones and doing clerical work. One clerk will be hired at minimal salary to maintain office continuity as volunteer help changes each day. For more information call Tomita (PA 2-0496).

KAWABE RETIREMENT HOME NEARS COMPLETION

After three years of construction including acquisition and clearing of land site, the Kawabe Memorial House for the moderate income up to \$4,725.00 per year will be ready to be officially dedicated early in 1972. Jerry Nakata and secretary Tak Kubota conducted the tour through the building Nov. 20 just before the executive committee for the retirement home were to meet.

The ten story reinforced concrete structure with protective coating on the outside will contain 162-units covering 10 floors. Only the tenth floor needed carpeting at that time. Looking west towards the panoramic Elliot Bay one can see the historic Collins Fall -Fieldhouse soon to be torn down and to the east we look at the old Washington Junior High

School to suffer the same indignity of demolition.

Some of the building features shown included disposal chute on each end of hallway, kitchen which will prepare one meals per day in the dining room (at least for the start), lounge, library, hobby room, laundry room, clinic and basement storage room. Extensive security and monitoring system in the event of medical emergency or fire has been built in. Each unit consists of bathroom, bedroom and spacious living room with kitchen portion

Though the price of approximate \$150.00 per month including one meal is out of range for the many elderly Issei widows, the Kawabe Memorial House hopes to meet the specific needs of the community. The initial fund was started with a huge donation by the late Mr. Harry S. Kawabe. The general contractor is Sato Corporation.

SANSEI HELPS TO DEVELOP ELECTRONIC GEAR, COMPUTER AND PLOTTING DEVICE FOR NAUTICAL CHARTS Lt. Mel Asato and civilian Ed Jones are equipment developers in latest in automatic data gathering systems designed to speed up the production of nautical charts used for commercial shipping, small crafts and operation and military.

Asato and Jones, employees of the National Ocean Survey for the Dept. of Commerce, were instrumental in developing the new electronic device that will enable survey ships to plot depths of navigable waters cutting 25% off a once tedious job.

Asato, a commissioned officer in the National Oceanic and Atmospheric Administration, and Jones who both work out of the organization's Seattle Headquarters, put the latest scientific mapping equipment through its paces on a recent voyages of the NOAA Ship Rainier between Lake Union and Point Roberts on Puget Sound.

Banks of electronic gear and computers team with a plotting device enable the ship to zigzag across a body of water and have the depth recorded automatically on a chart. In the past, depth recordings were transferred by hand to maps. The need to compute or plot manually either during or after survey operation is eliminated by the automatic plotting capability. Any corrections to the area surveyed can be made immediately.

The time saving becomes staggering when it is realized that the National Oceanic Survey produces about 2.7 million charts a year. The installation of the new gear on three of the agency's ships and six auxiliary launches is costing \$497,200. In the past, the lack of sufficient automated data gathering equipment has meant a backlog of unprocessed data. The result was a lengthy delay in the production of charts.


