ALL PAC*ASIAN BASKETBALL TOURNAMENT IN SEATTLE PROPOSED FOR NEXT SPRING

The planning committee for the proposed 1st Annual Pac*Asian Invitational Basketball Tournament to be slated for Mar. 29-31 in 1974 in Seattle has been doing lots of homework.

The tourney hopes to draw representative teams from Vancouver, B.C., Seattle, Portland, San Francisco, Fresno, Stockton, San Jose, Sacramento and Los Angeles. The three ethnic groups in Seattle represented by Nisei Veterans Committee Basketball Leagues, Filipino Youth Association and the Seattle Chinese Athletic Association have shown interest and indicated support and will be cosponsors with the Seattle Park Department. The format to be used as a guide for detailed planning has already been written. The sponsoring group here is planning to incorporate under Northwest Asian American Athletic Association. The goal is to incorporate each major coastal area to move the tournament from city to city each year.

Frank S. Fujii, the prime mover, described the purpose of this tourney:

"Asian ethnic awareness throughout the Pacific Coast has dedicated a direction of togetherness and understanding among the Asian-American Youth Programs. As much as gains have been indicated in many phases of Asianisms, still a greater togetherness can be created through not only Governmental Projects and Studies in grants and research but a concrete program such as an Annual Invitational Sports Tournament inviting youth and along with their community support."
