This will be an "open" meeting according to President Sam T. Shoji who is finishing out his successful term in office. Please bring your friends and get acquainted with the JACLers. There will be the usual food, refreshment and beverages. Everyone is welcome.

There will be an extensive membership drive for 1975. The board has allocated \$620 for the purpose of increasing membership and brochure together with current copy of Pacific Citizen will be enclosed to be mailed out to general greater Seattle Area.

Tomio Moriguchi disclosed that JACL Charter Flight with the JAL is being planned for Oct. 1975.

The nomination committee reported that ballots were mailed out. The results will be released atthe general members meeting to be held Dec. 20 at the Kawabe Memorial House. The nomination slate was expanded from the floor when Chuck Kato was added to 4th vice president slot for three way battle; correspondence secretary has added Arlene Oki and Midori S. Uyeda; Connie asaka's name to historian making it a two-way race with Kayko Watanabe. The group III category for the board of governors had added Terry Nakano, A. Mark Kinomoto and Gerald Yuasa to its list of candidates. The nominating committee has done a wonderful job and added ex-xitement to the balloting. Members of the nomination committee headed by Don Kazama includes Jiro Namatame, Cherry Kinoshita, Hippo Sakahara, Bill Kawahara, Hideo Watanabe, Mako Nakagawa, Vicki Asakura, Gil Hirabayashi and Pat Sado.

Nobi Chan, chairing the annual JACL installation dinner, announced the tentative date for Feb. 7. The Honorable Mayor Wes Uhlman will be the keynote speaker. Nobi Chan requested that each board member make an effort to get 6 in the tatami room in the buffet style dinner at the Bush Garden Restaurant. The immediate past banquet chairperson Pat Sado left a comprehensive folder to help plan for the 1975 banquet. \$250.00 working fund has been advanced through the approval of the board.

Henry J. Miyatake, chairing the chapter evacuation reparation committee, returned from the National JACL board meeting where he was promised 45 minutes but was only able to pitch in for 32 minutes. He reported to the Chapter that National President Shig Sugiyama was not in favor of the reparation as such. Sugiyama was quoted as saying Issei should not be included in the reparation. According to Miyatake he had asked for poll of JACL National Board but Sugiyama refused. As far as he was concerned, he was opposed to the idea altogether. Miyatake said he talked to 17 people on the subject of evacuation reparation claims at the board. Only two persons opposed the idea -- Dave Ushio and Shig Sugiyama. One sat on the fence. It was obvious that executive level simply refused to accept the concept, Miyatake concluded.

Chairing the Seattle Chapter Issei Concerns Committee for the past five years, Connie Asaka continues to bring surprises in new ideas and innovation. The latest is the "Lap Blanket" project for which Asaka has hit the jackpot. Through JACL and the media of the North American Post in Japanese language, the Issei and Nisei community women were invited to participate. Response came from Renton to Queen Anne. The Issei were happy to get away from the TV for a change and to act as participants in this volunteer work. This was a chance for Issei to renew acquaintances and to make new friends according to Asaka.

65 lap blankets were crotcheted and quilted and will be gift wrapped and delivered between Dec. 21-23 to ten different mursing homes. The delivery will also include visitation in trying to bring cheers to the shut-ins. Asaka asks help in providing drivers to make deliveries.

Lap blanket volunteers met Dec. 6 at the Kawabe Memorial House and will be wrapping up the month and a half project on Dec. 13 at the Beacon Towers. Ring Mrs. Hashiguchi on the main floor Apt. 1503. The technique for creating lap blankets were demonstrated in the Issei Nutrition Project being conducted at the Nisei Vet memorial Hall.

NEW DIRECTOR FOR THE N.W.-INTERMOUNTAIN REGIONAL DIRECTOR FACES CHALLENGE

Stan Kiyokawa, familiar name in the JACL Youth Council, and native of Portland is the new Pacific Northwest-Intermountain Regional Director with the office in Portland. He succeeds Don Hayashi. Kiyokawa attended Eastern Oregon State College and Portland State University. Kiyokawa was previously associated with Brooklyn and Creston YMCA Latch Key Program as its Director and served as National Youth Council Director for JACL.

In the last District Council meeting hosted by Seattle the function of the Regional Director came under fire. Seattle ddin't seem to get in on the benefits. "Why didn't you ask us?" was their reply. We brought up a question on hypothetical problem situation requiring Regional Director intervention. "What would you do under this circumstance and what would have been the strategy for its solution?" It was obvious that Director would have been already overloaded with routine task to intervene outside of writing letters and giving generalized brotherly advice.

This brought up the question of accountability for the regional director. Last month Don Kazama brought this issue to the November Chapter meeting. The discussion will probably be made during the December meeting.

RECOMMENDATIONS FOR DUTIES, RESPONSIBILITIES AND ACCOUNTABILITY FOR THE REGIONAL DIRECTOR

The Ad Hoc Committee appointed by the Chapter President lists the following items for consideration as the duties, responsibilities and accountability for the Regional Director. This was done in conjunction with the recommendations that were presented at the Pacific Northwest District Council meeting held Sept. 28-29, 1974.

The items listed below are in alphabetical order rather than by priorities since the determination of actual priorties and ratings must be established between the Regional Director and each local chapter so that the priorities can be tailored to meet Chapter needs and programs.

DUTIES AND RESPONSIBILITIES

1. To help chapters and district council set program goals and objectives by providing information, resources and technical assistance (in areas including but not limited to):

Education, Elderly, Group Benefit Plans (insurance, health care plans, retirement, etc.), Funding/Grantsmanship, Leadership Development, Membership, Youth.

2. To advocate for Japanese Americans and other minorities (in areas including but not limited to):

Anti-defamation, laison with other groups and organizations with interests in common with JACL, monitoring discriminatory legislation, outreach to the broader ethnic and greater community, public information.

3. To facilitate communications among the many JACL groups (chapters, districts, national):

Dissemination of information which would provide possible models and examples of chapter and district activities and programs. Dissemination of national, district and chapter information and activities. Making regular quarterly reports on the Regional Director's activities, emergency concerns and suggestion for psssible action.

ACCOUNTABILITY

- 1. Under the direction of the District Council, the Regional Director shall carry out priorities under the three areas listed above.
- 2. The Regional Director shall be responsible to and seek guidance from the Pacific Northwest District Council Governor.
- 3. Actions involving the areas listed above would not require District Council action but would be considered the carrying out of the outlined responsibilities. If in the opinion of a district committee, District Council action was necessary, the matter would be brought up to the District Council.
- 4. Accountability and the evaluation component shall be established by the District Council for the Regional Director.

DR. MASUDA SCORES RACIST PLOY IN POLITICAL CAMPAIGN

Dr. Minoru Masuda, as chairman of the Seattle Chapter Anti-Defamation Committee, wrote to U.S. House 3rd District candidate Don Bonker(D). Bonker has subsequently won the election over A. Ludlow Kramer. Dr. Masuda wrote:

"... you have run T.V. spots in which you have spoken against log exports to Japan as a political issue. We do not contest your right to use log exports as a campaign position even though we may not agree with that position.

"Our concern is that in your overzealousness you have allowed racism to creep into your campaign. The emphasis on log exports to Japan (emphasized by the Japanese freighter in the background) was a deliberate attempt to stir up latent racist emotions to further

your political cause. This is written because of concern that negative reactions to Japan's economic activities are negatively reflected on Japanese Americans. We don't need to tell you of the outcries against Japanese steel, electronics, textiles, whaling, overseas industrial developments, etc., in recent years. In all of this, it is the Japanese Americans who have become the scapegoats of wrath, for we are here and we are visible and Americans see the face and cannot distinguish the difference that exists between the Japanese and the Japanese Americans.

"We are dismayed by your campaign tactics which have utilized a racist ploy in furtherance of your political career. While this letter cannot undo the damage done, it is our hope that you will understand and desist further from the disservice and harm you have rendered to all Japanese Americans."

MINORITIES ON INCREASE IN SEATTLE SCHOOLS

The growing percentage of minority students and the shift of minority children to the South Region -- trends established the past few years in the Seattle Public Schools -are confirmed.in the 1974 district racial-distribution survey made public Nov. 22. More than 26.9 per cent of the regular 64,588 regular students are minority. There is a loss of 17,-740 white students in a period of declining enrollment.

The survey shows these minority totals for this year as black, 10,124, or 15.7%; Japanese 1,530, or 2.4%; Chinese, 1687, or 2.6%; Filipino, 1,240 or 1.9%; Spanish, 870, or 3.4%; American Indian, 1,005 or 1.6%; and "other" 855, or 1.3%.

Garfield High School is 76.9% black with 866 black students. Two other high schools have high minority enrollments. Cleveland has a 36.6% white enrollment and Franklin, 30.8%. South Shore Middle School is 44.5% white. The state defines a school with 40% of any minority as de facto segregated. Under that definition Seattle has 14 black de facto schools.

Two schools have more than 40% Asian enrollment -- Beacon Hill, 41.41% Chinese and 53.91 total Asian and Kimball, 45.18% Asian. Cleveland High School is 39.8% Asian.
