LAND LAW REPEAL MEETING IN PORTLAND. Chairman Emi Somekawa of the Pacific Northwest District Council called a special meeting of the Alien Land Law Repeal at the Holiday Inn in Portland Feb. 27. Washington delegates were there to give finer details of the campaign strategy and to work out a practical program of support by member chapter of the PNWDC and to tie this support program with a statewide program which is gradually taking shape in its final form.

Delegates from the state of Washington included Sally Kazama, Tak Kubota, Eira Nagaoka, Toru Sakahara, Dr. Terrance Toda, and Kaz Yamane of Puyallup Valley Chapter.

The concept of equal effects and results is closely allied with equal opportunities, provided equal opportunities have injected a human meaning into it.

To be really meaningful, equal opportunity must be the OPPORTUNITY TO BE EQUAL. It is not enough to just eliminate artificial barriers to employment, housing and education, whether the barrier be legal or subtle, for even if these barriers were to disappear today, the American Negro would still not receive full equality.

The distance between the Negro and Caucasian is still far too great in all areas that make up this society. The cause of this distance is centuries of humiliation, discrimination and segregation, and more than equal opportunity will be required to close the gap so that the Negro can take his proper place in society and share in the responsibilities and rewards of the total community.

It is like two men running in a track meet. One runs with track shoes on a cinder track. The other with lead shoes, carrying a heavy pack and running in sand. When the second man is finally relieved of his lead shoes and pack and placed on the cinder track, it is apparent that the pre-existing circumstances left a gap between the men. The second man, being far behind, would require more than being relieved of his handicap, if this is to be an even match.

The burdens imposed on the Negro have weighed heavily and have exacted their toll in human dignity and humanity. To help close the distance between the Negro and Caucasian, part of the answer may be in effective and positive action to include Negroes in all aspects of our total society. Negroes must participate in the planning and determining of their own futures as well as for all Americans futures, rather than having paternalistic planning and determining of programs being made for them.

Another part of the answer may be found in training programs; in eliminating ghettos and in integration of schools. There are, of course, many parts to the total answer. But for the final answer, we must look at the question from a different perspective--that of visualizing this conflict challenging us as a conflict between right and wrong, of justice and injustice, rather than a conflict between races.

FACE to FACE In the past few months Roberta Byrd, moderator has presented on Channel 9, informative programs on various minorities in Seattle--the Filipinos, the Chinese, the Japanese, the Indians as well as the Negroes. In the near future she will present a program focussing on the Indians alone; the different tribes in the Northwest, their life, their difficulties. This particular minority has received little attention in relation to their problems, and is greatly misunderstood by the vast majority of people. The Human Relations Committee recommends watching Face to Face from time to time.

DEADLINE FOR SOCIAL SECURITY ADMINISTRATION'S MEDICARE MARCH 31ST

Any American citizens age 65 or over or any alien of that age who was legally admitted for permanent residence and has resided continuously in this country for at least five years is eligible for the Social Security Administration's Medicare program. This includes persons who did little or no work at all covered by Social Security, and even includes those who may not even have had a Social Security card.

Person presently receiving Social Security benefits is automatically covered for the Hospital Insurance Benefit (Part A), but he must notify the Social Security Administration that he wishes to have \$3 deducted each month from his Social Security checks for Supplemental Medical Insurance benefits (Part B), which covers doctors bills.

People who are not receiving Social Security benefits, must apply for both the Hospital and Medical Insurance Benefits. The deadline for filing is March 31, 1966.
