May Sasaki acted as pro tem recording secretary. Father Clement was present at the meeting. Father Clement donated \$100.00 to the Chapter in memory of Minnie (mother of Father Clement) who passed away recently. Father Clement served in the Seattle Japanese community's Lady Queen of Martyrs Church (Maryknoll Mission) with the late Father Leopold H. Tibesar in pre-WW2 years. We thank Father Clement for the donation and for his continued devotion to community. At a meeting on Jan. 20 with Walter Hundley, Supt. of Parks & Recreation Dept., members of the Asian community expressed their dissatisfaction with the Department's policies and their inept handling of the Seattle Tennis Center appointment. The concern outlined included lack of any Asians on the administrative level which would handicap Asians from receiving better considerations.

President Taniguchi announced appointment to the board of Rita Fujiki Elway, Karen Shimizu, and Dean Charles Z. Smith. Also past president's advisory council appointment included Jiro Aoki, Tak Kubota, Dr. Terrance Toda, and Min Tsubota.

Mako Nakagawa announced that Committee to Overturn Bakke Decision has planned potluck dinner to be held at Filipino Community Center. She is forming telephone committee to contact officers and board members. See additional detail in Calendar of Events on page 6.

JACL mailout group turned out on Jan. 10. Gary Matsudaira is the new chairman. In attendance were Bill Walsh, Mike Yaguchi, Mako Nakagawa, May Sasaki, Alisa Ogishima and Gary Matsudaira.

Mako Nakagawa called attention to colorful wall decors created by May Sasaki and her group.

John Takizawa spoke on the planned fund drive for Keiro expansion. Keiro is licensed for only 63 persons. Plan calls for 2,000 sq ft expansion. This will help stabilize deficit. Momio Moriguchi said there is need for 14 full time Japanese speaking aides. Fund request from JACL amounts to \$500 for the first year and additional \$500 the second year. The matter tabled for the budget and grants committee to study the request.

Seattle Chapter supported a task force to look into Review Board and to study the big picture apart from the Review Board. Some businessmen in International District are asking the Review Board process be modified to take care of "inequities of guide lines."

JACL NATIONAL SCHOLARSHIP PROGRAM

Applications for the 1978 JACL National Scholarship Program are now available it was announced by Izumi Taniguchi, National Scholarship Chairperson and Rich Okabe, National Youth Director. The application forms and all pertinent information are being sent to all JACL chapter presidents. Scholarships averaging \$500 will be awarded to graduating high school seniors and to four graduate students. These scholarships are made available through donations and trust accounts earmarked for this purpose. Through the generosity of many individuals, the program will award over \$10,000 to students this year.

The National Scholarship Program, now in its 32nd year, seeks to give recognition to the many outstanding students of Japanese ancestry who desire to further their educational careers. Although the awards are small when compared to today's increased tuition costs, it is hoped that the value of education as stressed by the Issei can be instilled in our youth.

The scholarships are open to all members of JACL, children of members, JAYs members, and all persons of Japanese ancestry. Applicants will be judged on academic achievement, financial needs, and extra-curricular activities. Students are required to submit a high school transcript, test scores, and a Confidential Parent's Financial Statement in addition to the completed application.

Last year, 217 freshman and 41 graduate applications were received and this year's response is expected to be equally as good. The applications will receive a preliminary screening by six review committees. These committees, headed by district scholarship chairpersons, will be asked to select the top ten applicants within their group for further review by the final selection committee.

Students are encouraged to contact their local JACL chapter for additional scholarships. In 1977, over 40 chapters awarded scholarships totaling over \$20,000 to individuals in their areas. Eligibility, judging criteria and deadlines vary.

Applications for the National Scholarship Program must be postmarked no later than April 1, 1978. Forms and brochures may be obtained from any JACL chapter. Rita Fujiki Elway, a Wallingford resident, and Ann Ormsby have been selected as aides for newly elected City Councilman Michael Hildt. The two, who were chosen from a field of over 100 applicants, will work part time. Ormsby is the former chairperson of the city's Board of Freeholders and was selected in 1973 to fill out the last few months of former Councilman Liem Eng Tuai's term when he resigned to run for Seattle mayor. She is past president of the Puget Sound League of Women Voters and a graduate of Wellesley College.

Elway is a communications and community affairs consultant. She was recently appointed by President Jimmy Carter to the National Commission for the Observance of International Women's Year.

Elway was a keynote speaker at last year's Washington State Women's Conference and was founder of the Asian/Pacific Women's Conference. She is member of the Japanese American Citizens League board of directors.

Elway has a master's degree in communications from the University of Washington and is a doctorate candidate in higher education.

NEW JAPANESE RESTAURANT FOR PARK PLACE

Seattle will have a new Japanese restaurant, to be the largest of its kind on the West Coast

RESTAURANT (Cont'd): in mid-March when the Asuka Restaurant opens at Park Place. The \$500,000 restaurant, on the main floor of the office building adjoining the west side of the Freeway Park, will feature sushi and tempura bars, tatami rooms and a piano bar. It will serve lunch and dinner, offering a full range of classic Japanese cuisine. There will be seating for 150. Design is by Lovegren-Loveland & Associates, Bellevue, and Takashimaya of Kyoto. Contractors are the C.B.S. Construction Co., R. & L. Enterprises and Takashimaya. Financing for the 7,000 square foot restaurant is by the Small Business Administration and Seattle Trust & Savings Bank. Takao Sugiya is president of Asuka.

1978 INSTALLATION BANQUET

Undaunted by the massive media build-up for the TV Super-Bowl, the Seattle Chapter plunged ahead with the annual installation and award banquet Jan. 15 at Bush Garden Restaurant. 220 responded nevertheless and we might add that it was possible to sneak down to the lounge for TV viewing. Chairperson Mary Fujita and her committee had laid the thorough groundwork to assure the success for the evening. Master of ceremony Phil Hayasaka was at his best.

Officers and board members were duly installed by Tak Kubota, past National JACL vice president. Greetings were expressed by outgoing president Cherry Kinoshita, Consul-General Kenichi Yanagi and the newly sworn in Mayor of Seattle Charles Royer.

Cherry Kinoshita outlined the accomplishment of the Seattle Chapter for the past year including alien tuition bill assist, scholarship, retirement seminar, program for the elderly, travel program, the directory going to 7,000 household, and the all time high in membership. Kinoshita said she "had to admit at the end of my term I had failed JACL and the JACL had failed but not in the usual sense." JACL, she noted, is a human and civil rights advocates of Japanese American needs. The Seattle Chapter's 31 positions have only 6 women. On the National JACL level there were only 13 women president among the 104 Chapters. None of the National JACL officers were represented by the fairer sex.

Consul General Yanagi noted that this is the Year of the Horse in the oriental zodiac. But twelve years ago it was significant as the fire-horse year resulting from the combination of two oriental zodiacs. According to the old belief, said Consul General Yanagi, when born under this particular year, will cause the girl to be responsible for the early death of her husband. This will make her very difficult to find marriage partner. Fortunately this combination of horse and fire year occurs only once in 60 years. This actually affected population trend in Japan. School classes have fewest numbers. One advantage is less competition to enter employment field or to enter school. The Consul General said he was happy to note that Japanese Americans in this area are playing a very important role in various social, economic, political and cultural field of this great nation.

Seattle Mayor Charles Royer recalled that one year ago on this very JACL installation banquet, he had made his first political appearance as a candidate for mayor. He sat with Frank and Arlene Oki and others (Repres. James Knox, 35th Dist.; Jack Meyerson, running for prosecuting attorney; and Barbara Pisposesi, now special assistant to Mayor Royer). From this nucleus came the Asians for Royer Committee which during the last year performed couple of minor miracles, according to Mayor Royer. Mayor Royer credited Arlene Oki who probably more than anyone else in the campaign did precisely what she said she was going to do. And according to the Mayor, Arlene probably more than anyone else helped organize the campaign. He said three new faces who are there because of the active participation of Asian American, Japanese American specifically. He was referring to himself, City Councilman Michael Hildt (with campaign chairperson Tomio Moriguchi) and Doug Jewett. (Arlene Oki was among the first to be appointed to Mayor Royer's staff to work on community contact. Rita Fujiki Elway has been selected as one of two aides for City Councilman Michael Hildt).

Recognition Awards

Tak Kubota chaired the recognition committee and made presentations.

Charles Z. Smith, associate dean of the Univ. of Washington School of Law, and KOMO-TV and KOMO radio news commentator, was presented with "JACL Award for 1978," for his contribution to the Asian American causes. Dean Smith is past judge for King County Superior Court, Seattle Municipal Court, and the Juvenile Court. He is past deputy prosecuting attorney for King County and back in 1961 joined the U.S. Dept. of Justice at the request of Bob Kennedy. Dean Smith is a member of the Seattle Chapter board. Locally during the development of the Urban Renewal in Central Area when Dr. Terrance M. Toda was JACL representative, Dean Smith was instrumental in coordinating total community organizations to help lay groundwork for renewal objectives.

Richard L. Hutchins of the U.S. Immigration and Naturalization Service was also honored with "JACL Award for 1978" for making the Seattle office a service agency and not merely an enforcement agency. JACL initiated the naturalization program following the passage of Walter-McCarran Immigration and Naturalization Act (1952) with Dr. Kelly Yamada with his committee putting together naturalization classes with the help of Mr. Hutchins. Mr. Hutchins has continued to serve the community sacrificing personal comfort and convenience with the total sense of fair play. When Hutchins received the reward, he said, "If we had more people like Tak (Kubota) in the community working with the government agencies, the people will get a better shake."

This was followed by President Taniguchi speaking on the hopes for the coming year (see text which follows). John Matsumoto received the past president's pin as did Cherry Kinoshita.

Master of Ceremony Phil Hayasaka took time to pay tribute to the late Dr. Martin Luther King Jr. and the late Hubert H. Humphrey for their contributions to civil rights movement.

Greater Maturity Needed to Solve Problems

Rep. Norman Mineta is the only Asian American in the House of Representative. He was the keynote speaker. Repres. Mineta has spoken here previously during the Seattle Chapter's 50th anniversary stemming from the days of Japanese American Progressive League.

Mineta said the new officers and the new members of the board will have the responsibility to face exciting challenges. In order to meet those challenges, Repres. Mineta said it is important to consider the broader political context. It is important because the group such as JACL must be especially aware of the political process which can lead us to understand

INSTALLATION BANQUET (Cont'd.) proper JACL roles.

Repres. Mineta said,

"The JACL has always been fortunate to have within its rank astute individuals, people willing to become involved, people willing to become leaders in their own community. As we look at some of the complex issues which confront our country today, I think that kind of willingness to work is exactly what our political system demands. Old ideas, simplistic answers, and traditional rhetoric will no longer suffice. If we are to solve the problems facing our country, greater maturity is going to be demanded. Both the public and the leaders must speak of complex issues in honest terms. The public must begin to make different choices from among complex issues."

There are very important implications for JACL, Rep. Mineta said. When Japanese American community has a concern, it must be communicated as more than just a general principal. In a political climate of complex issues competing for the attention of the government the pressure will be on us to back up principal with detailed plan of action. The JACL's past history of political sophistication and accomplishments in the public sector convinces me the JACL will have no problems in meeting the challenge. There is another consideration for Japanese American community in the current political mood in the United States, Rep. Mineta continued. That is that Japanese Americans have a responsibility to participate in changing political attitude. Moreover, we have a unique contribution we can make to that evolution. For as a people who have come to know the best and the worst of what is America, we have the opportunity to provide for our family, to know freedom from degradation, to know the dignity of self reliance. Moreover, we experienced intolerance and bigotry that lie dormant as potential force of human nature to strike at some unknown point or time. In our past experience we have been deprived of our fruits of our labors and left without political voice to remedy these wrongs. Because we have experienced life in America both with and without these rights that we have come to value the American way of life, the American idea of justice, of equal representation and respect for the individual.

Mineta urged that we remain an active participants for we don't have a right to drop out because we have benefited from the American promise. We have a unique and special responsibility to participate in the political systems and to become leaders in the development of political maturity in our country. What we do today will determine whether the American dream can be preserved for the future generation.

We thank chairperson Mary Fujita and her committee made up of Frank Hattori, Richard Ishikawa, Lillian Iwata, Tak Kubota, John Matsumoto, Robert Matsuura, Kimi Nakanishi, Jiro Namatame, Shig Otani and Roy Seko.
