November 1981 Page 3 <u>CCRR GEARS UP</u> (Cont'd): Pending the Commission's final report expected sometime in 1982, Seattle's Community Committee on Redress/Reparations set out an interim plan of action at its Oct. 28 meeting, chaired by Chuck Kato. Three committees were established: a Speaker's Bureau to fulfill requests for speaking engagements and to actively seek public relations opportunities before groups; Media Alert to respond to both positive and negative media coverage; and Political Action to develop congressional lobbying contacts and to garner organizational support groups.

The financial panic facing the local Redress effort at the outset were comfortably eased. Thanks to the hundreds and hundreds of generous community supporters. (Surprisingly numerous donations of \$100.00 and \$500.00 were mailed in.) As of Sept. 30, specific expenses for this several workshop, mock hearings, and 3-day Commission Hearings, totaled over \$12,000.00! After all expenses have been paid, the remaining fund will provide a base to support upcoming activities and begin lobbying efforts which are expected to intensify once the Commission's report is issued (and provided the report is acceptable.)

Applying the conflict of interest theory, Don Kazama said the nomination committee delegated a separate subcommittee headed by Kaz Ishimitsu to tabulate the ballot.

Don Kazama reported the community organization the <u>Elderly Concerns Committee and the Nikkei</u> <u>Aging Project</u>, are "talking to each other" and hope is that these two organizations may eventually work together and possibly merge by 1982. She actually purchased the blank tape and had the contents put in. We hope to keep this in the Seattle JACL library which was originally started from the Madame Hosoe Kodama fund.

President Lloyd F. Hara envisions bowling as fun time event on Saturday, Jan. 2 at the Imperial Lanes provided he can find someone to chair the event. This is not a bowling tournament. Manager Fred Takagi told Hara about the past JACL difficulties when the Seattle Chapter board majority thought that limiting the number of "whites" on JACL bowling was inconceivable and inconsistent with the JACL which is a civil rights organization. The national JACL bowling committee was forced to act on question of caucasians on each bowling team. Some of the teams entering the national tourney was loading up with hot-shot white bowlers and taking the fun out of the tournament itself. President Hara had talked with Manager Takagi for over an hour. National tournament is now a separate organization.

<u>New Appointments to the Board</u>: Councilperson Delores Sibonga, Phil Hayasaka, and Ruthann Kurose, community representative for the Repres. for the Mike Lowry Office, have resigned from the board since their commitment makes them unable to attend the Wednesday meeting. The appointees to fill the vacancies are attorney Roger Shimizu, Dr. Tetsuden Kashima, director of the Asian American Studies, at the U.W., and Marie Kurose. Marie handles the Youth Committee.

The <u>National Redress Committee</u> disclosed that John Tateishi was hired as the full time director and has added research assistant and secretary. What we heard from the Seattle board report was that the regular National JACL staff were not required to work on Redress. This is in sharp contrast with Ron Ikejiri who was quoted as not having enough work in the office.

In Seattle the make-up of the Redress organization is two fold: a) the Seattle Chapter and b) the 14 local Nikkei organizations which organized and ran three fun drives. The group "b" paid some of the volunteers which rented extra room and was as busy a place as you can imagine with phones ringing continuously and the brochures and mailings being printed and getting the whole Seattle Commission Hearings on Redress organized. The next phase is public relations work, lobbying and setting up the speakers bureau.

President Lloyd F. Hara wanted the <u>dollar figures</u> and <u>breakdown on spending</u> for the National Redress Committee. He has met with key JACL figures and correspondences were sent to responsible persons receiving promises for the request. The situation has become "crystal clear." Those details of the expenditures will not be divulged (at least not to us for a while). President Hara was a county auditor for eight years receiving reputation for being hard nosed. Chuck Kato said at the board meeting "there is so much credibility gap between the National and the Chapters that it is rediculous."

A demonstration grant from the United Way for leadership training and/or youth services to be administered by Seattle JACL is on the plan. The asking amount is about \$15,000 but traditionally the approval of any expenditure is much less than the asking amount. The funding source being asked is the United Way.

INSTALLATION BANQUET SET FOR JAN. 17 HOPES TO BE AN EXTRAVAGANZA

Planning for the installation commemorating the Chapter's 60th anniversary is developing at a furious pace. Jiro and Shea Aoki are chairpersons. The committee is going over the program' meticulously and hopes to cover the whole historical range of the Chapter in ten year increments. The anniversary year book with its history and personnel is being published. Photo display will be at the banquet site.

The banquet will be held at the Butcher Restaurant in the Atrium Room, Sunday, Jan. 17. Three members of the original Seattle Progressive League, forerunner to JACL, survives. We hope to have all past presidents present.

The committee is soliciting donations and advertisements to finance the booklet. The response has been overwhelming according to co-chair Shea Aoki.

Lots of water had run under the Chapter bridge. the J^ACL had assumed to act as spokesmen for Japanese Americans during the evacuation crisis, a real thankless task which was open for the taking to other Nikkei organizations. The campaign for Immigration Act Amendments of 1965 eliminating the Asia-Pacific Triangle and the National Origin formula was one of post WVII accomplishments. We made three tries for the State Land Law Repeal succeeding on the third try. We successfully campaigned with other organizations to eliminate the new version of internment camps built for standby basis. We were the initial organization to fund the Asian Drop-in Center which was under director Ruthann Kurose. We had a hand in EOC's origin, one of the first to fund the Keiro. Currently we note the Pride & Shame exhibit, Day of Remembrance, the signing of President Ford's Proclamation, the Canadian Japanese exhibit here, the Commission Hearings. This was all done with volunteer people power.


NIKKEI <u>HEALTH FAIR</u> (Cont'd): volunteer their services. They gave free eye, foot, hearing, dental and physical exams and provided information on nutrition and preventative health care. About 100 elderly Issei and Nisei enthusiastically participated.

The idea for a Nikkei health fair developed when ACRS was given a \$1,000 grant from the City Division on Aging. The money was to be used as "seed" to start service organizations for elderly Japanese. Because a number of programs already exist for the Nikkei seniors, ACRS called together a group of community members to discuss how the money would be best spent. The group felt that the grant should be used to further a need that wasn't being met by present program - and came up with the idea of a health fair. Health is a foremost concern among the elderly Issei and Nisei. Although most seniors have their own doctors and go for regular check-ups, there was no ongoing educational work being done in the community on preventative health care (how to keep healthy and not get sick in the first place). The committee decided to focus the fair on basic nutrition and health education. Screening would be 'ven to assess kay health problems that would need specific follow up and education in the

ature. Subcommittees were then set up to get the work going.

The response by the community was tremendous. Mikkei from all generations and professions pooled their time and resources to make the fair happen. Doctors and nurses contacted their colleagues to volunteer their services. Students from the U. of W. got their friends to drive the vans from agencies and churches to chauffeur the seniors to and from the clinic. People with bilingual skills helped to translate pamphlets. Some businessmen donated paper goods and bought lunch for the volunteers. (Cont'd next issue).
