Silver Pins: National JACL President Jim Tsujimura, who will complete his 2-year term in August, presented the pin to the following:

Shea Aoki has accompanied her husband Jiro as delegates to all the JACL national convention from the 1930s. She was Jiro's right hand person when he was Chapter president. She was active in the board and was on installation committee for '76, '80, and '81. She continue to act as spokesperson with the link of earlier members being present at the board meetings. She has acted to promote JACL Jr. trying desperately to get off the ground.

Mich Matsudaira, past president, 1st vp, and board members, was the pioneering exec director of Washington State Commission on Asian American Affairs. He was advisory Commission for U.S. Census. He was involved with social concerns, and worked on pride and shame project.

Hana Masuda was the behind-the-scene worker for late Minoru Masuda when many of the committee meetings were held at his residence. She worked on pride and shame and the Tomono Kai. She worked on Nisei Aging Project and the Minoru Masuda Memorial project committee. She was the Chapter link withe the Seattle Public Library.

Chuck Kato has served as prexy, vp, board, and the many committees and served as delegates and committee persons to the district council. He was co-chair of Japanese Cultural Ctr, past president and continues as board member of Univ. Students Club, and was president of Asian Engineers Assn. He co-chaired the Redress movement from its infancy leading to CWRIC. Somehow he manages to keep two feets on the ground in spite of all his professional accomplishments.

Henry Miyatake who was among the forefront of the Redress movement for 7 years, was also the leader in the cultural center project, was responsible for the Day of Remembrance demonstration, and was responsible for the committee leading to revoking the Executive Order 9066.

Kenko Nogaki, Charter Member of the original Seattle Progressive League and forerunner of JACL, continued leadership during WW2 year to help establish Washington, D.C. chapter and became their vp.

Ben Nakagawa, 1973 president and co-president during Chuck Kato regime, member of National Nomination Committee; educational committee, co-chair Japanese Cultural Center Committee, proficient fund raiser on two recent occasions, and our articulate spokesman at JACL National Convention.

Ken Nakano was among the committee for Japanese Cultural Center, Nisei Retirement Seminar, International Relations, Atomic Bomb Survivors Program Committee (also at the National level), Redress Committee, chapter historians for many years, helped organize Eastside Lake Washington Chapter; and acted as liaison with Shunju Club and Nihonjin Kai organization.

Charles Z. Smith serving as panelist and moderator during redress symposium, legal advisor for Iva Toguri Committee, Minoru Masuda Memorial Scholarship board of director, vp, and many other chapter responsibilities too numerous to mention.

Dr. Kelly Yamada was chair of the Awards and Recognition Committee for the installation and awards banquet. Dr. Yamada is an optometrist and has worked in Oakland and Peoria, IL before returning to Seattle. He belongs to several professional group. In 1973 he was appointed to State Board of Examiners for Optometry by Gov. Dan Evans. In 1978, he was appointed president of International Assn of Examiners. He belongs to the Rainier Rotary Club and the Japanese Baptist Church.

Dr. Yamada's committee included Ken Nakano, Phil Hayasaka, Takako Yoda, Kimi Nakanishi, Tomio Moriguchi, and Eira Nagaoka. Advisors were Cherry Kinoshita and Shea Aoki. Art work Lacking the copies of certificate of recognition and silver pin awards and since no request was made, the story was "written by ear" and is subject to corrections. Ray Okamura was also on the crusade and likewise wrote to a Merriam-Wedster's Collegiate Dictionary publisher. F & W Dictionary also agreed but Oxford Dictionary didn't.

Shosuke's niece, a librarian in New York, suggested that he attend the Social Responsibility Round Table of the Washington State Library Association. Sasaki told the Round Table that the objectionable word promotes interracial friction and that word should not be used. A resolution was then drafted and sent to Library Association Chapters in major cities.

It was moved and seconded to amend our previous position to include that those incarcerated were not disloyal.

Paul Hosoda informed us that he will aid those who are unemployed to get unemployment compensation.

It was suggested that we have associate members and have lower dues rates for Senior Citizens and those retired.

Ken Okuma presented a list of goals which were: 1) Asian J-A awareness (history, culture, society) 2) J-A pride (our people) 3) group support (individuals, all) 4) heritage for youth (not think white) 5) perpetuate J-A ways (obligation, language, ceremonies) 6) community activity involvement (education, civil service, govt., community projects) 7) prepare candidates for public office 8) social contact 9) open JACL to all Pacific Island citizens.

Each person present was asked to vote for the three goals they felt were most important. Priority items for this will will be 1) Asian, J-A awareness, J-A pride 2) community activity involvement 3) heritage for youth and perpetuate J-A ways. TULE LAKE PILGRIMAGE SET FOR JUTE 4-6

A bus from the Pacific Northwest will join the annual pilgrimage to Tule Lake for the first time this summer. About 300 people have chartered busses from Northern California each year since 1973. A rough schedule thus far calls for departure from Seattle/Tacoma at 7 p.m. on Friday, June 4, arriving at Tule Lake early Saturday morning. (Busses are air conditioned, with restroom facilities.) Motel accommodations are available for those who wish; others sleep at the fairgrounds in sleeping bags. Four meals are provided during the weekend. This year's program includes a performance by the Seattle taiko group, workshops, and a tour of the camp site. The bus leaves Tule Lake Sunday morning and arrives in Seattle that evening. Fees for the bus ride and meals are expected to be about \$50 per person. Issei and students receive special rates.
