Cultural Festival Fund, Retirement Conference Fund and Cultural Center Committee Fund have been transferred to the general fund by the board. Transfer had been previously recommended by chairs of the above funds. This move was agreed to and reaffirmed prior to the board action.

Karen Seriguchi prepared the Seattle JACL resolution to the National Convention to reflect concerns with National Redress campaigns calling for National Committee to make decisions on Redress with consultation and not to be made in isolation. Motion passes.

Ben Nakagawa released the name of <u>Denny Yasuhara</u> as a <u>candidate</u> for <u>JACLer</u> of the <u>Biennium</u>. Yasuhara was a constant force in WSU litigation to create Asian American Studies Program which is now in jeopardy. He was the leader when Spokane Chapter sponsored a rest home and completed building the structure worth over \$1 million currently. The project called for considerable sacrifice form approximately 1,000 Nikkei in Spokane area. We saw Yasuhara's agony when his Chapter failed to get the Inagaki Award for that year highlighted by rest home project. The award went to the Chapter which converted a residence of some sort into a Issei drop-in center. In the past the Northwest Chapters had been monopolizing the awards which includes second place laurel. Feeling existed at the National level that awards should be · geographically. given more equable distri

In another Spokane JACL project, the Nisei parents were always dismayed when the Sansei left Spokane to look for work. Why can't the Sansei find the jobs here? No jobs could be had for Sansei, Denny and the committee went on a campaign stating their case appearing on TV and other media. They found that their top teacher candidate was denied employment. They went to the school board. Telephone firm and other major companies where the Sansei had submitted applications and not resulting in employment were followed up. The battle cry was that companies had to follow the affirmative action program dictated by the Civil Rights Act. The teacher was hired within a week. A telephone company opened up a slot for Sansei leading to his management career. This is just two specific cases we know of. This is not a new story but we cite the case of Denny Yasuhara waving the JACL banner in the cause of justice.

Mako Nakagawa, Kathryn Bannai, the Hurds including Aya, Massie Tomita, Janice Nishimori, and Aki Kurose were present for the April mailout. We than those volunteers who came out in spite of the many options they would have. The mailout went by without a hitch.

The Univ. of Washington Archives which was in receipt of JACL papers including minutes about ten years ago will be asked to liberalize the use for undergraduates and for interested researchers. The use was being restricted to graduate students only. The motion passes.

Ken Nakano of the International Relations Committee met Mar. 18 to discuss the medical exam and symposium held in 1981. The group which met was concerned that 63% of Northwest residents who took the physical examination for the effect of atomic bomb radiation needs medical attention. The next visit of the . Hiroshima redical examination team will be in 1983.

Push has been made by <u>Sansei membership</u> committee with Michael Sato at 625-3726 and Jerry Shigaki at 543-5715. They are aiming for 50 members. The letter mailed to the Sansei said in part:

"With over fifty percent of the board being Sansei, this year we have the opportunity to shape the future of our local JACL and to continue our organization's involvement in current issues, problems and needs in our community.

"Maintaining the momentum generated through our activism in the redress issue, the Seattle Chapter will:

"Act as a watchdog of discrimination against Japanese Americans, with particular emphasis on the positive portrayal of Asian Americans in the media;

"Provide a forum for community education, involvement and advocacy and serve as a catalyst for mobilizing and networking individuals towards collective goals; and

"Sponsor sports activities, including a Fun Night/Tennis Play which will provide lessons and a mini-tournament for all levels at the Seattle Tennis Center. ..."

Ken Nakano said that <u>Floyd</u> Schmoe was recommended April 29 for the 4th Degree Order of the Sacred Treasure.

Mentioning only the brief sketch of his unbelievable accomplishments, Floyd Schmoe has been a park naturalist at both Mt. Rainier and in the National Park System. He taught biology and forestry in Univ. of Hawaii and the U.W. He is a prolific writer and authored many books. He did relief and reconstruction work in Japan on his own in Hiroshima and later funded by United Nations Homes for Hiroshima. One hundred two and four unit homes were built. In 1952 he continued relief work in Korea.

Actually what I was able to do during the Relocation and later in Hiroshima and Nagasaki was only a token of my feeling of regret, and my wish to share in the guilt and suffering brought by the war. The friendships I made, and keep, more than repayed me for all my efforts, and the experience both in the camps and later in Japan, is a highlight of my life.

Will you please express my gratitude and good wishes to all who, with you and Dr. Tsujimura, brought this about.

Just before the evacuation the members were operating more than 206 hotels and 56 apartments in Seattle bulging at the seams with tenants helped by wartime defense workers.

For the past 15 years the fire code, building code, increasing demands by the tenants, and changing spatial demographic makeup of the city made the hotel and apartment business less lucrative, especially in the low income and inner city area.

Many owners have retired, passed on, or sold out to make room for new downtown structures.

KOMO-TV'S "UP FRONT" VIEWS JAPANESE REARMAMENT ISSUE
