"District Director" Karen Seriguchi:

- a. She will be going to Washington State Univ. and will attempt to devote some time to establish a youth chapter on campus.
 - b. The establishment of a JACL chapter in the Olympia area appears a possibility in a couple of years.

Vice Governor John Matsumoto:

a. The chain-of-command pertaining to the District office staff to the National Executive Director and the District Governor and whomever else appears "to be a little hazy," YET. It was reported that the District Director has a solid vertical line leading to the Executive Director, BUT, comment was made to the following theme -- that kind of organization leads to chaos -- . We then moved right along to the Governor's report.

Governor Homer Yasui:

Denny made a dynamic and slightly emotional statement to the effect that only Asians feel it's necessary to present the "white" perspective to an issue being contested by a JACLer! "Who's newspaper is it?!"

No motion was presented, but it was the consensus of the PNWDC to support the position of Denny and inform the Pacific Citizen Editor of our feelings.

Health - Rowe Sumida:

a. It is becoming increasingly difficult to find insurance companies to carry health insurance coverage. It may be easier for JACLers to locate State programs rather than JACL group coverage due to the difficulties stated above.

Endowment Fund - John Kanda:

a. There has been an official request made to the endowment fund committee to "loan" the redress committee \$100,000 at 10% interest for a period of two years. Security for this loan will be a book to be published by Random House.

Washington State University Update - Denny Yasuhara:

a. The University is planning to consolidate the minority affairs offices, thus demoting the directors. This move greatly threatens the continuation of the minority affairs office for Asian Americans and the Spokane Chapter will again work to prevent such action.

FLOYD SCHMOE KECEIVES MEDAL - BOARD OF BEAR MORE AND THE SCHOOL OF BEAR MEDAL - BOARD OF

Japanese Consul General Naoki Nakano presented the 4th degree order of the Sacred Treasure to Mr. Floyd Schmoe for his humanitarian service to the Japanese people in Hiroshima and Nagasaki in 1948, and toward Japanese Americans from 1941 to 1946. The award took place at the Japanese Consul General Official residence. Vice Consul M. Nakano was the officer in charge.

Floyd W. Schmoe was born on a farm in Kansas. He studied forestry at the U.W. and New York State College of Forestry at Syracuse. He served eight years as park naturalist on Mt. Rainier National Park. He later took degrees in marine biology and taught at the U.W. and Univ. of Hawaii.

During and after both World Wars and the Korean War, Floyd Schmoe did relief and reconstruction work in Europe, Africa, Japan, and Korea.

During the 1942 uprooting of American citizens of Japanese ancestry, many Nisei students lived with the Schmoes and were aided in their move. Although Mr. Schmoe encouraged people to resist the expulsion, he visited assembly centers as well as the concentration camps to offer his services. Later, he actively recruited and placed Nisei students in colleges throughout Midwestern and Eastern states.

Many tuberculosis patients remained in Seattle while their families were removed. Mr. Schmoe visited each of these patients regularly throughout the war years and aided many in their rehabilitation.

During WWII, he became a target of the Tolan Committee, which investigated the expulsion. A great deal of time was spent in questioning him. Mr. Schmoe also received threats from the public, and this increased as the internees returned to Seattle. He spent many days laying out the group work to overcome the hostile attitudes facing Japanese Americans.

Mr. Schmoe also met returning internees and helped to establish hostels and find jobs.

Underlying all this was Mr. Schmoe's great commitment to humanity and peace. The bombing of Hiroshima and Nagasaki affected him deeply, and he set about raising funds in a quiet way. A Quaker himself, he found the Quakers eager to help. A new mission was formed to help rebuild what the bombs destroyed. Thirty-five houses and two community halls were built in Hiroshima and Nagasaki as a result of Mr. Schmoe's efforts.

For his tireless work on behalf of the Japanese American community, the Japanese American Citizens League awarded Floyd Schmoe a Certificate of Recognition and Appreciation 1976.

At the age of 86, Floyd Schmoe testified before the Commission on Wartime Relocation and Internment of Civilians, which held a hearing in Seattle on Sept. 11, 1981. Mr. Schmoe once again told a U.S. congressional commission that the internment of Japanese Americans was unnecessary and that the wrong done by our government should be properly redressed.

dedication ceremony said, " . . . ther spirit of "Lefty" still remains, and he continues to
speak to us . . "

In the Memorial Day program sponsored by NVC, president Kathryn Bannai placed the wreath in behalf of JACL as did all the other groups. Of the eight-person firing squad from the Univ. of Washington's ROTO program, three were women, showing the changing time.
