PUYALLUP MONUMENT DEDICATION

Sculptor George Tsutukawa presented his 500-pound, silicon, bronze sculpture at the Puyallup Fairgrounds, Sunday, August 21 with about 700 in attendance to witness this momentous occasion for Japanese Americans. The sculpture is a memorial to the 7,000 who were interned from April to September, 1942 and hundreds of thousands will pass by it during the Western Washington State Fair this month.

This project was not an easy task, to put it mildly, and it took a lot of long hours in meetings and on the telephone, plus a lot of dedication to reach the eventual ceremonies last month. In 1982, members of the Washington chapter of the American Legion objected to any memorial built on the Puyallup Fairgrounds. They complained to the Puyallup fair board, and early this year, fair board members voted to move the morument from inside the fairgrounds to to an outside parking lot. Tsutukawa backed out at this point.

But after complaints from the JACL and more publicity, fair board members reconsidered their decision and moved the monument back inside the fair's gate.

So, on August 21, 1983, the crowd of largely Nisei, cheered as Tsutukawa and Gov. John Spellman unveiled the memorial-inside the fairgounds. Spellman, who has come out fighting for redress, was well received by the crowd.

"Every week I receive letters asking if I remember Pearl Harbor," Spellman said. "All those letters reflect a common confusion, confusing the war between our country and Japan with the national deprivation of civil rights. The internment, Spellman said, was "unjust treatment of Americans solely because of their race."

After similar remarks by other politicians, Tsutukawa talked about his sculpture.

"I tried not so much to remind ourselves of the hardness and the misery of the evacuation, " he explained. "I was more concerned about our future generations. I tried to convey in this sculpture a feeling of friendship."

REDRESS IN CANADA

At our first redress meeting, the primary focus was information: What happened during World War II? Was an injustice done to the Japanese-American citizens? If so, what would constitute appropriate remedies—the kind that would obtain the above objectives? We wanted to inform ourselves so that we could proceed intelligently, relevantly.

What emerged, by the end of the meeting, was a sense of direction: We need to formulate both non-monetary as well as monetary options in our Redress proposals. Thus, two working committees were assigned the task of preparing

FALSE CLAIM FORMS CIRCULATED: A form to verify dates of internment for individual Japanese Americans is being circulated in the Pacific Northwest. The form is addressed to the National Archives and Records Service.

A non-Japanese American is believed to have begun distributing the form two years ago in Los Angeles as a claim for financial redress. John Tateishi, JACL redress director, advises that "any individual who receives such a form should ignore it." The government is not requesting internment dates for anyone at this time.

He added, "The form is misleading people to believe that compensation is immediate. It is a cruel hoax inflicted on the community." Rep. Mike Lowry introduced a direct compensation bill for former internees in June 1983. Another bill is expected to be introduced this fall. Passage of any redress bill, however, will take many months.
