MEETING WITH DON STEELE

Members of JACL recently met with Supt. of Seattle Public Schools, Don Steele and Supt. Alice Huston, to discuss the organization's recent concerns regarding Supt. Steele's performance.

Those representing JACL were Mako and Ben Nakagawa, Sam Shoji, Arlene Oki and Jerry Shigaki.

JACL's concerns to the superintendent were: Outreach to Asian communities; the District's Asian Affirmative Action profile for higher level administrative positions; unsatisfactory implementation of the PRI (Prescriptive Reading Inventory) Program; the long delay in filling the Bilingual Program director's position; and perception of disharmony within the District's administration resulting in loss of public confidence in the effective management of school programs.

DON STEELE MEETING, continued...

In response, Supt. Steele committed himself to the following: The Seattle Public School District will initiate quarterly meetings with the JACL; the District will work more closely with principals, teachers, and community persons before implementation of the math component of the PRI Program; the District will continue to support improved staffing ratios for bilingual education students; Supt. Steele conceded there is a need for discussion on the effects of the desegregation plan on bilingual programs; the District will seriously look at the sub-contracting services from community-based agencies, and that every effort will be made to improve the public image of the District, particularly at the top administrative level.

POTENTIAL URBAN MASS TRANSPORTATION ADMINISTRATION Section 16(b)(2) Applicants - The federal government will be allocating federal funds to Washington State to support the Urban Mass Transportation Administration's (UMTA) Section 16(b)(2) Program in 1984. The Section 16(b)(2) Prgm. makes capital assistance available to private, nonprofit organizations to assist them in providing transportation services to the elderly and the handicapped. The cost of the program is shared with 80 percent federal share and 20 percent local match.

The application period is open through March 5, 1984. The Washington State Department of Transportation (WSDOT) is the agency responsible for managing the Section 16(b)(2) Program in Washington. The WSDOT has developed an "Applicants Information Guide" to assist potential applicants in developing their application. The guide will be available upon request. Requests must be made in writing to: Mr. Jerry Carlson, Washington State Dept. of Transportation, Planning, Research, and Public Transp. Transportation Building, Olympia, WA 98504.
