We will remember until redress is won!

As we prepare for the July, 1986 National JACL Convention in Chicago, please note that immediate past president David Okimoto will be coordinating all activities in preparation for the convention. Ben Nakagawa and Tomio Moriguchi are preparing for our own 1988 National JACL Convention to be held here in Seattle during the last week of July, 1988. Please make plans to attend, and to welcome many friends and visitors who will be coming.

JACL members wishing to become 1000 Club Life Members can do so by paying \$500, rather than the standard \$1,000, by July 20, 1986. More detailed information will be forthcoming, but this is a good opportunity to help JACL, the local chapter and yourself. I recommend it highly.

The redress movement is picking up more support in Congress because the need to correct the internment injustice is being better understood throughout the nation. Please keep your LEC lobbying donations coming. We need to first pass the authorizing legislation through Congress and have it signed by President Reagan. Then an appropriation bill for monetary payment needs to be passed and signed by the President.

JACL is committed to serving the Nikkei community. Join me in doing what you can.

REDRESS BILL PASSES

House Bill 1415, the Civil Rights Restrictions bill sponsored by Representative Gary Locke, was passed in the House on Feb. 15 by a vote of 82-15, and passed in the State Senate on March 6 with a vote of 45-1. The bill, which will enable the Seattle School District to disburse \$5,000 in redress payments to each of 27 former school secretaries or their surviving spouses, must now be signed by Governor Booth Gardner.

Jerry Shigaki, chair of the JACL Committee for HB 1415, credited the hard work of Rep. Locke for the successful outcome of the bill, and acknowledged the support of Senators Jim McDermott, Phil Talmadge and George Fleming. Shigaki also praised the efforts of Cherry Kinoshita, Naomi Sanchez and Becky Sasaki, who accompanied him on many trips to Olympia to speak to legislators on behalf of the bill.

PROFILES OF THE SEATTLE CHAPTER OFFICERS

PRESIDENT-ELECT MAY SASAKI by James Hattori: An interest in teaching youngsters about ethnic diversity and cultural awareness led May Sasaki into the JACL. Now, 11 years later, she's President-Elect of the Seattle Chapter, still clinging to those same concerns for the Nikkei and other minority communities.

Sasaki, a Seattle native, works for the Seattle Public Schools as a resource person in the controversial integration program. She describes her job as a fringe-management position, noting that there seems to be few Asian Americans in important management jobs in the District.

Her career began in the classrooms of the Highline School District, right out of college. Then she got married and put her job on hold while raising four

children--three daughters and a son--the youngest now 19 years old.

Sasaki went back to the classroom more than a dozen years ago, this time in Seattle. It was her friendship with Mako Nakagawa, who headed up the Rainbow multi-cultural program, that led to her involvement with the JACL. Sasaki says she was impressed by the organization's willingness to pursue issues of importance, like human rights. And the JACL gave her a chance to meet lots of people in the Nikkei community—people who've added a lot to her life.

The internment experience has made some Nisei reluctant to get involved in some of the things JACL stands for, even though they may support those causes. Sasaki says she's encouraged by the surge of activity among Sansei and even Yonsei members. She hopes to continue building support among younger members in the community, as well as draw on the wealth of experience among the "old guard" JACL

members.

She sees redress for Japanese Americans interned during World War II as still the organization's number one priority. But she hopes to broaden JACL's community support by offering more, like social activities, which gives all members a chance to become more acquainted, and simply have fun.

When she assumes the Presidency of the Seattle Chapter next year, May Sasaki hopes to bring to the JACL a philosophy she's spent many years teaching

youngsters--that diversity gives strength.

Selection of scholarship recipients will be based primarily on the following criteria:


- -- academic achievement and potential;
