**JACL Redress video paired with Okazaki film***by Cherry Kinoshita, chair National JACL Redress video project*

A premiere showing of the recently completed JACL video, "Redress: The JACL Campaign for Justice," will be presented as part of a double feature with the 1991 Academy Award-winning documentary, "Days of Waiting," at the Nisei Veterans Hall, 1212 S. King Street, Saturday afternoon September 14.

"Days of Waiting," directed and produced by Steven Okazaki, tells the compelling story of artist Estelle Ishigo, one of the few Caucasians to be incarcerated along with 110,000 Japanese Americans during World War II. The 30-minute documentary relates the moving story of Ishigo's tragic childhood, her marriage to a Nisei during a period of rampant racism against Japanese Americans, her decision to remain with her husband and enter the concentration camps, her internment life, her husband's death, her lone battle

for redress and her poverty-stricken life after the war.

The internment story as depicted through the life of Ishigo provides an appropriate background sequence for "Redress: The JACL Campaign for Justice," a two-year National JACL project chaired by Cherry Kinoshita. This video-story of the legislative and grassroots struggle undertaken to achieve an apology and reparations from the U.S. Government was produced and directed by John Esaki of Visual Communications in Los Angeles and was funded by grants from the Minoru Yasui Memorial Fund and two Seattle-based foundations, the Kawabe Memorial Fund and the Motoda Foundation.

U.S. Senator Daniel Inouye on seeing the finished production, commended Visual Communications on

**Directory Project Underway***by Janice Yee, project co-chair*

The Seattle Chapter JACL has begun work on the long-awaited Greater Seattle and Vicinity Japanese Community Directory. Co-chair Ken Sato and I hope to have the directory published and distributed by the middle of October 1991.

The last directory, co-chaired by Don Kazama and Janice Nishimori and published in 1982-'83, contained over 6000 names and 1000 business listings. The 1991 directory will include listings from Seattle, Bellevue, Bainbridge Island, Vashon Island, Everett, Tacoma and other areas surrounding Seattle.

Innovations for the new directory include larger

and easier to read typesetting and black on white printing. The directory will also contain paid advertisements from businesses that support the Nikkei community. It will also give businesses increased exposure in a publication we expect to be distributed to over 10,000 homes and businesses.

**We need your help!**

Newly available computer technology will help make this directory much easier to produce than previous directories. However, much of the research and data input must be done manually. Volunteers are needed to look up names in the phone book, enter names in the computer, proofread print outs, solicit businesses for advertisements, help with mail out and distribution and anything else.

## Redress Update

### U.S. House endorses F.Y. 1992 redress appropriations

The U.S. House of Representatives honored its commitment to redressing the internment of Americans of Japanese ancestry June 13 by approving \$500 million for redress payments beginning October 1, 1991, reported Congressman Norman Mineta last month.

The commitment was endorsed by the House in a 338-80 vote as part of its approval of the \$21.6 billion Commerce-Justice-State Appropriations Bill (H.R. 2608) for fiscal year 1992.

"This strong vote shows an overwhelming commit-

ment to the letter and spirit of the Civil Liberties Act of 1988," said Mineta, referring to the legislation which authorized \$1.25 billion to apologize and compensate surviving former internees for their loss of basic constitutional rights at the hands of the U.S. Government.

Since October 1990, more than 20,000 individuals have received their compensation payments of \$20,000 each, and a total of 25,000 will have received compensation by this coming October.

The Commerce-Justice-State Appropriations Bill will next be considered by the U.S. Senate.

## Obituaries

### Mike Masaoka: 1915 - 1991

Mike Masaoka, a long time champion of Japanese American and Asian American causes passed away on June 26, 1991 in the Washington D.C. area following a long illness. He was 76.

Masaoka was born in Fresno, California, in 1915, the fourth of eight children. He grew up in the Salt Lake City area, where his father operated a small fish market. He received his B.A. in political science from University of Utah in 1937, and became the first paid executive secretary for the National JACL. He was hired in August 1941 just prior to the outbreak of hostilities in the Pacific.

He is credited with organizing the 442nd Regimental Combat team and being the first Japanese American to volunteer for that Nisei combat unit formed during World War II. Four of his brothers also volunteered—one of whom was killed in action—while their mother remained in the Manzanar Relocation Camp.

Masaoka returned home to continue his work with the JACL following the war, a period in which the JACL scored an impressive string of legislative victories, including the Japanese American Evacuation Claims Act, the 1952 Walter McCarran Act (which allowed issei the opportunity to become naturalized citizens) and the Immigration Act of 1965.

In 1950, Masaoka was selected as the JACL's first Nisei of the Biennium. In 1968, he was awarded the Order of the Rising Sun, Third Class, the highest decoration Japan bestows upon a foreigner, for his contributions to improving amity and understanding between Japanese and Americans.

He is survived by his wife Etsu; granddaughter Michelle Amano; brother Tad, San Mateo; and sister Kiyoko, Chicago.

Memorial services were held in Chevy Chase, Maryland, July 2.

### Susumu Fukuda: 1903 - 1991

Dr. Susumu Fukuda, dentist and prominent member of the Seattle Japanese community, died June 23. Fukuda was born in Fukuoka, Japan and came to the United States in 1915. He attended North Pacific College of Oregon, graduating in 1927 and becoming one of the first Japanese American dentists in the Seattle area.

He worked long hours, sometimes exchanged services for fresh vegetables in lieu of payment, some-

times offering services without charge and occasionally performed dental work on house calls, according to friends and relatives of Fukuda.

Fukuda spent his last years at Seattle Keiro Nursing Home. He is survived by his wife Tami, son Alan, and three daughters Janet Powell of Bellevue, Lilian Hirano of Richland and Ilene Blackburn of Seattle.

Memorial services were held at Blaine Memorial United Methodist Church July 2.
