## Redress Update

Redress becomes a tangible reality to some in the form of a \$20,000 check; to others, the letter of apology signed by the President of the United States means more (see boxed story below on new letter format). This week redress checks for 22,800 persons born before January 1, 1928 were paid during the first week of October, accompanied by a "more authentic" letter of apology, as reported by Bob Bratt, ORA Administrator.

Since more than one check could be issued in the case of heirs of an deceased individuals, over 23,000 checks were stuffed by hand and mailed out in roughly equal numbers on October 2, 3, and 4. Out of 2,200 cases left in the allotment for the 1991 redress payments and letters, approximately 1,900 cases are awaiting return of documentation from potential recipients. Funds for 300 cases within the

pre-1928 group are being held back for those who have not yet contacted ORA.

The Help Line, 1-800-395-4672, or (TDD) 1-800-727-1886, will be open from 9:00am until 9:00pm EST to receive reports about lost or stolen checks. Persons who have received a green verification letter but who have not received their checks by October 21 are asked to contact ORA on the Help Line immediately. Persons born before January 1, 1928 who have not received the pink letter of Potential Eligibility, or who have returned their documentation but have not yet received the green Verification Letter should also call the Help Line immediately to ascertain their case status.

The number of redress payments and letters in the FY 1991 disbursement total 1,697 recipients in Washington state, and 529 recipients in Oregon.

## The New Redress Letter of Apology

The official presidential seal imprinted in gold will now appear on the letter of apology which will accompany redress checks to be distributed this year, and hereafter, according to Bob Bratt, ORA Administrator.

Identified more clearly with the printed words, "George Bush, President of the United States" and the date of October 1990 added to the bottom of the page, the letter has been enlarged to an 8-1/2" by 11" page printed on a heavier paper that is suitable for framing.

Although the ORA was unable to effect any of the changes that the JACL-LEC recommended, Bob Bratt said "I believe the new format enhances the appearance and authenticity of the

apology letter, and most importantly, I hope it will be more meaningful to redress recipients ..."

The ORA will not automatically mail new letters to 1990 redress recipients (the first group of persons 70 years and older). If you received the older letter and wish to receive the new letter, write to ORA at the following address:

## Chapter Focus

### Leadership Conference.

Janice Yee and Ray Ishii attended the National JACL Leadership seminar in Washington D.C. from September 28 – October 3 as representatives of the Pacific Northwest District. They met with members of Congress Sen. Daniel Inouye, Rep. Patsy Mink, Rep. Norm Mineta, and Rep. Bob Matsui. They learned first-hand about the legislative and lobbying process, focussing on how JACL and others played a role in the passage of redress, and they visited the Office of Redress Administration for a close-up look at the process of redress disbursement. The Pacific Northwest District Council and Seattle Chapter co-sponsored the two participants with matching \$500 grants.

### Redress Workshop

A lower than anticipated turnout of approximately 60 individuals sought assistance at the Office of Redress Administration workshop held at the Nisei Vets Hall last month. This low attendance was attributed to the fact that the ORA had already sent out green Verification Letters to approximately 22,700 of the 25,000 eligible individuals scheduled for payment for Fiscal

Year 1992. The largest corporate donation in the Pacific Northwest was made at this workshop to the JACL Legacy Fund: \$3,000 from the Allstate Foundation. Lisa Chinn, of Allstate, made the arrangements for this generous contribution.

### Legacy Fund

### Nikkei Concern Health Forum

### EO 9066 Exhibit at Wing Luke Museum

Local Japanese Americans are searching their basements and attics, and sifting through collections of old photos and artifacts for the major historic exhibit at the Wing Luke Museum, "Executive Order 9066: Fifty Years Before and Fifty Years After." A recreation of a typical pre-war Japanese American storefront and of a barracks room at Minidoka Internment Camp will be highlights of the exhibit, which opens on February 19, 1992. Educational programs, guest speakers and tours for students are planned in conjunction with the exhibit. A curriculum kit containing textbooks, lesson plans, and teaching aids will also be available. Security Pacific Bank recently indicated that it will be one of the major sponsors of the exhibit and has committed \$10,000 to the project. Exhibit organizers hope to raise \$150,000 in corporate and community contributions. Each dollar contributed to the ENDOWMENT FUND remains with the local Seattle Chapter.





JACL LEGACY FUND

PURPOSE: To establish a perpetual endowment fund from which only the earnings will be used to implement National JACL's goals; fighting for civil and human rights issues; countering hate crimes, Japan-bashing, and negative media images; promoting national Legislation such as redress; liaison with the office of Redress Administration; and providing professional staff in its national, Washington DC, and regional offices.
