# **President's Report**

For those of you who think Marge Schott is unique in her "taking my racism public" attitude, events of this past week should make you ponder.

Two Spokane Democratic Party officials recently made racial slurs directed at members of the Asian/Pacific Islander community, creating a rift among party officials. Marge Davis referred to owners of the Davenport Hotel as "Chinks" at a Democratic Party committee meeting. Christopher Marr, a member of the Spokane Chapter JACL, filed a grievance with the local party, only to be further insulted by Betty Drumheller, who "bowed" to him after he refused to shake her hand.

I am not surprised at these events, I have been around too long for that, but I am frustrated and disillusioned at the ignorance and insensitivity of these two "civic leaders."

These two individuals must be held accountable for their actions. They must formally apologize to those whom the comments directly offended: the Asian Pacific Islander community. My understanding is that a reprimand would include their taking leave of their positions for a designated period of time.

The ultimate issue for me is how we can use this incident to leverage a longer-range objective: education provided in schools, to party members, and to everyone in the Spokane and larger state and regional community, so that all might come to a better understanding of racism and its destructive nature.

We support the Spokane Chapter and must take action that reflects our concern and supports their efforts. On behalf of the Seattle Chapter, I have contacted the Commission on Asian American Affairs, Charles Rolland, chair of the state Democratic Central Committee, and the Governor's Office to voice our support for the Spokane Chapter. I encourage individual members to contact their state legislators and legislative district offices to make your opinions heard.

# **Chapter Focus**

## **Legacy Fund report**

For the 1992 distribution of Legacy Fund earnings, the Seattle Chapter once again topped the nation with an earnings return of \$1,651.00, announced Gail Ideno, National Director of Fund Development. Based on 1992 annual earnings of \$120,311.70, a solid increase over earnings in 1991, the breakdown of earnings will be as follows: 20% to Chapters (\$24,062.34), 10% for Grants (\$12,031.17), 5% for Growth (\$6,015.59) and 65% for National Programs (\$78,202.60).

As of January 20, 1993, the National Legacy Fund has gone over the \$4 million mark, with a total of \$4,049,906.30 in gross contributions and pledges. However, out of its national membership of approximately 25,000, Ideno reports that "only 20% of JACL members have donated to the Legacy Fund."





# **Special Reports**

#### Redress Update

For fiscal year 1994, 3,974 potential redress recipients have been identified as of the end of February, according to Paul Suddes, Administrator, Office of Redress Administration. Of this total, 3,276 have been approved as eligible and are ready to receive checks this October, with 698 cases still awaiting completion of documentation.

Under special provisions added to the original redress legislation, approximately 40 non-Japanese spouses were paid early this month, as well as Peruvians of Japanese ancestry, who were ruled eligible, reported Suddes.

In 1992, there were 348 appeal cases, 113 of which have been denied, with only one case reversed as being eligible. Of the 234 cases still pending, 192 are still awaiting further information to be provided by

the claimants. In 1993, 290 appeal cases were sent to the appellate division of the Department of Justice. Of these, only 7 cases have been denied, with the remainder of 283 cases still open. Thus, for the two previous years, a total of 517 cases are still pending on appeal, according to Suddes.

If no further cases appear, an not counting the appeal cases pending, there will be a grand total of 78,974 cases compensated by October of this year, or approximately \$1.58 billion disbursed of the total \$1.65 billion authorized for individual payments. The issue still remains unresolved as to where monies will be found to finance the Education Fund.

Anyone who has not yet sent back to ORA any requested documentation or information should do so promptly, as the ORA would like to have all cases ready this spring for payment in October.



During his time at USTR, Mr. Fukushima participated in trade negotiations with Japan under the MOSS (Market-Oriented Sector-Selective) talks, the Super 301 provisions of the Trade Act of 1988, and the Structural Impediments Initiative (SII). In December, 1992, he made a presentation on Asia at President Clinton's Little Rock Economic Conference.

Mr. Fukushima is Vice President and a member of the Board of Governors of the American Chamber of Commerce in Japan (ACCJ), Programs Committee Chair of the Executive Committee of the American Electronics Association (AEA) in Japan, and Government Relations Chair of the US Semiconductor Industry Association (SIA) in Japan. Among his publications is *Nichi-Bei Keizai Masatsu no Seijigaku (The Politics of US-Japan Economic Friction*) (Tokyo: Asahi Shimbunsha, 1992.)

Mr. Fukushima received his undergraduate education at Standford University and his graduate education at Harvard University Graduate School of Arts & Sciences, Harvard Business School, and Harvard Law School. While at Harvard, he was a Teaching Fellow for Professors David Riesman and Ezra Vogel and former Ambassador Edwin Reischauer.
