State Civil Liberties Bill passes Education Committee unanimously Jut sent back to Committee later

A proposed bill to provide seed money (\$40,000) to develop educational materials about the WWII eviction and incarceration of Japanese Americans and other similar mass violations of civil liberties, passed unanimously out of the State House Education Committee January 13, only to be referred back to the Education Committee a week later.

The Civil Liberties Education Bill (HB 1572) was referred back to the Education Committe in order to avoid the House Appropriations Committee, where in all likelihood it would have died. In the past, bills with fiscal impact under \$50,000 did not have to go through the Appropriations Committee. This term, all bills with fiscal impact are being routed through the Appropriations Committee, regardless of the amount.

According to Anndi Kawamura of Rep. Kip Tokuda's office, the strategy now is to get the bill passed without the oney, establishing the policy, then working to get the funding later. In addition, a provision setting up a fund into which people can make donations is being considered as an amendment.

Rep. Tokuda (Dem.), who co-sponsored the bi-partisan measure with Rep. Mike Wensman (Rep.), said that the bill would provide for programs which would "ensure that the painful lessons of our past will be remembered."

Rep. Sharon Tomiko Santos reiterated Tokuda's sentiment saying, "Remembering the past is a remedy for the future. We need to educate everyone to be true to our vow: Never again."

Rep. Santos said that the bill needs support from all legislators, but especially from those outside the Seattle area, and urges constituents of legislators outside Seattle to contact their Representative. Besides Representatives Tokuda, Wensman and Santos, those signing on to the bill so far are Representatives Velma Veloria, Dave Quall, Mark Schofler, Steve Conway, Ed Murray, Dow Constantine, Val Ogden, Phil Rockefeller, Phyllis Kenney, Al O'Brien, Dave Schmidt and Kathy Haigh.

In 1942, Marguerite Eyrikson and her family rented an apartment in Puyallup from the Tomita family. A few months later the Tomita family, along with other Japanese Americans, were evicted and confined to makeshift barracks at the Puyallup fairgrounds. Eyrikson found it unbelievable and shocking that she couldn't visit with them except through the fence which separated the Japanese American family from the world outside.

Later, she marveled at the Nisei soldiers who were fighting in the war while their families were still incarcerated. She decided that in her lifetime she would like to honor these veterans.

At age 84, Marguerite Eyrikson decided that this was the time and told her daughter that they should honor them somehow.

In September last year, at the Puyallup Fairgrounds, Marguerite's daughter Lydia Pressey and her company, LP Productions produced
