Leadership group lays out collaborative plan for International District future

On July 5th, members of the inaugural class of the Asian Pacific Islander Community Leadership Foundation (ACLF) presented an analysis of the International District (ID) to a packed crowd of community activists, politicians, social service workers and other prominent community leaders assembled at Nikkei Manor.

"Logic of the International District" was created by Geneva Witzleben, Vaishali Kaushan, Julien Loh, Tammy Luu, Kelvin Sezto, Christina Hong and Raymond Lam, all members of the ACLF ugural class, and Seattle Chapter JACL Board Members Mari Hirabayashi and Matthew W. Nakata.

Paying close attention to the presentation was a panel consisting of: Jane Nishita, manager of Public Policy for Quest Communications, Sudha Shetty, Planning Development Specialist for the City of Seattle Domestic and Sexual Violence Prevention Office, and Miebeth Bustillo-Hutchins, Executive Director of the Commission on Asian Pacific American Affairs.

Following the 30-minute presentation, the panel asked a series of questions regarding the group's study and actual process of the study.

Much of the work that went into the presentation centered on providing ACLF participants with the tools and skills needed to work cohesively on a large, undefined project.

At the conclusion of the presentation, panelist Nishita said she was interested in the whole process and the group dynamics of the study." She posed the question, "In trying to accomplish your goal of a final presentation, how were you all able to work together?" The ACLF participants responded by stating that it was a little hard to come together as a group working on such a huge and undefined assignment. But as the group came together to collaborate on interviews or to share thoughts on the project, they came to know each other's working styles better. That made the process sier.

According to Jill Nishi, co-moderator of the leadership workshops that produced the project and presentation, "The goal of this particular project was twofold. The first aspect is that it allowed the participants to research and explore the needs of the International District community. The second aspect of the project




President's message

36th Biennial JACL National **Convention Resolutions**

Though delegates from the Seattle Chapter supported all of the resolutions which passed, they focused much of their efforts to ensure the successful endorsement of several important resolutions including An Apology to Wartime Resisters, Federal Recognition of Native Hawaiian Sovereignty, and Equal Justice for Dr. Wen Ho Lee. President Sharon Sobie Seymour also advocated for National Council support of the Wartime Parity and Justice Act of 2000.

The following resolutions were endorsed at the National Con-

- JACL Apology to Nisei Resisters of Conscience.
- Federal Recognition of Native Hawaiian Sovereignty.
- Full Military Benefits for Filipino World War II Veterans.
- · Posthumous Recognition for Jim Miyazaki.
- Support Bill Lan Lee's Nomination for US Asst. Atty. Gen. for Civil Rights.
- Requirement to Enact and Report on 35th Biennial Coun-
- Religious Freedom for Minorities (opposes amendments to US Constitution that would reduce separation of church and state).

The following additional resolutions, under emergency status, were approved:

- · Support application of equal protection before the law and right to due process for Dr. Wen Ho Lee.
- Support Hate Crimes Bill
- Endorse Retention of Masaoka Quotation on National JA Memorial to Patriotism.
- · Oppose Siting of Stadium in or near Philadelphia Chinatown.
- Support Confirmation of Former Congressman Norman

for US Secretary of Commerce.

· Commendation for Nisei Congressional Medal of Honor

The following resolution did not pass:

• Support Wartime Parity and Justice Act of 2000 (Rep. Xavier Becerra, D-CA), a bill that provides full reparations for Japanese American and Japanese Latin American WW II detainees.

young people through targeted activities and business ventures such as the creation of a forum where several API movies can be own throughout the year and rough the establishment of an International District community radio station.

Further recommendations included: continuing the effort of incorporating mixed income housing, continuing the effort to bring in funding for the establishment of a variety of small owned businesses, resident empowerment through education and consciousness raising, and further development of community leaders who could help to mobilize the community and convey the needs of the commu-

based on a series of interviews which they conducted over a four week time period with community leaders, politicians, usiness owners, writers/ pubhers, activists, and other community workers familiar with the International District. The

group acknowledged that a few aspects that they would have liked to have covered more indepth they could not research as thoroughly as they would have liked to due to time constraints. On the whole, the group synthesized a great deal of information about the International District and presented findings from interviews that were suggested as recommendations. The group also collaborated to make recommendations of their own.

Said Sharon Sobie-Seymour, "This program is excellent because it gives the youth of our APA community the knowledge and opportunity needed to foster careers and further community involvement."
