# Take the time to honor Nisei Medal of Honor recipients

Please join the Nisei Veterans in honoring PFC William K. Nakamura and T-5 James Okubo, two Nisei heroes who were posthumously awarded the Medal of Honor last year. The Nisei Veterans organization has been working with the Pacific NW District Council JACL, the Seattle Chapter JACL and other sponsoring organizations for many months to organize an event to honor those who gave so much to this nation. The ceremony will be held at the Seattle Center's Mercer Arena on National Medal of Honor Day, Sunday, March 25. It will begin at 1:30 PM with a musical prelude, followed by the ceremony at 2:00 PM. The program will also acknowledge the accomplishments of other Medal of Honor awardees from Washington State.

Twenty Nisei and other Asian Americans were awarded the Medal of Honor in June 2000 for their meritorious service during World War II. As General Eric Shinseki, Chief of Staff, U.S. Army, notes: "It is unfortunate that it has taken 50 years for these men to receive this proper acknowledgement of their heroism."

The sacrifices of the brave Nisei veterans of the 100th/442nd regimental combat team who gallantly fought for U.S. interests during World War II should never be forgotten. They fought in Italy and France in a segregated unit while many of their Nisei brothers served in the Military Intelligence Service in the Pacific. All fought with the full knowledge that their loved ones were being deprived of the very freedoms for which they were fighting.

The 100th/442nd RCT received more medals for heroism than any other unit in the history of the U.S. — a total of 18,143 individual decorations for valor. The regiment also suffered the highest

combat casualties of any American fighting unit, a casualty rate of 314%. In an ironic twist, the Nisei soldiers from the 522nd Field Artillery Battalion of the 442nd, whose own parents were imprisoned by their own government in U.S. concentration camps, liberated the survivors of Dachau, one of Hitler's death camps.

The Nisei soldiers of World War II made the ultimate sacrifice to demonstrate their love for country, family and community. As President Bill Clinton said at the Medal of Honor ceremony on June 21, 2000:"They risked their

# Hosokawa defends JACL, praises Nisei veterans, thanks Seattle JACL

Although Bill Hosokawa was unable to deliver the keynote address in person, his message to the Seattle Chapter had a little bit of something for everyone: humor, nostalgia, history and the words of a man who is not afraid to speak his mind.

Hosokawa briefly reminisced about his childhood during a time when Japanese were afforded second-class status. He spoke fondly of Jimmie Sakamoto and his weekly newspaper, The Japanese American Courier, where he worked part time and " (his) pay for working there a few days a week was a lunch ... which was provided by Mrs. Yagi's little restaurant around the corner for 25 cents." It seems Jimmie was responsible for not only introducing Bill to the JACL in 1935, but he promoted our young chapter, known then as the Seattle Progressive League, in his newspaper.

Hosokawa succinctly chronicles the beginning of early Asian im-

migration, recounts the fear which lead to discriminatory immigration laws and eventually to Executive Order 9066 during World War II. He defends the actions of JACL during this tumultuous time, observing:

"Today, some individuals contend that since the evacuation order was illegal and unjust, we as patriotic Americans should have defied the authorities in defense of our rights. JACL is accused of selling us out when it urged us to accept Evacuation as our contribution to the war effort."

However, at the outbreak of war, the national JACL leadership and Mike Masaoka acted in the JA community's best interest. "The ma of leadership was not usurped by JACL, it fell by default on frail shoulders," in the wake of the FBI roundups of the Issei leaders. He asserts

that "the decision to cooperate was not made without intense soul searching."

Further, he points out that JACL received pledges of support from the Buddhist Church of America, the Japanese Christian Federation of North America and the Northwest, Northern California and Southern California Young People's Christian Conferences indicating that the young, inexperienced Nisei leaders did not stand alone.

Post war years the JACL "citing the proud and bloody record" of the "magnificent ... Nisei soldiers offering their lives in defense of the country that had betrayed them," and the "record of civilians who had borne a cruel injustice ... " achieved naturalization of Japanese and other Asians, anti-miscegenation laws were repealed, and ultimately redress. "Thank you, Seattle chapter, for leading the way."
