'Shinnen suggests strenth of conviction and faith'



As part of the University of Washington Law School's 100th Anniversary, a gross injustice was undone March 1. Takuji Yamashita was finally inducted into the Washington State Bar Association 99 years after he graduated from the Law School.

A graduate of the University of Washington Law School in 1902, Yamashita passed the bar exam, but was refused entry because of laws which excluded Asians from induction into the Bar. Excluded from his chosen profession, he became an accomplished businessman. In 1921 he challenged the Alien Land Law in the U.S. Su-

preme Court, decades before JACL took up this fight.

On March 2, Seattle JACL, the Asian Bar Association of Washington, the Wing Luke Asian Museum, the Ehime



Club, and the Organization of Chinese Americans held a reception for Yamashita's 20+ family members who came to Seattle for the bar induction ceremony. Wang Yung, in his welcoming statenent, said the greater Asian Pacific Islander community owes a large debt to Yamashita who challenged racist laws and believed very deeply in the American creed of liberty and justice for all.

The kanji chosen for this historical event, Shinnen, suggests strength of conviction and faith. Mr. Yamashita possessed shinnen that justice would prevail in the end. We would all do well to keep that faith as we struggle today against injustice.

the copy of the final bill given to the Council by Nisei Veterans Committee member Tosh Okamoto and Sharon Seymour of the Japanese American Citizen's League. "This honors a person who showed his patriotic valor and gave his life for his country. It proves that while we don't always get it right the first time, in the end, we can."

"We served to prove ourselves as Americans," said Okamoto. "The honor received by William Nakamura puts closure to a cloud that has been over my head for many, many years."
